

COUNTING UP THE SLAIN

A CLOSE SCRUTINY OF THE BAT-
TLEFIELD.

Rev. R. W. Bayson again summarizes the
Points he has Made and the Errors
Father Davis has Failed to Rectify—
Girded Quotations Uncorrected—The
Bible Only a Record of the Events It
Contains.

Kingston, Dec. 17.—(To the Editor)—In
the Editor's article on the relations between Father
Davis and myself, it was mentioned that his
attacking the Church of England in the
Canadian Freeman on October 12th, he had confined himself to attacking
those points of our doctrine in which there is a real difference be-
tween the two churches, if he had avoided all the ridicule and misrepres-
entation I should have taken no notice, for a Roman Catholic, writing in a

case. In the first article Father Davis stated that our claim to be catholic
deserves the same regard as every other
one who practices any religion or the
teachings of the Evangelical Christianity,
and in accordance with this, he has used no other weapon than ridic-
ule and the misrepresentation necessary
to make it effective. And this
makes objects to be made an object
of ridicule himself.

I however have not ridiculed him, I have confined myself throughout to
one object, viz., to expose the false
and falsified quotations and the gross
misrepresentations which have formed
the basis on which nearly all his articles
are based. Now I ask you to repeat what I have said before, it is
that I have done a disservice which
cannot possibly continue further
in view of the shield held in
disgust for truth on my part.

On October 14th, he quoted a portion
of St. Cyril's epitome to
prove these words "Of all schisms
that whereby obedience is withdrawn
from the supreme head is the most
dangerous to the Catholic church." These
