BY-LAW NO. SCHEDULE "A" (Continued). 11. BY-LAW NO. SCHEDULE "A" (Continued). 12. The said parties of the first part shall pay to the said Corporation the amount of the said debentures as they mature, and interest thereon, and shall pay to the said Corporation the cost of such insurance from the parties of the first part; provided that in the event of the destruction of the said elevator by fire the Corporation shall not be entitled as against the parties of the first part to collect any larger sum under any policy or policies of insurance on said elevator and premises held by them at the time of such destruction, and interest created by the Corporation in respect of said bonus. 13.
