

WHAT'S TO BE GAINED!

Is there anything to be gained by the ting of Riel? Yes, the government, which has been aptly described as between the devil and the deep sea, will be relieved of an overpowering embarassment. Is that all? It is enough for the present. Two great parties, mixed in politics and intensely excited, collide in regard to the disposition of the rebel. The government, having Riel's destiny at their command, cannot hope to please them both. The antagonistic elements are just now unthey may become more amiable by-andbye. A postponement of the crisis is most desirable. Months hence there may be less sensation by the hanging or reprieving of the criminal. And it will be months in all probability before the Privy Council is called upon to consider the merits of the case. A reversal of the lower court's decision is scarcely to be expected. The grounds for the appeal are very similar to those in the Conner's case, which came before my lords on the very day on which the felon expeated his crime. The Privy Council however, intimated that Connors could not have been saved by them, that they would have overruled the appeal The only hope of Riel, therefore, hinges upon the action of the government, eventually, and the government will be guided very largely by the drift of pub-

MEANS TO AN END.

It is quite apparent that the government has gone on the short side in respiting the time for Riel's execution, since it will be almost impossible, within the month, to discuss the merits of the case before the Privy Council. The rebel's legal friends have left for England, and will lay the issue before the highest court in the realm. To have done otherwise, to have been tardy in action, would have been to make exposure of the flimsy excuses to which the government are driven in their ef forts to save the culprit. If the man has not been tried by a competent court and before a jury of his 'peers; if the best side of his case has not been brought out; if his counsel have overlooked anything which can tell in his favor; if he is really and truly insane and irresponsible for the criminality of his conduct, and there is ground for a new trial, it should be had. The Manitoba court, however, the president of which is one of Canada's foremost jurists and judges, swept away the basis of the appeal and weakened the hope of a different result in England. The Privy Council may save the rebel; the Imperial government may suggest his pardon; some extraordinary thing may intervene to lift oppressive responsibility from the shoulders of the government. But, all other expedients failing, the political machine will do its work. Mr Moylan, Inspector of Prisons, in reviewing the situation, said to a Victoria. DEATH OF G. W. FERWICK.

AWAY-HIR RESIDENCE IN KINGSTON. Another old and prominent citizen has send over to the majority. We refer the late G. W. Fenwick, sr., of Williamsville. For some years the deceased has been ailing, suffering from rheumatism and an affection of the heart. Last winter he had a very severe attack of sickness and was for a long time confined to his bed. He subsequently rallied and was able to move about. He was again prostrated, however, this time with fatal results. He was born in Newcastle-on-Type 67 years ago. He studied medicine in a college at London, England, but his course in life was changed by the death of his father. In 1840 he came to Canada and entered the office of Dr. Nelson, of Montreal. After a short apprenticeship with the doctor he took the position of time keeper during the building of the Cornwall Canal; afterwards he acted as purser on a steamboat, and succeeding to a captaincy, commanded several steamers, one of which was the Beaver plying between Kingston Ottawa. He was also for a short time in the employ of Macpherson & Crane, forwarders, at this port. Tiring of the water he became a resident of the city and for many years carried on the hotel business in the Fenwick House, corner of Gore and Ontario streets. He made many friends among the citizens and was elected a public school trustee, representing Sydenham Ward at the board for 17 years, the longest term ever held by a trustee. He was then brought out by the Sydenham Ward electors for alderman and was again successful. He was twice married. By his first wife he had ten children, of whom five boys and three girls are living. He had ro children by his second wife. Dr. T. M. Fenwick, his eldest son, has been practicing in the city for over 22 years; Edward Fenwick is employed as traveller for Wemar & Co., druggists, Hamilton;

Ald. J. Carson, in a letter to a friend. speaks about the horse show at the Industrial Fair, Toronto. He says the show is very large, and that there are some of the finest horses in Canada on exhibition. There are over 250 stallions at the show grounds, and Carson writes very bitterly about the unfairness of the judges in awarding prizes. He says: The Toronto men will not allow any of the prizes to go east, but if a western man exhibits any stock he is sure to get a prize. 'Out of eight horses that went from Kingston and vicinity only two of them were awarded prizes. I received a second prize for my Suffolk Punch stallion "Palmer," and Mr. Hugal, of Ernesttown, got a third prize. He exhibited two colts, one three year-old and two seven years old. Mr. Johnston, of Odessa, showed a two year old colt; Potter & Williams, of Napanee, showed "War Cry" stallion, as a thoroughbred : T. Wilson, of Kingston, showed "Galloway," a thoroughbred; M. Backer, of Picton, had two Percheron stallions. in the class in which Palmer was judged before the horses appeared in the ring. 
