#### A. HOPPINS. MRS. HAMMERSLEY'S WEDDING.

The Duchess of Marlborough Appears to

be Nobody's Wife Just Now. NEW YORK, July 11 .- The Herald publishes some legal views as to the validity of the Duke of Marlborough's marriage to Mrs. Hammersley. There is a serious doubt whether the marriage is valid, and even question whether the duke has not committed bigamy.

James Hillhouse, of the New York bar, has made an examination of the statutes of a HAZA TO BE STATE OF New York to the state of New York to regard to their riage, divorce and bigamy, and an examination of the English law, and the result is that what was supposed to be a valid marriage was in reality no marriage at all, or a lites. marriage of such an extremely dubious nature that a question is presented whether the marriage is not void.

Another lawyer says that the duke's marriage, taking place within the state of New York, its validity must be governed by the law of the state of New York, because the permission or prohibition of particular marriages belongs to the country where the marriage is to be celebrated. The duke has ignorantly exposed himself to a charge of bigamy. The parties are, however, free to marry in England, and their marriage there would dispel the cloud that now rests upon their union.

NEW YORK, July 11.—The World's London correspondent called on the Duke of Marlborough yesterday for the purpose of interviewing him on the subject of his recent marriage. The duke said: "I am sure that the service performed by Mayor Hewitt, in the presence of the accredited representative of the British consul-general, is without flaw and above cavil. You see I had given a great deal of thought to the matter, more perhaps than the lawyers who were not so interested personally." George Lewis, the greatest authority on English law in its relation to divorce, stated to the correspondent that the marriage was perfectly valid. Cards were issued yesterday by the Dowager Duchess of Marlborough for a reception to be given July 23rd to meet Lilian, Duchess of Marlborough.

An Amazen Dismissed Before the Prosetor Arrived-Fined For Offending.

NAPANEE, July 11 .- Of the four girls arrested last week for being inmates of disorderly houses Agnes Smith was sent to the Mercer reformatory for one year and Catharine Brown for thirteen months. Charlotte and Minnie Davy were remanded for a

Sarah and Victoria Wayman, mother and daughter, who reside on the Nimmo farm, near Clark's Mills, were brought before Police Magistrate Daly on Monday on a charge of having assaulted one Samuel Hooley, of Thompsonville. The offence was alleged to have been committed in the paper mill yard while the complainant was quietly engaged at his work. The women have been a terror to the neighbourhood for a long time past, and it was hoped that the result of their arrest would be that they would get free quarters in the county boarding house for a time. However, when the hour for trial arrived the prosecutor did not turn up and the magistrate discharged the prisoners. Hooley arrived shortly afterwards with a number of witnesses, and was very much chagrined at the turn affairs had taken.

W. A. Taylor, proprietor of the Dominion house, appeared before the police magistrate on Monday charged with a second infraction of the Scott act. The charge was proven and a fine of \$100 and costs inflicted.

J. S. Hulett's high stepping banged-tailed team caused quite a sensation Monday evening by running away and dashing furiously up Dundas street. They were caught before much damage was done.

## HE DIED IN PRISON.

Inquest Will be Held Touching the Death of Mr. Mandeville, Nationalist.

LONDON, July 10. - Mr. Mandeville, the Irish nationalist, a nephew of O'Mahony, Fenian head centre in America, died in prison, where he had been committed for a breach of the Crimes act. In announcing the death Mr. O'Brien declared in the house of commons that Mr. Mandeville had been injured by brutal treatment. He was kept many days on bread and water, and would have died of starvation but for the compassion of the officers of the prison. Mr. Healy writes that Mr. Mandeville died for the cause of Ireland, that he was killed by the rigorous treatment he received in prison. Mr. O'Brien asked Mr. Balfour what official information there was in regard to the death of Mr. Mandeville, and whether the government would take any measures to secure an adequate enquiry into the cause of Mr. Mandeville's death.

LONDON, July 11.—Private letters, received by the Parnellites, give a satisfactoay account of Mr. Dillon's health. He is receiving careful treatment at the hands of the prison officials, who, it is believed, have taken warning from the death of Mr. Mandeville. Mr. Parnell said that an inquest would reveal the fact that Mr. Mandeville was terribly ill-treated while in prison. He was compelled to pass the night lying on a plank, and was deprived even of a blanket. He passed the time in solitary confinement,

#### in a cell unfit for habitation. Sir Morell Mackenzie.

LONDON, July 11 .- Sir Morell Mackenzie was greeted on his arrival here by a large crowd. Sir Morell stigmatized as fabrications the reports of interviews with him in Paris and elsewhere; henceforth he would not open his lips on his experiences at Charlottenburg and Potsdam. # A SENSATIONAL FIASCO.

THE SALIENT POINTS IN THE GREA TIMES CASE.

There is Probably No Truth in the Suggestion that the Action was Collusive-Among the Bishops.

London, July 11 .- The great Times case has been at once a sensation and a flasco. The disclosures made in the Attorney-tieneral's speech for the defendants have produced a profound impression upon the public, but this only serves to deepen the feeling of disappointment that the mass of evidence which had been collected at such great expense was not laid before the jury. The scale on which the case for the defendants was prepared is sufficient refutation of the theory that the action was a collusive one. I have good reasons, moreover, on independent grounds for saying that there is no truth in that suggestion. Until a few days before the trial serious doubt was entertained at Printing House Square whether the case would come into court at all, but it was his case he would do so thoroughly, and produce a number of important witnesses to refute The Times' attack upon the Parnel-

The points which have most impressed the public are Mr. Parnell's old Forster letter to Mr. Egan and Mr. Frank Byrne's letter from Cannes acknowledging the receipt of Mr. Parnell's check. As regards the former, I understand that all who have examined the document are satisfied of its genuineness. The body of the letter is in the handwriting of one of Mr. Parnell's fellowprisoners. It is known by whom it was passed out of Kilmainham, a person in whose hands the writer was as safe as he would naturally have supposed himself to be with Mr. Egan. The precautions taken were so complete that even if it had been intercepted in transit no suspicion would have attached to the writer. As Mr. Parnell says he never wrote such a letter, of course the signature must be a forgery, but I believe there is no doubt that the forgery was committed in Kilmainham prison on the date given, namely January, '82. In the earlier period of Mr. Parnell's imprisonment he came under punishment for attempting to bribe a warder to carry out a letter for him. Afterward communication with the outer world was carried on freely without expense or

serious risk. One hundred and ten bishops never dined before in England under the same roof. The scene at the Mansion House was very striking on Wednesday. The prelates from the States do not, like their Anglican colleagues, wear purple court dress, but appear in ordinary garb, and it was somewhat difficult to realise that some of the stalwart, moustached men present, looking more like guardsmen than clerics, were actually bishops with vast dioceses.

A very interesting figure was the venerable black bishop, Dr. Crowther, who looked for all the world like a picture of "Uncle Tom" in Mrs. Beecher Stowe's immortal work. Another was the Bishop of Michigan, who was a cavalry officer in the Civil war. third was the tall, gaunt Bishop of Minnesota, Dr. Whipple, with flowing hair encircling his shoulders, who is better known as an apostle to the Red Indians. Some of the bishops well-known to London were welcomed back again-such as Dr. Barry, primate of Australia; Dr. Anson, well remembered as rector of Woolwich, but now Bishop of Qu'Appelle, in the Canadian region where the thermometer often registers forty degrees below zero, and Dr. Mackray, bishop of Rupert's Land. A good many Irish bishops were present, all wearing skull caps. The Archbishop of York made a capital speech, urging that the Prime Minister's bill for creating life peers was a great raison d'etre for continuing bishops as members of the Upper House. The speeches were homely and to the point. The seven hundredth Lord Mayor of London, the first Papist who has occupied the civic chair since the Reformation, welcomed the 92nd Archbishop of Canterbury and the 108th Bishop of London. The Primate made a genial, kindly address. The Bishop of Minnesota, for the American prelates, and the Bishops of Calcutta and Sydney, for the Colonial bishops, also spoke. It being Independence Day, the band played a charming selection of American airs, and subsequently The Star Spangled Banner with variations. EDMUND YATES.

In the Imperial Commons.

London, July 11 .- In the House of Commons last evening, Mr Smith, the Government leader, moved that precedence be given daily to Government business during the remainder of the session. He asked the assistance of the House in making the County Bill workable. He hoped the bill would pass next week. If the members lent their aid to facilitate business the Government would be enabled to adhere to their programme of promoting bills for Imperial defence, for local reforms, for the creating of a Ministry of Agriculture and for several Irish measures. If the work was progressed Parliament would adjourn in the early part of August and reassemble in October. After some discussion the motion was agreed to without division.

## The Mormon Church Troubles.

SALT LAKE CITY, July 11.—Receiver Dye has compromised in the matter of the Mormon Church property. The receiver keeps what property he has seized and has been paid \$157,666 in cash. Further proceedings are to be dropped pending the hearing of the appeal in the United States Supreme

## Women in Politics.

LONDON, July 11.-The relations of women to politics grows closer. The Primrose league provoked the formation of the Women's liberal federation for Gladstonian missionary work, and that in turn has given rise to the Women's liberal-unionist association. The new league seems fairly launched, and more fair fingers are to dabble in the dirty water of politics.



It is understood that Dr. Teche, deputy minister of agriculture since 1864, has been superannuated on account of ill-health, and that Mr. John Lowe, secretary of the department, has been promoted to the position of deputy minister.

# TROUBLE IN THE GUARDS

Captains Thompson, Toller, Cote, Hod gins and Bate Dispute and Resign.

OTTAWA, July 11 .- For a long time rumours of disputes between Colonel Macpherson, of the Governor-General's Guards, and his officers, have been in circulation. Yesterday matters culminated in the resignation of Adjutant Hodgins, Captain Thompson, Captain Toller, Captain Cote and Captain Gerald Bate.

The following is assigned as the reason for the action of the five officers mentioned. A demand was made by the friends of Mr. Le Breton Ross, of the department of railways and canals, who belonged to the Sharpshooters when in the North-West, for a commis sion for him. This evoked considerable opposition from the officers. Mrs. Ross wrote a letter to Major Todd upon the matter. and the five officers who have resigned wrote to Col. Macpherson asking him to call a meeting to consider the letter. The request from the officers was refused by Col. Macpherson, on the ground that the matter was one that should be dealt with by him and not by the officers. There is the resignations of the five were sent ... Macpherson called a meeting of the officers and hopes that the matter will be satisfactorily settled.

## PRINTING LYING REPORTS.

The Truth Will Yet Come Out-The Fibbing Must be Stopped.

Berlin, July 11. - The Nonsische Zeitung declares that the reports printed yesterday of the German physicians, who attended the late Emperor Frederick, were in many respects untrue. It says it is understood that independent authority will soon show, in a statement based on the record of the late emperor's case, that the conclusions arrived at by the German physicians were incorrect. The Messrs. Decker, a publishing firm, have his wife in an insane asylum. commenced an action against the National Zeitung tor publishing alleged false reports of the doctors who attended Emperor, Fre derick. They claim heavy damages. Deckers will issue the official reports of the case to morrow.

## THE PATRIOTIC LEAGUE.

It is Coming to the Front-General Bou langer Gives Advice.

Paris, July 11.—The De Roulede section of the patriotic league will hold a demonstration in front of the Strasburg statue on July 13th. M. De Roulede, in a circular, says: "In occupying itself resolutely with home politics, and adopting for the welfare of the country, and the salvation of the republic. the programme of the leader of the national party, Gen. Boulanger, the league has never for an instant lost sight of its primitive object, viz., the restitution of Alsace Lorraine." Gen. Boulanger met with a cordial reception at Forgies. In a speech he advised his hearers not to cry "Vive Boulanger," but "Vive la Republique" and "Vive Revision."

## Seizing the Irish World.

# THE FISHERIES TREATY

SENATOR HOAR'S LONG THREATENED SPEECH.

A Plea for the " Protection " of the American Fishermen-A High Tribute to Cana-

dian Statesmen. WASHINGTON, July 11 .- Senator George Hoar of Massachusetts delivered his longthreatened address on the fisheries question in the Senate yesterday. The speech in the form of public document makes over sixty close printed pages, besides which the Senator felt impelled to add a summary not contained in the printed document. Mr. Hoar's address was a plea for the protection

of the American fishermen, because the fish-

ermen are the only portion of a nation that

maintain unimpaired their fighting quality

during a long peace. "We pay," said Mr. Hoar, "\$60,000 a year for West Point and Annapolis. Canada exported from the produce of her fisheries in 1887 a value of \$8,843,388, of this we took nearly \$1,500,000. Every dollar of that was only possible enemy, towards the support of a naval school to which Annapolis or Greenwich is quite unimportant. The desire of Canada and Great Britain to contract within the least possible limits the fishing grounds to which Americans shall have access and to possess themselves without obstruction of the calling which brings to this great American market its supply of fish for food and oils has a vastly larger purpose than mere struggle for a profitable in-

dustry, important as that may be." He said the Fisheries Treaty is not the road to honor, to safety or to power; it is not the road to the respect of Great Britain or even of Canada. Where it removes one cause of discord it will produce ten new grievances. Adherence to treaties, submission to the judgments of duly constituted treaties, the same for both sides, will give us security. We can never have commercial reciprocity until justice and courtesy are first established. We can never live in peace with Canada if we allow her to think that the methods she has taken for the last three years are the way to concessions from the United States; we can never live in peace with England if we permit her without prompt and instant protest to try once more the experiments on our forbearance which preceded the revolution, which preceded the war of 1812, which accompanied the war of

the rebellion. The rejection of this treaty is in the interest of a true, thorough and lasting peace. We have every motive of kindred, of friendship and of commercial interest to live in amity with the Mother Country, and with the young power which is rising on our northern boundary, whose frontier for more than fifty degrees of longitude marches side by side with our own.

We look with no contempt or dislike upon Canada. We are glad to see the spirit of her young nationality stirring in her veins; we behold with admiration the growth of her magnificent railroad system and the courage and enterprise with which her statesmen are adding these new links to the chain with which England like a mighty snake is winding her coils about the globe.

Sir Charles Tupper and Sir John Macdonald may well give lessons to both sides of this Cham er. Canada is not afraid to create or control the great railroads that are essential to her commercial prosperity, she does not send away her famous engineers when they place their genius at her command, humbled and baffled from her legislative chamber, to die in sorrow and disappointment. She is not afraid to build a ship railway, or even to create a navy, but when she asks us to abandon our fishermen to her tender mercies to build up a naval school for her by giving her fishermen our market, she asks what is neither fitting for us to yield nor for her to receive.

I do not like the present treaty. It leaves the American sailor to be bullied and insulted without redress and abandons the American right to the fisheries, older than the nation itself, which the valor of our fathers won for us and the wisdom of our fathers preserved for us.

An allusion by the speaker to tue lack o special ability on the part of the American negotiators of the treaty was taken up and contested by Senators Payne and Gray. Mr. Hoar thought that if Messrs. Frye, Scott or Woodbury had been selected as the American representatives a more satisfactory treaty would have been agreed upon.

At the close of his speech Mr. Hoar was

complimented by a number of the Senators on his side of the House.
