The "Times" Doesn't Think Much of the Tricks of American Politicians.

LONDON, Oct. 29. -The Times says : "It seems to be certain that the American government has taken a step that will render it impossible for Lord Sackville to remain at Washington. We are not prepared to censure Lord Sackville. A British minister at Washington or whether elsewhere must be an English gentleman, and he may be forgiven if he is not up to all the dirty tricks of American politicians. If America were not in the thick of a political struggle it would be possible that some of them should enter a protest against the undignified vulgarity and interested unfairness shown by both parties."

LONDON, Oct. 27 .- The Sackville incident has caused a considerable stir in diplomatic circles. Mr. Phelps, United States minister, has gone to Hatfield house, Lord Salisbury's country residence, in Hertfordshire, to see Lord Salisbury. He called first at the foreign office, and finding the prime minister gone immediately followed him to his country seat. It is said that Lord Salisbury favours the retirement of Lord Sack ville.

A SENSATION BY AN ARREST.

A Society Man Turns Out to be a Thief of the Meanest Type.

NEW YORK, Oct. 29. - A Herald despatch from Brussels says E. F. Schwartzkoff, secretary of the United States commission for the Belgian exhibition, who came here with letters of introduction to Prince DeChimay, minister of foreign affairs, and to M. D. E. Moreau, former minister of public works, from the Belgian minister at Washington, who had been received and entertained by the best society in Brussels, was arrested yesterday on a charge of stealing a diamond necklace from M. Barditt, a Parisian jeweller, in 1886, and for numerous swindling operations committed between 1884 and 1882 in France and Belgian. Schwartzkoff, who is a fine-looking man, thirty-five years of age, led a very luxurious life in Brussels. He had subsequently to his swindling operations gone to America, and become a naturalized American. This he thought sufficient to protect him from arrest for his former backslidings, but his arrest proves the contrary. The case has produced an immense sensation in Brussels.

GLASS WORKS SCHEME.

The People of Napanee Nonplussed About

It-The Council Looking Into It. NAPANEE, Oct. 27 .- Richard Davis, the originator of the now defunct glass works, was a prominent figure at the meeting of the ratepayers, Friday evening, when he presented his scheme to employ 500 men. He guaranteed to have \$10,000 placed in a bank to the credit of the council if the council would advance a similar amount, the whole to be used in building the glass works. Mr. Davis' scheme is to bring out thirty of his associates from England. They are all glass-blowers, and are anxious to come to this country. Each will put in \$1,000 and form a co-operative industry. No use will be made of the old glass works. Mr. Davis will erect works down on the flats. Bottles, jars, etc., will be manufactured under the gas process. The ratepayers ordered the council to consider the scheme and ascertain if there is anything in it.

A RESORT TO DYNAMITE.

Six Men, Injured by the Explosion of It-The Work of Discharged Men.

DULUTH, Minn., Oct. 29.—On Saturday some one placed a can of dynamite cart. ridges in the front of a blacksmith shop belonging to one of the street contractors, and when it was fired up an explesion occurred, seriously wounding six men who were there sharpening tools. They were taken to St. Luke's hospital, when pieces of melted zinc, tin and lead were found imbedded in their flesh, causing terrible lacerations. A DAY DEVOTED TO THE CASE IN THE SCOTCH COURT.

The Case Bent to the Procedure Rol for a Becision on Enrious Points.

EDINBURGH, Oct. 29. - In the Court of Sessions on Saturday the case of Mr. Parnell against The London Times was again called. Messrs, Strachan and Balfour, Mr. Parnell's counsel, moved that the closure of the record of proof be allowed.

Mr. Murray, counsel for The Times moved that the question of jurisdiction in this case be sent for determination to the procedure roll. The prosecution had made many alterations in their complaint, they had deleted all reference to the statement that Mr. Parnell had supplied Byrne with money to enable him to escape justice, and it was no longer argued that the statement Sale tales motion bearing the

The judge thereupon said this left the record with only one question.

Mr. Murray said he wanted the question of jurisdiction to go to the procedure roll, because no relevant averment as to jurisdiction had been made. He where the defendant's statements were not met, the plaintiffs made a simple denial. The prosecution had taken no notice of two averments concerning English law.

Mr. Strachan replied that the only question of English law referred to the summons taken out of England. Attorney-General Webster, continued Mr. Strachan, spoke in the O'Donnell trial of the instructions which The Times had given him, but The Times had editorially adopted the Attorney-General's alleged slanders.

The court them granted the motion of plaintiff's counsel that the record be closed. Mr. Murray said the only publication averred in the complaint was that copies of The Times had been mailed to persons in Scotland. This averment he contended was irrelevant. The prosecution, he further said, claimed a right under the registration act to certain funds, to which he was clear the act gave them no right.

The judge decided to send the case to the procedure roll, for a decision on the various points submitted.

The Times' record maintains the whole of its charges. It alleges that the action is an attempt on Mr. Parnell's part to avoid a full inquiry by the Parnell Commission, and to limit the issue of the Commission's work to the sole question of the genuineness of three letters. The defendants do not rely upon the letters for proof of their statements, which are equally true even if the

letters were not signed as purported. On the day before the summons in this case was issued the prosecution secured the issuance from the Court of Queen's Bench of a writ in an action for libel for £5000. As that action is pending other proceedings with respect to the same matter are, by English law, barred. The publication of the Attorney-General's statement in the O'Donnell action and a fair report of the proceedings were privileged by English law, therefore no action can lie. The Times' articles were a fair comment, therefore the defendants should be acquitted. The prosecution's statements are declared to be irrelevant and insufficient to support an action.

The Parnett Commission.

LONDON, Oct. 29. - The great fact of the moment in the history of the Parnell Commission is the fact that the Attorney-General on Friday finished his five days' opening speech. The Commission forthwith adjourned to Tuesday. Sir Richard Webster is thought to have done his work well, though tediously. He was bound to traverse again oft-trodden ground, to recite the history of the Land League and the National League, and to repeat the grim story of out. rage and crime which, in Mr. Gladstone's words, dogged the footsteps of the League with fatal precision. It was his duty as an advocate to endeavor to establish a connection between conspiracy in Ireland and conspiracy in America. It was his duty to allege, and it will be his duty to try to prove, that Mr. Parnell and others were accom-

plices in conspiracy and crime. Sir James Hannen remarked early in the week that the Attorney-General entered upon the case as he thought fit, and was responsible if he made a mistake, and he declined to check him. But as soon as evidence is offered with reference to the proceedings of the League the Court will be called on to rule definitely whether it is or is not admissible. It will be seen, therefore, almost at once whether the Judges intend to narrow the inquiry to the acts and words of the defendants themselves, or whether they will allow the Attorney-General to prove the whole case.

The opening of the Sofia and Vakarel Railway, constructed by Bulgarian resources and Bulgarian labor, has raised Bulgaria's credit and won the sympathies of enlightened people. The gallant army was equal to the position in which it was placed and would justify the nation's confidence.
