The Coming Diocese of Ottawa.

Meeting about three hundred at the
meeting in Ottawa, Tuesday to consider
the division of the diocese. Right Rev. L. L. Ladd,
for thirty-one years in charge of the diocese,
spoke advocating division. He had worked
for years for the division. He did not know
of a single instance where the sub-division
had failed in benefiting the church. He had
been in the ministry for twenty years and
had been successful, and he believed that in
this there would be confirmed a similar
number in each of the new dioceses. Strong
resolutions were passed endorsing the division
and \$30,000 subscribed, of which senator
Clement gave \$1,000 and W. H. Roslyn
\$1,000. Mr. Roslyn sent a letter from a
mechanic engineer \$10 for the fund, on
which it was agreed that fifty cents should
subsidize. He would agree to give \$10 five
years if the ninety-six others would also
do so. Lord Stanley during the evening
made an address encouraging the establish-
ment of a new diocese.
