ABRON REINICH'S DEATH

NEWSPAPER ATTACKS DROVE HIM TO DESPAIR.

His Son-in-Law Said He Did Not Commit Suicide—The Documents of the Late Baron Now in Charge of the Government.

PARIS, Dec. 16.—The principal witness examined by the Panama Committee yesterday was M. Rouvier, who resigned the Foreign Ministerial portfolio, M. Combes, former Minister of the Interior, and Georges Clemenceau, Radical deputy.

M. Rouvier was the first to be examined. He declared he had nothing to add to what he had said on Tuesday. On being questioned as to his taking up the defense of the Baron, he replied that when he left the Reinich residence the Baron appeared to be greatly agitated; that he asked the Baron if he had committed any criminal offence or brought any nephews or deputies, and the Baron replied: "No, I have no nephews or deputies."

Rouvier, continuing, said he could not explain why Baron De Reinich had hoped that M. Herz would have the news paper attacks upon him stopped. He said he had been told that the Baron was to be summoned only as a witness. M. Rouvier added that he had been assured by the Baron's son-in-law that the Baron had not committed suicide.

M. Clemenceau, testifying that Rouvier had asked him to see Herz, said that the Baron was driven desperate.

He presented a pistol to the jailor's face and walked out of the jail unaccompanied and took to the woods. A dozen officers and 100 citizens went in pursuit.

Wauzelot, a lawyer, came to the jail with Fox in front of a shotgun. He captured him half a mile from the village

They were skating on a pond which they were unfamiliar with and skated into an open spot at a inlet where the swift water was not known.
