## DILKE OF THE FUTURE.

POINTED INTERVIEW WITH A MAN OF THE HOUR.

His Idea of the Future of the Empire-His Travels In India-The Annexation of Canada With the United States an Il

logical Deduction. Paris, Jan. 30 .- Sir Charles and Lady Dilke have spent the past week at a quiet hotel in the Rue St. Honore. The ambassador, Lord Lytton, has called upon him, and the way would seem to have been completely paved by the friends of the famous baronet for his return to public life. The manner in which he was entertained by the Marquis of Dufferin at the vice regal lodge at Simla, and his presentations to the Sultan of Turkey by the Queen's ambassador, Sir William White, have excited considerable comment, for it is evident that the Queen's ambassadors, both here and at Constantinople, as well as her viceroy and commander in chief in India, in view of their official capacity, have not acted without due consultation with the authorities at Windsor and at W hitehall.

A correspondent found Sir Charles bronzed and invigorated by his long vacation. He is much thinner than when he sat on the treasury bench as the coming man of the

liberal party. "I have been travelling along the western boundary of our Indian empire," said he, "and as usual have been making notes upon the men and manners I met with. The results of my observations will appear in the March and April numbers of the Fortnightly Review. These articles will be of a military character, dealing with the strategical defences of the empire. After this is off my hands I will settle down to serious work.

"I have for many years intended to re write my work 'Greater Britain,' which, with the lightning march of time in our day, has already become antiquated. This new work will be less taken up with travelling experiences and choses rus than with statis tical studies and political forecasts."

"Will you speak of the Pan-Saxon empire. the dream of Harrington and Froude, Oceania girding the seas!"

"Yes, and decidently teo," said Sir Charles, with a smile. "I shall speak of this and all other questions connecting our colonies and the English speaking countries."

"Then, Sir Charles, you are the very man to speak about the dream of the annexation of Canada by the United States."

"An illogical deduction in which I refuse to follow you," was the reply. "I have read a good deal about this question in the American and Canadian papers of late. But from my personal acquaintance with the views held by the leading men in both countries I do not think that the question is as yet within the realm of practical politics."

"Should Canada desire to be annexed what would be the course of her majesty's government?"

"I have nothing to do with her majesty's government, nor am I even in politics. So I have not the slightest idea as to what would be the action of the government in the eventuality you speak of. Personally, however, I have reasoured believe that the Canadians have not the slightest desire to be annexed. Should they wish it I imagine any British cabinet would let them shape their own destiny, wishing them godspeed.'

## ABSOLUTELY FALSE

Another Witness Commits Perjury Before the Commission and Confesses,

LONDON, Jan 31. - The witness O'Connor, who swore that Timothy Harrington had instructed him to visit tenants' houses at night and intimidate, has made aworn information declaring that the evidence was absolutely felse. O'Connor being sick, and fearing death, sent for a priest and confessed, whereupon the priest insisted upon his making reparation. The Parnellite leaders are disappointed, however, in not obtaining from O'Connor the names of the persons who instigated the perjury. The evident reluctance of the commission judges to deal with cases of contempt of court causes increasing boldness in criticising their conduct. Truth to day accuses the judges of want of courage in not protesting against the impertinence of the attorney general in wast ing their time. No doubt the judges would gladly do so if they dared. The other day, at a dinner, Justice Day was asked by a gentleman how long the commission would last. His reply was that he thought it could only and in one way, and that was the death of one of the judges.

## ANOTHER SCANDAL OUT.

A Young American Loses Her Head-Her Family is in Disgrace.

NEW YORK, Jan. 31. - The Herald's Nice says the most strenuous efforts are being made by Mrs. Wilcox and her friends to hush up the elopement scandal. They have induced the Viscount Du Moiron, the public prosecutor, to keep silence, and he has closed the mouths of the police officials. There is good reason to believe, however, that the runaways have arrived in Nice, and that the mother had an interview with her erring daughter yesterdey. Whether Dr. Sellon is in custody or has been liberated, or what is going to be done, it is impossible to say. MINNBAPOLIS, Jan. 31. - Carlow Wilcox, the father of the young lady who eloped at

Nice, resides in this city. He knew nothing about the report until a correspondent called on him yesterday and handed him a copy of the despatch announcing the fact, Miss Wilcox was one of the bright ornaments of Minneapolis society. The family has a host of warm friends who would be exceedingly glad to hear that the unpleasant report is unfounded.

## Not Pleased With De Lesseps.

Paris, Jan. 31. - Two holders of Panama canal shares applied to the courts yesterday for a summons against De Lesseps. They demand the dissolution of the present company and the appointment of a liquidator with power to make over to a new company the assets of the old concern. The court postponed its decision until Saturday. At the request of a holder of Panama canal lottery bonds, the court appointed a sequestrator of the sums received by the company from all future issues of shares

## Two Men Lose Their Lives.

CORNWALL, Jan. 31 .- Mr. Michael Cline, his son, and a man named O'Neil, who lives on Longue Sault Island, started in a sail boat for Dickenson's Landing, and when about ten feet from shore the boat upset, depositing the three men into the St. Lawrence. O'Neil managed to reach the shore, but the other two were carried out by the current and drowned.

#### THE STRIKE IN NEW YORK.

It is a Serious One-Importing Hundreds of Men From Other Cities.

NEW YORK, Jan. 31. - There is no material change in the situation in New York city this morning. The two days' stoppage of the cars has cost the strikers \$20,000 and the stockholders of the roads \$50,000. The Fourth avenue railroad has decided to run fifty cars to day. Ine Second avenue road will also make its first attempt to run a car. The 42nd street, Grand street, and some other lines will also attempt to run cars. To day many applications for work were made at the Sixth avenue stables. The Eighth and Ninth avenue roads will await the result of efforts to run cars elsewhere before doing anything. It is feared there will be trouble on the belt line to day. The first of the 23rd street cars was started at 7:15 o'clock. It is intended to run all the cars on the road to-day if possible. The Sixth avenue road started its cars at 8:24 o'clock. The Third avenue line is running as usual.

NEW YORK, Jan. 31.—It is reported that the Broadway road has secured 700 men in Philadelphia, who are to be placed on the cars to day. This is expected to make serious trouble. The representatives of all the local assemblies met last night. The men were unanimous in their decision to continue the strike until they are recognized by the companies. The Atlantic avenue railroad, of Brooklyn, have decided to start their cars on the Fifth avenue line to-day. Policemen are stationed along the entire

NEW YORK, Jan. 31.-A car was taken over the Fifth avenue road in Brooklyn at 9:30 a.m. There was no interference. It is rumoured that the Eighth avenue men will probably return to work to day. At 10 o'clock the first Broadway car was started and proceeded quietly down town.

NEW YORK, Jan. 31 .- Word was received at police headquarters at 1:30 p.m. that a mob was gathering at the corner o 58th and 10th avenue obstructing the tracks and threatening to tear them up. A patrol wagon filled with reserves was at once despatched to the scene, and Inspector Steers was telegraphed to proceed there at once.

NEW YORK, Jan. 31. - Inspector Byrnes expresses the opinion that the backbone of the strike is broken. The managers of the companies declare they make no concessions to the strikers. They have all the men they want and will only take the best of the old hands back, and under a pledge of dissociation from the unions. A number of strikers were arraigned in the police court this morning, charged with breaches of the peace. Three of them were sent to prison for a month. Several were held for trial on serious charges, and some were fined.

#### A BRUTE AND HIS END.

The Crime he Committed Before He

Finally Took His Life. NEW ORLEANS, Jan. 31. - Stiene de Champs, aged 55 years, dentist, yesterday enticed Juliette, aged 12, and Laurance Detsch, aged 9, into his room, where he ordered the eldest to disrobe, saying he intended to perform an operation on her. She complied, the younger daughter watch ing his movements. He endeavored to chloroform the latter, but she escaped and gave the alarm. When the police arrived they found the doctor in a nude state lying beside Juliette on the bed. The girl was dead and the doctor in a comatose condition from the anaesthetic he had taken. He was sent to the hospital and may recover. Examination showed that the doctor had criminally assaulted the child before taking the drug himself.

## The World's Cotton Spinners,

LONDON, Jan. 31. - An Austrian publication gives the following interesting figures respecting the position of British cotton manufacturers as compared with that of the rest of the world. The number of spindles in England is 42,740,000; in the rest of the Europe, 23,180,000; in America, 13,500,000; in India, 4,420,000; total, \$1,840,000. The quantity of cotton consumed is: In England, 1,514,521,000 pounds; in the west of Europe, 1,459,110,000 pounds; in America, 944,758,-000 pounds; in India, 300,000,000 pounds.

A Swindle at Chamberlain's Expense, LONDON, Jan. 31 .- While Joseph Chamberlain was on his wedding tour an American swindler, by means of a forged letter, purporting to be from Erastus Wiman, obtained a loan from Austen Chamberlain. He then got a bogus bill cashed at the latter's banker. He afterwards bought a number of orchids, and representing bimself as Austen Chamberlain tendered a forged check in payment for the flowers and obtained a large sum on change. He has not been seen

## O'Brien Put in Gaol.

Dublis, Jan. 31 .- William O'Brien was to day lodged in Clonmel jail to undergo the sentence of four months' imprisonment imposed on him. When ordered to remove his clothing and don the prison garb he refused, whereupon he was seized by warders and his clothing forcibly removed. His heard was then shaved off. #### ACROWN PRINCE'S DEATH

AND HIS END WAS MORE OR LESS CLOUDED IN MYSTERY.

The Career Which He Began Not Followed Out-The Popularity of the Youth Singularly Blurred - The Shock His Demise Occasions in a Political Sense-Who Will Succeed to Austria's Throne?

LONDON, Jan. 31 .-- It is stated that official private telegrams from Vienna affirm that the death of the crown prince was due to a wound inflicted with a rifle.

VIENNA, Jan. 31.—The crown prince had suffered during the last few years from rheumatism of the joints. Yesterday morning he had a severe shivering fit. The Vienna papers do not refer to sensational reports regarding the cause of the crown prince's death. One rumour was that he was accidentally shot while another had it that he was murdered by a peasant. NEW YORK, Jan. 31 -The Times' Lon-

don says it is still a matter of uncertainty

as to how the Crown Prince Rudolf died. The first story from Vienna was that he had met with a fatal accident in the hunting field and I hear now that an Italian officer here has a telegram in cipher from Rome saying it it anderstood there that he was shot by a forester whom he had wronged. But later dispatches from Vienna, although differing as to the locality in which the prince was at the time of his death, agree that he was found dead in bed by his valet. He was a familiar figure in London, and plans for a long visit to England next May were made by him when the Prince of Wales was in Austria. The friendship between Albert Edward and Rudolf was one of the closest existing among European princes. It originally had a basis in a common dislike for young William of Germany. These two young heirs of Hapsburg and Hohenzollern were as boys very fond of each other, being nearly of the same age and purposely thrown together by their parents. William as a lad of 14 spent nearly the whole summer of 1873 at Vienna, at the time of the exhibition there, and played about with Rudolf like a brother. There is now a retired English police dignatary here who was a sergeant of the English section police of Vienna then and he tells a story of arresting and cuffing both boys for falling on a flower bed in the exhibition garden and being overwhelmed with horror when he learned who they were. It was only in recent years that the two young men fell out, and whatever was the cause of their quarrel it was so profoundly bitter that it had been counted upon as a possible factor in the European situation in the future. Rudolf until recently was regarded as a prince of exceeding promise. He was a great linguist, an excellent musician, and wrote easily and well. He affected the society of authors, artists and statesmen, and married one of the prettiest and sweetest princesses in Europe. Vienna was particularly enthusiastic over the young couple, and throughout the empire Rudolf shared to the full the great affection his father is held in. But soon there came a change. He quarreled with his wife, and the public took her side. The tone of his associations visibly sank, and painful stories of his habits and doings began to be circulated ; at the same time his health declined. As a boy he promised to be strong, but when I last saw him in Berlin, last March, he had a pale, sallow, shrunken face, shrouded in black side whiskers and a mustache, but he was prematurely bald, and there were suggestions of bad health both in his expression and carriage. It was there that epilepsy, which is the hereditary curse of the Hapsburgs, specially afflicted him, so that he had constantly to be watched as a precaution against fits. It is quite likely that he died in one of these. The question of succession will create the deepest interest throughout Europe. His only child is a delicate little daughter in her sixth year, and would in the natural order of things be passed over by the Salie law in favor of the emperor's brother, Karl Ludwig, who is a man of 56, and has three sons between 20 and 26. But in view of Rudolf's poor health this question has been discussed some of late, and there is a notion here that some such provision may be made in favor of Rudolf's daughter, as the famous Pragmatic sanction of 1740 by which Emperor Karl secured the succession for his daughter Maria Theresa. The archduke, Karl Ludwig, is not a notable or popular man. His marriage with the daughter of Bomba produced sons who are even less admirable, mentally and morally. Hence, some such plan to keep the dynasty in the line of the little girl and carefully select the right kind of a husband for her, may be resorted to. The funeral of the dead prince will be the greatest pageant Vienna has seen in a cen-

## Some Later Particulars.

VIIENNA, Jan. 31.—Crown Prince Rudolph left Vienna Monday in a court carriage for Breinterfurth, where a cab was to convey him to Meyerling. The crown prince, however, preferred to walk, and did not use the cab. During the walk he conversed with those who accompanied him. On Tuesday the crown prince and his friends went on a hunting expedition. Upon the return of the party the crown prince complained of a headache and retired to his room. He sent a telegram to the palace at Vienna, stating that he would be unable to attend the imperial dinner which was to be given that evening, and wrote several letters in his own room. Wednesday morning he awoke before 7 o'clock and summoned his old servant, Johann, to whom he gave an order to have breakfast served at 7.30 o'clock. At the appointed time his valet carried his breakfast to the room, and was horrified to find the crown prince dead in his bed. The remains were brought to Vienna this morning. A large crowd surrounded the station in this city when the train arrived. The most profound silence reigned. The station itself had been filled with people, but they quietly withdrew when requested

to do so by the guards. VIENNA, Jan. 31.—Crowds of people awaited the arrival of the cortege at the Hoffburg, where the coffin was borne in to the apartments of the deceased prince. An enormous copper coffin was sent to Meyerling, on the same train that conveyed the doctors who had been deputed to enquire into the cause of the death of the crown prince. The body was placed in the coffin but when it was attempted to place the coffin in the hearse, it was discovered that the hearse was too small and it was necessary to use the hearse in which the bodies of the paupers are conveyed as it was larger

than the one selected. LONDON, Jan. 3I.—The Vienna correspondent of the British American Journal states that the death of Crown Prince Rudolff was caused by a rupture of the cardiac walls with an effusion into the peri-
