

# CLAYTON ENTERPRISES.

A Big Furniture Company Organized-A Seed House Under Consideration.

CLAYTON, Feb. 6.-A company has been organized for the manufacture of furniture, and will be known as the Clayton furniture manufacturing company, limited. The preliminary papers for incorporation have been sent to the secretary of state. The capital will be \$12,000, of which \$10,400 has already been provided for, and is divided among 65 stockholders. The location for the factory has not yet been decided upon, but will be inside the corporation limits. The company will build one building 30x100 feet in size, one 30x75 feet, and an engine house and dry kiln about 30x30 feet. The work of building will commence within a very short time. The factory will employ about 25 men, and will hire by the piece. The kind of furniture that will be manufactured at present will be what is known to the trade as bedroom suites. It is the intention of the company to add in the future the manufacture of other wooden merchandise.

An effort is being made by our citizens to induce men of capital and experience to locate a seed house in this village. The prospects are said to be very flattering.

Singing by a Phonograph.

NEW YORK, Feb. 6. - A trial of the phonograph in connection with the long distance telephone was made between the operating room of the American telephone and telegraph company here and the Franklin Institute in Philadelphia. An audience of several hundred persons was antertained by cornet solos and songs by Professor Hoth and Miss Effic Stewart. Some of the cornetist's airs were distinctly repeated back from the phonograph in Philadelphia to the New York end of the circuit.

#### THE PRESBYTERIAN CHURCH.

The Opening of it Next Sunday-A Description Given of the Edifice.

The new Presbyterian church, Westport, will soon be opened for public service. The structure is a little larger than the size of building now in use in Protestant churches. It has a very handsome outward appearance and takes the place of the old one erected in 1857. Rising immediately above the foundation is a white cut stone base following all around the building. On this base rests ed. White and red brick is used, and blocks are formed so as to show a white face next to the main body of red. The pattern is one that compels attention from the passer. by. The church is built with buttressed corners, and buttresses between the windows standing out in relief four inches, leaving the wall like a panel between the stone base buttresses and brick cornice. The tower is 12 ft. square and 40 ft. high. On the tower rests a spire also 40 ft. high, surmounted by an iron ornament. The tower, spire and ornament are built from a design of Mr. Gordon, of Gordon & Heli well, architects, Toronto. Opposite the spire window is hung a bell of 500 lbs. from the celebrated firm of Meneely & Co, West ! Troy. The windows are of stained glass, with patent ventilators, from McCausland & Son. Toronto. The seats, pulpit and communion table were made by the enterprising firm of Conley & Wing, Westport. The model for the seats is from the Andrew's church furnishing firm, New York; the pulpit is from one of Geissler's designs, New York ; the table from one of Shaw & Co's. designs, Boston. A set of five church chairs and cushions for all the seats were furnished by Conley & Wing from the Hault Manu facturing Co., Ingersoll, Ont. A wood furnace in the basement supplies heat to the church. On the wall behind the pulpit is painted in the arc of a circle in large gold letters the motto, "The Lord is in His Holy Temple." Beneath this circle in the centre is a shield about 3 x 4 ft. with the words, "I Love Thy Courts, O Lord." The first of these mottoes shows the relation of the Lord to the house, the second the sentiments of the worshipper respecting the house. The whole is done in the best style of the art by Mr. G. F. Reynolds, who is noted for fine artistic work of this kind. On the wall over the entrance to the church is another motto on an unfolding scroll, "l'eace be Within Thy Walls," seen by the congregation leaving the church. This church is to be dedicated on Feb. 17th. The Sunday services will be conducted by Rev. John Wilkie, M.A., missionary of the Presby terian church at Indore, India, and Rev. J. J. Richards, of Lyn, formerly minister over the congregation. Mr. Wilkie was a class mate in the University of Toronto and Knox college of Rev. David Y. Ross, M.A., the present minister of the church. A teameeting will be held on Monday evening, 18th inst., at which neighboring ministers of all denominations will be present to address the people.

# OVERTAKEN IN HIS SIN.

PRINCE RUDOLPH WHILE ACTING

BADLY WAS SHOT DOWN. Another Version of His Taking Off -Wounded by a Forester Who Mistook Him in the Night - The Gate Keeper And His Conference With the Emperor

of Austria. LONDON, Feb. 6 .- A Munich correspondent believes that the following story of Rudolph's death is true : On Tuesday last a baroness, not named, arrived at Meyerling and took quarters in the game keeper's house near the castle. Her presence was known only to the game keeper and his wife. At midnight Rudolph dismissed his guests and visited her. He had been an hour in the house when a forester, equipped for the chase, going to consult the game keeper, knocked upon the door. A window was opened and a man jumped out. The forester fired at the fugitive, who fell and fainted, having been shot in the shoulder. He was recognized as the crown prince. The forester summoned help and carried him into the house. The baroness thinking Rudolph was dead, quickly took poison and fell dead. Rudolph revived and was taken to the castle. His valet plied him with questions, but Rudolph said emphatically: "I have fallen and my nose his bleeding. Go away I wish to be alone." Rudolph locked the door and shot himself. The baroness was buried on Thursday in the Heiligenkreuzin convent.

The Journal des Debats, of Paris, has a similar story, but says Rudolph was mortally wounded by the forester, and died in half an hour. The game keeper then went into the woods and shot himself. LONDON, Feb. 6.-A Vienna correspond-

ent says the emperor to day gave audience to the game keeper, who, it was alleged, committed suicide after shooting Rudolph. VIENNA, Feb. 6. -Some-Austrian and Hungarian prelates, in accordance with the dictates of the church, refuse to hold memorial services on the ground that Rudolph committed suicide, while the leading bishops and archbishops order services on the ground that Rudolph was temporarily insane when he committed the act. It is reported the pope will take the latter view and issue instructions accordingly. It is rumored that the emperor will shortly publish an address to the people. The emperor has decided to devote the capital of four million florins to the maintenance of Crown
