The End of Virgil Jackson-The Last Night Spent in Singing.

UTICA, March 14.—Virgil Jackson was hanged this morning for the murder of Norton Metcalle in Augusta Centre. The crime was committed on January 29th, 1888, and grew out of the criminal relations between Jackson and the wife of his victim. Metcalfe had ordered Jackson to keep away from Mrs. Metcalfe. Jackson, however, followed her to church that fatal Sunday afternoon, returning in company with her. As they neared Metcalfe's home he came out of the house and met his wife and Jack-A SHOP ON KING STREET, with dwelling son in the road. Words passed between to the country. There were at present men the two men, and then they partially clinched. Immediately afterwards three shots were fired by Jackson in quick succession, and Metcalfe fell to the ground dead. Upon the day of the trial Jackson's plea was self defence, but the plea availed him nothing, and he was convicted of murder in the first degree. He has shown remarkable nerve, and even when informed that the last thread of hope was broken, by the declination of the governor to interfere, did not betray nervousness. He has held that a man gets all his punishment on earth. He refused to see the clergymen. As a prisoner he has been quiet and orderly. He was a fairly good performer on the flute, and passed much of his time in playing and reading. Last night, at his request, local vocalists visited the jail and several songs were sung, Jackson singing with them. # OF TOURING.

THE MINISTERS EXPENSES ARE GO-ING AWAY UP, UP, UP,

And no Details Are Given of Them-Money Drawn in Thousands of Dollars and no Explanations Made-Loose Government Methods and How to Correct Them.

OTTAWA, March 14. - The travelling expenses of ministers were ventilated by Mr. Somerville (Brant) at a meeting of the publie accounts yesterday. An account for \$1,. 000 or so, expenses of Adolphe Caron, was before the committee. In the house Sir Adolphe said that all the vouchers in connection with this expenditure were certified to by the department and forwarded to the auditor-general before being paid. It turned out that no explanation was ever given as to how the money was spent, but it was merely drawn in a bulk sum and certified to as correct by the deputy-minister of militia. As a matter of fact in this case the money was drawn before the minister set out on his trip to British Columbia, and no details were ever given as to how the money was expended or if it was expended at all. Hon. Mr. Bowell, who always resorts in argument to what the Mackenzie government did in every case of this kind, asked Sir Richard Cartwright what was his practice in regard to travelling expenses. Sir Richard Cartwright replied that his habit was when minister of finance to spend the money out of his own pocket, and submit a general statement to his deputy. Dr. Bergin, of Cornwall, disputed the right of the committee to inquire into whether the minister drank soda water or anything else on his journey. The debate on the subject took pretty wide range, seeing the ministers refused to give any explanations, and Mr. Lister made a rather strong speech against the whole system, showing that ministers owed it to themselves that the matter should be cleared up. For instance it was stated freely in the country that ministers used passes not only on government railways but on the Canadian Pacific and Grand Trunk, and notwithstanding this charged their fares in the cabinet who would never-as private members-have thought of expending five dollars a year on cab hire, and now they spent hundreds of dollars and lived luxuriously at the public expense. The outcome of the discussion was that Mr. Foster promised to see that some better arrangement was made for drawing travelling expenses. It is certainly absurd that a voucher should be given for the proper expenditure of a certain sum of money on a trip before the trip was made or the money expended.

### BUSINESS IN THE CHURCH.

Spirituality seems often no longer the test of the chuich's official business success. High social position, shrewdness in the conduct of affairs, are coming to be considered the more important qualifications for a good vestry man or trustee. I do not refer to the episcopal church alone but to the churches in general The man poor in spirit but rich commercial. ly is preferred in a church officer to the man poor in worldly goods though rich spiritual. ly. This commercial tendency is also obvious in pew renting. The rich occupy the choice places, while the poor must sit in the obscure out of the way corners. The church becomes a club house, and this amounts in cases to an exchasion of the poor. If the church was to be merely a means of providing comfort able homes for Sunday orators, and cosy seats for wealthy listeners, the pew renting system might be a success. But as the church is for a common salvation, of rich and poor alike, no system that shuts out the poor or puts the rich into a fashionable house with a saint's name at one end of the town, and the poor into a bare chapel by themselves at the other end, can ever be a system that God will prosper. If it could be known openly in how many parishes at this moment some influential and managing men are secretly discussing the question of how they shall contrive to get rid of the minister because he is not paying well in tillness is refuted by the announcement that pew rents, or how they shall find one that will do that, an appeal of alarm would arise to the ears of God. I have long been an advocate of the free church system. I don't believe men should own the church at all. It should be as free as the winds of heaven.
