SUGGESTING A SALT TRUST.

Asking For a Six Months' Option - A

Benefit to the Trade. HUTCHISON, Kas., March 20 .- All the salt operators in this city have received propositions from the English salt trust, asking for a six months' option on their works, at prices to be agreed upon hereafter. The expressed object of the consolidation is to limit the manufacture to the legitimate demands of trade. The Hutchison people are of the opinion that the scheme would be highly beneficial to the salt industry of Kansas, and would result in largely extending the territory supplied from the Hutchison works.

Hard and Fast Agreement.

PHILADELPHIA, March 20 .- The anthracite companies have arranged a plan for regulating the coal trade during the present year. The arrangement is an allotment of per centages based on the production during last August, September, and October. The scheme differs from the former agreements in providing a money penalty for exceeding the per centage.

Orangemen at Napanee.

NAPANEE, March 20. - The County Orange Lodge met yesterday in the Orange hall here and passed a resolution condemning in the strongest terms any attempt at a compromise on the Jesuit bill. The meetirg was well attended, and there was but one opinion on the question.

THE CLAUSE CANCELLED.

THE RAILWAY COMPANY WILL NOT OFFER ANY PROTEST.

Capt. Carter Appears Before the Council And Tells Why the Clause Was Introduced-Apologies are Made and the Matter Agreeably Arranged-Proud of His Work.

The wise heads of the city were on hand last night. But few had opportunity to express themselves. They were not alone in the chamber either. The gallery was crowded and the seats inside the railing had a sprinkling of prominent citizens. The little round head of Capt. Carter was seen above a chair, while the city solicitor was on hand to unravel knotty problems and declare his position.

Mayor Thompson, in opening, read telegrams sent to J. H. Metcalfe, M.P.P., asking about the bill and ordering its postponement. He added to one, "Council sharply dissents to clause three; can it be struck out if you are advised by council to morrow?"

The reply came : "Clause three cannot be struck out without the consent of all parties. If not mutually satisfactorily in its present shape all parties interested should come up to night so as to be here for to morrow. Have purposely delayed the third reading to give all interested parties a fair opportunity for examination before its final reading. Hon. Mr. Gibson, chairman of railway committee, and myself, desire that every thing be mutually satisfactory to all concerned."

A bill similar to that objected to was before the dominion house, and the mayor telegraphed the Hon. Mr. Kirkpatrick. His reply came: "Fill No. 90 has passed the railway committee and stands for third reading to morrow night. Clause three is only permissive. Consent of city council must be obtained before it is operative."

OTHER TELEGRAMS EXCHANGED. Ald. Gaskin had also telegraphed Mr. Met calfe, urging the postponement of third read ing, and telling him : "At meeting last night blame was attached to you." Mr. Metcalfe replied as he did to the mayor. He wired "My only desire is to act fairly to all con-

Applause tollowed the reading of the despatch.

Mayor Thompson had also notified Capt. Carter to attend. The council expressed its willingness to hear that gentleman.

Capt. Carter jumped right into the subject. He considered that he had done Kingston a kindness in inserting the alleged obnoxious clause, and he was surprised that it had been misunderstood. It was put in so that additional train service could be given the city. The clause was permissive only ; the council had to consent to it first. Nothing was done in the dark, for the bills had been sent broadcast, and everything was above board. He honestly thought the option would be to Kingston's advantage. Besides, by having it included in the bill, it would save from \$300 to \$500, the cost of bills before the parliaments. The city was not bound to accept the option. It could lay it in a safe until needed. As a citizen of Kingston he would stangly object to the clauses being struck out, but as an official of the N. T. & Q. RR. company he would not oppose its elimination.

This declaration knocked the wind out of some aldermen, who had their mouths set to say hard things about the railway company, but its indifference to keeping the clause in made them weaken.

Capt. Carter further added that the city by law would be carried out at its entirety. Later he would tell the council what the company would offer in the way of facilities, and the city could have ample time in which to endorse or disapprove of them. Capt. Carter told Ald. Gaskin that he had the honor of introducing the clauses in the bylaw. The parties to the bill were agreeable

to the clauses. Ald. Harty asked why clause No. 3 was not placed before the railway committee of the council as No. 4 had been?

Capt. Carter was surprised that such had not been done. The by law, passed by the citizens, was in the bill in its entirety. Additional advantages were granted by the clauses added.

POSITION OF THE SOLICITOR.

Ald. Polson wanted to know the position of the city solicitor in the matter. It might be considered that he was censurable for not calling the attention of the chief magistrate to such important clauses.

Mr. Agnew explained that the features of the bill were made public to the chief execu tive officer. As to clause 3 he had offered objection both in Kingston and Toronto. He did not, however, look on the clause as of great importance as it was permissive. The council could always protect itself. He did object, because if the council ence consented the agreement would be irrevocable, but he was told that the consent could be qualified and revoked at will. He was more concerned in having a clause added to the cordwood agreement, making it binding upon the successors and assigns of the Napanee, Tamworth & Quebec railway company.

Ald. Wilson-"Did you get it ?" Mr. Agnew-"We did." Capt. Carter-"You were very strong on

that point.' Mr. Agnew did not think clause 3 conflicted with the by-law. A VERY POINTED QUESTION.

CHURCHILL IS FOR WAR.

AND AFTER THE MINISTRY WITH A SHARP STICK.

The Navy of Britain Not What it is Sup. posed to Be-My Lard is Handicapped in His Attack, But He is Bound to Go Ahead-Attorney-General Webster Intends to Resign.

LONDON, March 20.-A correspondent called on Lord Randolph Churchill in his pretty house in Connaught Place, overlooking Hyde Park, to learn his views on the government's naval policy. He found him in a military mood, determined to smite his old colleagues and spare not, but confining his criticisms to parliament. He says the present position of things is fatal to all ministerial responsibility. For three years the ministers have been declaring the navy adequate, and last year they actually reduced the estimates. Now, he says, thesame ministers come forward saying the navy is dangerously weak. This shows that they have no fixed standard for the requisite naval strength of the empire. He would make the ministers of war and the navy professional men, with permanent seats in the cabinet, but only summoned to cabinet councils for military or naval business. Only so, he thinks, will responsibility be prought home. He further believes England's big ironclads are incapable of fighting, and the construction of new ships is, therefore, indispensable. He would spend more and quicker than the ministers propose, but only after reforming the admiralty and appointing an impartial commission of experts to fix the standard of strength of the British fleet. He thinks an increased expenditure will be popular in the country, but stigmatizes the government's bribing of working class constituencies at bye election of promises of the expenditure as a most unprincipled attempt to corrupt the democracy. In spite of Lord Randolph Churchill's brave word, the liberals distrust his sticking to his guns, and if the govern ment should in reality be in a tight place they think he would back down. He denies this, but says his position is very difficult in any case. He is determined, therefore, to persist, whatever be the consequences.

Sir Richard Offers to Resign. LONDON, March 20.-It is rumored that Sir Richard Webster has offered to place his resignation in the hands of Lord Salisbury, but no decision has been taken. Deputy Speaker Courtney, chairman of committees of the house of commons, has expressed the opinion that the proposed motion to reduce Sir Richard Webster's official salary on account of his connection with the action of the Times against Mr. Parnell will be out of order. He holds that Sir Richard's action was wholly in the scope of his private profession, and has nothing to do with his position as law officer of the crown. Mr. Gladstone, Sir William Vernon Harcourt and Mr. Morley met to discuss the question as to whether their course should be persevered in, and it is reported that they have decided to contest all the points if Mr. Courtney should decline to allow the motion

A HOT GLOVE CONTEST.

The Result of it-One is Completely Knock-

ed Out of Time, SAN FRANCISCO, Cal., March 20.-A glove contest between Jimmie Carrol, formerly of Boston, and Sam Blakelock, of England, took place last night in the rooms of the California athletic club. The men weighed 133 lbs. each. Young Mitchell and George McDonald were Blakelock's seconds, while Sam Fitzpatrick and Tom Meadows acted for Carroll. Hiram Cook was referee. Blakelock was knocked out by Carroll in the

fifteenth round. SAN, FRANCISCO, March 20. - Fifteen hundred people witnessed the fight. It was one of the pluckiest. Both men were scienced, but Carroll was too strong for the English man. The betting was slightly in favour of Blakelock. The fight commenced at 9:45. For the first few rounds Blakelock had the best of it. In the fifth round Carroll drew first blood. Honours were then even until the tenth round, when Carroll did some heavy rushing and knocked Blakelock down only the call of time saving him from a knockout. From that time on the fight was furious, Blakelock standing up and giving and taking heavy punishment. In the twelfth round Blakelock came up fresh, but Carrol was bent on finishing the fight and in rushing Blakelock around the ring got in heavy blows. In the thirteenth round Blake lock was groggy but plucky. Carroll got in some vicious upper cuts but could not knock the little man out. In the fourteenth round Blakelock was still full of fight, and got in some good stabs with his left, but Carroll was too strong and only waiting for a chance to give a knockout blow. It came in the fifteenth round when Carroll sent in blow after blow, finally delivering a terrific righthander under Blakelock's ear, knocking him senseless and winning the fight.

SENSATIONAL ELOPEMENT.

A Married Man of Forty-Five Runs Away With a Girl of Nineteen,

TORONTO, March 20. - A sensational elopement is reported, the runaway pair being Christian Mussen, builder, a man of 45, with a wife and family, and a pretty girl of 19, named Milly Spanner, employed in a business establishment on Wellington street. Mussen has been paying her attention for some months, and the girl seems to have become completely infatuated with him.
