The Only Alternative.

BRAZIL, Ind., May 15 - The two days conference between the local operators in the executive board and the miners' delegation ended yesterday with the operators' refusal to arbitrate the difference in relation to the yearly scale for mining bituminous and block coal. There seems no alternative for the miners but to accept the reduction or remain idle.

The Poles Must Go.

St. PAUL, May 15. - A determined effort is to be made in a few days to evict the Polish and Bohemian squatters on the "upper flats," Two thousand people will be evicted, and the flats will then be used for manufacturing and warehouse purposes. Some squatters have asserted their rights, which gives them title after twenty years residence.

An Action For Libel.

NEW YORK, May 15. - Rev. Father Francis Dent, formerly connected with the Franciscan religious community. of Olean, N.Y., has filed papers in Brooksyn, in a suit against Bishop Ryan, of Buffalo, Charles F. Perron, a newspaper editor in Olean, and a Brooklyn priest, for libel. Father Dent claims \$225,000 damages.

THE KAISER ON STRIKES.

EMPEROR WILLIAM RECEIVES THE MINERS' DEPUTATION.

William O'Brien Causes a Writ to be Issued Against Lord Salisbury for Libel-The Boulanger Prosecution.

Berlin, May 14, - Emperor William to-day received the delegates of the striking miners. He assured them the Government would use its influence to settle the dispute.

The strikers' interview with the Emperor lasted 15 minutes. The Emperor gravely listened to the grievances of the strikers and occasionally asked questions. In reply to their complaints he said he took a deep personal interest in the welfare of his subjects in Westphalia, as he did in the welfare of all his subjects. He had carefully is wed the struggle and he had ordered a thorough enquiry into the facts He warned the delegation against the plottings of political and especially socialait agitators. He grieved that there had been rioting and said that it was impossible to tolerate such conduct. "Tell your fellowwerkmen," he added, "that the Emperor himsel it necessary will order the troops to batter and shoot rioters, while if they are quiet the Emperor will protest them." He hoped the disputants would settle their differences without Government meddling.

In a recent speech at Watford the Premier accused Mr. O'Brien of advocating the murder and robbery of men taking farms from which the tenants had been evicted. It is for this speech that the action is brought.

Anti-Ritualism at Ottawa. OTTAWA, May 14. - At a meeting of the congregation of St. Bartholomew's Church last evening a petition signed by 100 members of the congregation was presented to the rector, Rev. E. A. W. Hannington, complaining of ritualistic practices in the Church of England at large, and St. Bartl domew's Church in particular. The specific charges are the wearing of colored stoles by the rector and the using of colored book marks with crosses on them. The rector announced that this was not within the province of a vestry meeting. Nevertheless he would carefully examine the statements made, and reply to them. Dr. Bell, a prominent member, protested that the rector knew well enough what the charges against him were, and that he should answer them. Mr. Hannington, replying, said that he had received an anony son conrection, but as he never red b anonymous communications he repeated positively that he had not read one word of this particular communication.

THE IRON BUSINESS.

Ex-Mayor Hewitt Says the Duties Will be Cut Off in the States.

LONDON, May 15. The New York Herald's representative yesterday interviewed Abram S. Hewitt who said : "I came here to look into matters connected with the manufacture of steel, more particularly into the Basic process of making open hearth steel. My visit will probably result, in time, in a general adoption in America of the Basic process. I have seen the principal steel manufacturers of England and the admiralty tests, and have gained all the information I hoped to get and I am well satisfied. I am convinced America will make iron and steel for mankind in the long future. We have the iron, coal, capital, skill and energy necessary to do it."

"How about the tariff?" "That is all that hinders us now. That foolish tariff-but that is only temporary. Another generation will see it removed. believe the American people will get tired of stewing in their own fat. I believe every tub ought to stand on its own bottom, and the United States is abundantly able to do it. It has the facilities for being the great. est exporting country on earth. The sooner duties are abolished the sooner it will become so. Now that food, cotton and petroleum, form the bulk of our exports, we ought to expert very largely of manufactured articles.

"What would be the result of removing the duty on iron ?"

"We would simply be compelled to make our iron where facilities are favourable and stop making it in places where they are not. We would have to shut up some of our mills which are now where they have no business to be. The iron and steel manufacture would be confined chiefly to the territory lying between Ohio and Lake Suwerior, to Tennessee and Alabama, and there is where it ought to be.'

"If you think that duties will soon be abolished you do not believe then that the republican party have entered upon a long lease of power ?"

"Yes I do. I believe that the folly of the democrats has given the republicans a long term. By that I mean that the republicans will hold for a long time the power to block progress. The next president may be a democrat, and democrats may quite likely get control of the house again soon but the republicans will retain the senate. There is no chance of their losing that for a dozen years at least."

"What do you think of President Harrison's appointments ?

"They are good on the whole, so far as I have learned of them. The selection of Mr. Lincoln is a very admirable one. He is a gentleman experienced in public affairs, and will make a most acceptable minister to England."

DINING WITH "PUNCH."

MR. GLADSTONE IS FETED BY THE EDITORIAL STAFF.

The Grand Old Man in Bounding Spirits -He Talks Familiarly And on a Great Variety of Subjects - For a Man of Eighty He Has a Wonderful Memory. New York Herald.

LONDON, May 11 .- Mr. Gladsfone's dinner with Punch's staff is still the talk of London, political society being much tickled at the notion of a grave statesman sitting down to meat with the merry men of Mr. Punch's family. The dinner was given at the house of Henry Lucy Toby, M. P.

I have had an opportunity of talking with some of the guests, and have picked up a few crumbs that fell from the table at which Mr. Gladstone sat. The Punch men are chiefly possessed with that feeling of surprise at the Grand Old Man's amazing physical and mental virility which strikes every observer of him. In public life, the only casual indication that he has entered his eighthieth year are an increasing deafness and a slight huskiness in his voice, which wears off as he talks, and he talks with abounding freeness, though, as some one observed, he is also a most attractive listener. One notable thing about his personal appearance is the brightness of his eyes. They are fuller and more unclouded than

those of many a man under fifty. Mr. Gladstone told a funny little story about Mr. Bright's habits. Until the last ten years he had no recognized medical attendant. There was some anonymous and unknown person to whom he went for advice, and of whom he spoke oracularly, "but," said Mr. Gladstone, with that curious approach to a wink that sometimes varies his grave aspect, "he would never tell his name or say where he lived. About ten years ago Mr. Bright surprised Sir Andrew Clark by appearing in his consulting room. Sir Andrew, who knew all about his peculiarities in this matter, asked him how it was he came to see him.

"Oh," said Mr. Bright, "it's Gladstone. He never will let me rest." Mr. Gladstone acted as mentor to Mr. Bright in other respects than his bodily

health. He used to advise him, as the one

panacea for preserving his health of mind

and body, never to think of political matters in bed or on awakening in the morning. Mr. Gladstone said: "In the most exciting political crisis I dismiss current matters entirely from my mind when I go to bed, and I will not think of them till I get ap in the morning. I told Bright this and he said, 'That's all very well for you, but my way is exactly the reverse. I think over all my speeches when I am in bed like Sancao Panza.'" Mr. Gladstone has the great gift of sleep. Seven hours he always gets, "and," he added, with a smile, "I should like eight. I hate getting up in the morning; I hate it the same every morning; but one can do everything by habit, and when I have had my seven hours' sleep my habit is to get up." Mr. Gladstone evidently enjoyed the company in which he found himself, and was in bounding spirits. One thing he said about Homer struck as new the company clustered round him. It was that he evidently did not like Venus Aphrodite, as the great Greek scholar preferred to call the goddess. He cited half a dozen illustrations of Homer's dislike for a goddess usually fascinating to mankind, pictures and

He said that he always liked to go round a picture gallery with an artist. "Artists," he said, "in looking at a picture always see in it less to criticise and more to admire than is possible to ordinary people. An artist sees more in a man's face than you or

Thirty-five times Mr. Gladstone has had his portrait painted. He had, he said, the good fortune to have fallen into the hands of a great artist, who made only the minimum of demand upon his time.

One scene he recalled with as much ease as if it had happened yesterday. It took place in the year 1841. "You were there," said Mr. Gladstone to

Lord Granville, sitting immediately opposite to him, and perhaps his oldest living friend. "You had not left the house of commons then. Didn't you vote in the division? naming the bill upon which the episode was founded. Lord Granville deprecatingly shook his head, and, to Mr. Gladstone's undisguised amazement, could not remember what took

place in the house of commons on a particu-

lar night forty eight years ago. But to Mr.

Gladstone the scene was as present as if it

had happened at the morning sitting of the house he had just left. The question was one on which party passion ran high and forces were so evenly divided that every vote was of fatal consequence. "The whips of those days, somehow or other," he observed parenthetically, "seemed to know better than they do now how a division would go."
