MURDER AT DETROIT.

Lively Fusilade in the Street-Beth Combatants Shot.

Detroit, May 15. - Peter Hartswell, 287 First-street, and his wife had family quarrels which resulted in his wife leaving him and going to live with her father, Wm. Smith, 140 Grand River-avenue. Hartswell wanted his wife to come back and live with him. Mr. Smith refused to let his daughter go. He said Hartswell was a worthless fellow and ill-treated his wife. Last evening Hartswell started to go to a grocery on Grand River avenue near Smith's place. Just as he reached the grocery he saw his wife and another lady at the corner of First and Grand River. He started on a run towards them and Smith immediately left his door running after Hartswell grabbed his wife by the arm and the other lady with Mrs. Hart well struck at him with umbrella. Then began fighting Hartswell, raining blows upon him. Smith ran up and he and Hartswell had some hot words. Hartswell then let go of his wife and made a motion as though he was going to draw a revolver from his hip pocket, when Smith whipped out his revolver and fired. Hartswell also drew a revolver and fired at Smith. They exchanged several shots in rapid succession, then Hartswell turned and snapped the revolver at his wife. Smith in the meantime had fallen to the ground and Hartswell yelled that he was dying. Both were covered with blood. One shot from Smith's revolver struck Hartswell in the left breast above the nipple. Physicians say he will bleed to death. Smith was arrested by the police and taken to the statio . He is probably fatally injured. Hartswell claims he got his wife to come out to speak with him and that he had no intention of doing any shooting, also that Smith fired three times before he (Hartswell) drew his revolver.

BISHOP'S LAST TEST.

The Mind-reader Stricken with Death After Performing a Feat.

NEW YORK, May 14. - Washington Irving Bishop, who became famous in this country and Europe by his extraordinary. and to many people inexplicable mindreading performances, died at noon yesterday at the Lambs' Club. The circumstances attending his death were as singular as, and in perfect keeping with, his remarkable career, for it was the effort to perform a wonderful feat of thought-reading which caused the cataleptic fit that ultimately proved fatal. Bishop had asserted that if two gentlemen would go to a distant part of the house and select a word in some book he would find the book, the page and the word. Dr. Irwine and Mr. Greene descended to the basement, and among a lot of old account books picked out the minute book of the Club and on page 87 selected the word "Townsend," afterwards secreting the book in a disused drawer among some discarded rubbish.

On returning to the room where Bishop was sitting Dr. Irwine endeavored to dissuade him from proceeding in what he ravely informed him was a very dangerous experiment, Bishop having just , been seized with a fit while attempting to perform a similar feat. But Bishop remarked that he would accomplish the feat even if it killed him, and insisted upon his being immediately blindfolded. When the handkerchief had been tied over his eyes he was led downstairs, his right hand being clasped on Mr. Greene's wrist. In due time he discovered the room, then the drawer and the book, and on the leaves of the latter being rapidly turned over by him, he stopped at the right one and then ran over it with a pencil. Suddenly he seemed to make a private mark, and then feverishly

requested that the book be brought upstairs. He had no sooner entered the room where the members were assembled than he pulled a bandage from his eyes and exclaimed, "Quick! quick, give me a bit of paper! and on receiving it he dashed off "Dnesnwot," that being the selected word written backward, so that it could be read in a mirror. He had performed the feat, but scarcel had he written the word when he was again seized by the cataleptic fit, from which he never recovered.

Freight Rates on Beef.

CHICAGO, May 15. - The Freight Committee of the Central Traffic Association yesterday agreed to reduce the beef rate to the basis of 45 cents a hundred pounds, Chicago to New York, taking effect May 18. The present rate is 50 cents by the direct lines while 50 cents has heretofore been the differential rate of the Chicago a d Atlantic, the Wabash Western and the Grand Trunk's Montreal route. The purpose is to abolish differentials and make the rates uniform by all lines. It is feared that the Chicago and Atlantic and the Wabash Western which are not members of the association will now cause trouble.

Mexico's Ex-President Interred. CITY OF MEXICO, May 14.—The funeral of ex President Lordo de Tejada took place today. It was made the occasion of a grand military pageant. President Diaz and his Cabinet officers, the diplomatic corps and more than a hundred generals were in line, besides 8000 troops and 6000 citizens. Students met at a theatre last night where patriotic speeches were made. A proclamation praising the deceased and censuring the Government was suppressed by the police.

Sentenced to be Hauged.

MAYS LANDING, N.J., May 15. - Andrew Grimes, the colored sailor who murdered Mate John Martin of the schooner Annie S. Cart last Christmas day, was yesterday sentenced to be hanged June 20.

Escaped from Brantford Jail. BRANTFORD, May 14. - Charles Hart and Frank Taylor, two Americans sentenced on May 1 to three months in the Central Prison for breaking into a bonded car on the Grand

SHELVED BY THE SENATE

MR. MACLARIAN PUTS THROUGH AN ADJOURNMENT MOTION.

The Victoria University Injunction Matter-A Resolution of Censure Burked-Hon-

orary Degrees Conferred. Cobourg, May 14 .- A meeting of the Senate of Victoria College was held here to-day. The degree of D.D. was conferred upon Revs. Hugh Johntson, D. G. Sutherland and others. After the regular business and conferring of degrees was concluded, Rev. Dr. Potts of Toronto introduced a resolution, which was seconded by Hon. John Macdonald, expressing regret that two members of the Senate should have entered an action for an injunction in the civil court against the Board of Regents and repudiating approval of and responsibility it. This was evidently designed to show; that the injunction was only the work of a part of the Senate and not of the entire body. The resolution was so worded that those who were against federation as well as those who were in favor of it might have voted ditapproval of taking out the injunction. The opponents of federation seemed. exceedingly anxious that no vote should be taken on Dr. Potts' resolution. Lawyer J. J. Maclaren, who has from the first fought against the scheme, moved in

amendment that the Senate adjourn until 2 p.m. to-day. Owing to other arrangements no such adjourned meeting coult be held amendment Mr. Maclaren's was plainly designed to prevent any vote being taken on the original motion. The vote was thus much more significant than had itbeen on a motion for an ordinary adjournment.

Messrs. Potts and Macdonald refused to withdraw their resolution. They insisted that the votes should be counted, and according Mr. Maclaren's amendment was carried by a vote of 20 to 17.

TWO BRUTAL HUSBANDS

Attempt to Kill Their Wives by Shooting

and Stabbing. MONTREAL, May 15 -A man named Francois Laurent, residing on Maple street, is alleged to have been drinking for some time past. He went home under the influence of liquor and quarrelled with his wife, whom he said he would murder. He then pulled out a revolver and shot her through the neck and in the hip. A third shot missed her. By this time the police arrived and arrested Laurent. Medical aid was procured for the poor woman and the bullet extracted.

Though wounded severely, she is not sup-

posed to be in any danger. A woman named Mary Sullivan, aged 39, residing on St. Urbain-street, was brought to the General Hospital. She said that her husband while under the influence of liquor tried to murder her. He took a razor and struck at her face. She put up her right arm to ward off the blows, when he gashed her on the back of the wrist, cutting her to the bone and severing the tendons. He also slashed her across the knu kles, and up the arm, when she managed to escape. The doctor says that she may probably lose her arm. The husband was arre-ted.

Short \$35 Out of \$184,000,000. WASHINGTON, May 14. - The recent count of money at the New York Sub-treasury revealed a discrepancy of \$35 out of \$184,-000,000 to be accounted for. The shortage resulted from the acceptance of a few counterfeit notes in the hurry of business and by the loss of a few pieces of silver. The loss was promptly made good and a receipt in full given to ex Treasurer Hyatt, who was responsible under his bond for the entire amount.

Earnings of Michigan Railways. Michigan railroads for February, 1889 were \$5,738,001 against \$5,550,304 for the corresponding month in 1888, an increase of \$187,697. The earnings for January and February were \$11,185,951 against \$11,007,-656 for the same period in 1888, or an increase of \$178,294.

The Andover Controversy. NEW HAVEN, May 15. - Rev. John E. Russell, professor of Piblical theology (New

Testament) at the Yale Theological School, has resigned. This action created great susprise. The resignation is attributed to a difference of opinion in reference to the Andover controversy, the professor, it is said, siding with the Andover professors.

Simcog's Fire Protection.

NOTES FROM THE CAPITAL. The Ontario Crown Timbers Business-Supreme Court Cases.

Of tawa, May 14. - Mr. Aubrey White, Assistant Commissioner of Crown Lands for Ontario, and Mr. G. P. Kirkpatrick, chief of the survey branch of the same department, are here. Accompanied by Mr. Bronson, M.L.A., they saw the Deputy Minister of the Interior this afternoon. It is understood that the object of their visit is to make final: arrangements for the separation of the Ontario crown timber business from the crown tim ber office here. It is expected that in future all the licenses will be issued, accounts kept and dues collected by the department in Toronto. It is also stated that the bona fide lumbermen who obtained licenses from the Dominion Government to cut timber in the formerly disputed territory will be able to continue as licensees of the Ontario Government on complying with the provincial crown timber regulations.

In the Supreme Court to-day the case of the Canadian Pacific Railway v. St. Therese was continued. The next case is the Exchange Bank v. Gilman. The case of Mitchell . Holland will conclude the Quebec list, after which the Ontario list will be taken up. Two cases on this list stand over until the October session-Macdougall v. Law Society, and Merchants' Bank v. Lucas.

Sir Charles Tupper left the Capital this morning at 8 o'clock for Montreal, there to take the Parisian for England.

THE JESUITS' ESTATES ACT. Resolutions to be Submitted at the Hamilton Meeting Monday Night.

HAMILTON, May 14.—The speakers at the anti-Jesuits' meeting next Monday night will be: Principal Caven, D.D., Rev. D. J. Macdonnell, B.D., and Mr. John Charlton, M.P. Dr. Macdonald will occupy the chair. The resolutions, five in number, to be submitted to the meeting have been prepared by the Committee of Arrangements. They disapprove of the act incorporating the Jesuits and the Estates Act, regret the defeat of Col. O'Brien's disallowance resolution, determine to petition the Governor-General to call a special session of Parliament without delay for the purpose of reconsidering that vote. failing in this to pray that the House be dissolved, express sympathy with the Protestant minority of Quebec in view of their many disabilities, declare for the complete separation of Church and State, appoint a committee to give effect to the resolutions, and delegates to represent the citizens of Hamilton at the Toronto convention on June 11 and 12. First Blood for the Jesuits.

MONTREAL, May 14.—The Jesuits scored the first point this morning in The Mail libel suit. Judge Loranger dismissed The Mail's exception to form and struck from the plea all matters and issues raised in the plea except in so far as they refer to the constitutionality of the act of incorporation of the Jesuits and the oath published by The Mail. Notice of appeal will immediately be given.

CONMEE & M'LENNAN IV. C.P.R. The Trial Begun at Cobourg Before Chief Justice Armour.

COBOURG, May 14. The trial of the celebrated railway suit of Conmee & McLennan and the Canadian Pacific Railway began in the Court House here at 12 o'clock to-day before Chief Justice Armour, who is holding a special sitting of the court for this purpose. The town is tull of lawyers and railway men The C.P.R. is represented by Hon. Edward Blake, Q.C., Hon. S. H. Blake, Q.C., and Hon, R. M. Wells and Conmee & McLennan by D'Alton McCarthy, Q.C., Donald Mac-Master, Q.C., and Wallace Nesbut.

Mr. McCarthy opened by a clear statement of the case and explained the different stages the action has gone through during the past four years. The litigation arose out of construction of part of railway in 1883 along the north shore of Lake Superior, the amounts involved are in excess of \$500,000 and each party claims the other is indebted to them.

The first witness examined on behalf of LANSING, May 15.—The earnings of Conmee & McLennan was John Ross of Montreal, formerly manager of construction for the company, at Port Arthur. He stated he had let the contract and had full authority to bind the C. P. R. Mr. Ross himself is now suing the company for whom he is not now working. The cross-examination, conducted by Mr. S. H. Blake, was in progress at 6 o'clock when the court adourned and is very search ing, Mr. Ross being considered an importan-

WORK ON THE NEW PARLIAMENT BUILDINGS RESUMED.

Why the Proposed Schemes for the Delivery of Drop Letters by Private Companies

Will Fall.

TORONTO, May 15. - The recent change in the cost of drop letters has started the quidnuncs upon a scheme for ousting the jurisdiction of the Postmaster-General in this respect. But enquiry yesterday at the Postoffice-elicited the information that the Great Northwestern Telegraph Company or any other association or firm are likly to find themselves in difficulty if the proposed scheme is carried out or attempted. The Postmaster-General has a monopoly of the collection and delivery of letters in Canada and anbody infringing is subject to a penalty of \$20 for each offence. The exclusive privilege of the Postmaster-General does does not embrace letters sent by a friend, who is journeying or traveling, provided such letters be delivered by such friend to the party to whom they are addressed; nor' letters sent by messenger on purpose, concerning the private business of the sender or receiver: nor letters concerning goods sent by common carriers to be delivered with the goods without hire or reward, profit or advantage for receiving, or delivering them. But no person is allowed to collect any such excepted letters for the purpose of sending them or conveying them, and any person employed in the Postoffice of in the Inland Revenue Office or Custom House can seize any such letters so conveyed, received or collected, sent or delivered and take them to the nearest Postoffiee and give such information to the postmaster as he may be able to give and as " is necessary for the effectual prosecution of the offend & and the letters shall moreover

Yesterday mo ning the engines at the new Parliament Buildings were set going again, creaking cranes lifted huge stone blocks into position and the sounds of industry echoed over the vast extent of the foundations. He will now be superintendent of construction. Mr. J. B. Vick was the late Mr. Yorke's foreman at the Esplanade stoneyard. Mr. Vick is superintendent of the stone cutting department. Mr. Carroll will provide supplies and do the financing. The contract will be completed at the figure it was originally taken at. difficulty in the settlement of the contract was between the new firm and the Yorke estate. The matter is now, however, definitely settled and as Mr. Carroll has given \$35,000 extra security the Government has no fear that the contract will not be carried through. Mr. Carroll says that every effort will be made to have the west wing and the centre of the building ready for the wall plates by the end of the year.

Manager Hill of the Industrial Exhibition Association figured in the new role for him of a peanut auctioneer yesterday afternoon. Up to last year the privilege of selling peanuts on the Exhibition Grounds during the fair had been given to one man, John Abate, for \$65. The other Italians in the business began to kick, and this year it was determined to sell the privilege by auction. At 4 o'clock yesterday afternoon many Italians assembled in the rooms of the association in Church-street ready to try for the coveted monopoly. Manager Hill did the auction business, starting with \$50. This speedily ran up to \$295, at which figure it was knocked down to John Abate.

The Ontario Grand Lodge of True Blues commenced its annual session yesterday at Shaftesbury Hall. Grand Master Bunting, Lindsay, presided. Deputy Grand Master Diamond, Belleville, was in the vice chair and Rev. E. B. Sibbald in the Grand Chaplain's chair. There were 113 delegates present. The reports of the Grand Master, Grand Secretary and Grand Treasurer were presented and referred to committees. Grand Master Bunting's address expressed satisfaction at the presence for the first time of representatives of lady True Blues and 16 new warrants were issued during the past year. The necessity for a revision of the constitution was referred to and the traitorous conduct of the two members who gave away the secret work of the order. The agitation for unrestricted reciprocity, commercial union or annexation was condemned, as was also the passing of the Jesuits' Estates Bill with those members of the Dominion Parliament, particularly of the Orange order, who voted against disallowance. Mr. W. R. Meredith was complimented on his stand against French in the public sch ols. The present Grand Lodge officers were also commended for the manner in which they had fulfilled their duties. In the report of Grand Secretary Worrel the progress of the order was ascribed to the efficiency of the various grand and district officers and tothe aid given by The Orange Sentinel. The report of Grand Treasurer R. A. Newman contained the statement of the financial position of the order, showing it to be good. The Grand T. easurer also discussed the Jesuit question at considerable length.

quite comfortable. Lockepor was visited by a terrific thunder and lightning storm yesterday morning. Two houses were struck by lightning-Captain Colin McKay's and Dean Lloyd's. The former was considerably damaged, the electric fluid passing down the chimney, shattering it and then going out the end of the house, tearing off boards, shingles, etc. Lloyd's house was almost wrecked, windows were broken, floors torn up, roof lifted and partly stripped of boards. The shingles were broken into matchwood and scattered over the fields. Mrs. Lloyd was in bed when the chimney fell into the room, covering the floor and bed with bricks but not injuring her in the least.

A Strike Settled.

PITTSBURG, May 15. - The strike of the railroad coal miners of this district, which began two weeks ago, for a uniform yearly scale of 74 cents a ton, was settled yesterday. A compromis wes made at 73 cents a ton. About 7000 men will resume work

The C.P.R.'s Ningara River Bridge.

ALBANY, May 14 .- In the Senate to-day Senator Laughliu's bill to incorporate the River Bridge Company (to give the Canadian Pacific Railway Company a brudge over the Nugara River) was opposed by Senator Linson, who characterised it as a dangerous measure and asked that the bill be recommitted to the Railway Committee, Senator Laughlin defended the bill, but Senator Linton's meeon was carried, 20 to 1.
