Happily no discussion is necessary in our case as to building breakwaters or planting tamaracks to keep a lone island in a state of decent repair! Of course we ought to claim no special credit for these natural accessories, but it is just as well to remind the people of the Ontario capital that blessed as they are, no doubt, with overshadowing greatness, they have not complete monopoly of every advantage.

THE AMENDED SCHOOL ACT.

The Ontario Government deserves the public commendations for its untiring endeavors to improve as near perfection as possible our educational legislation. A part of this plan, and no unimportant one either, is to rectify several glaring discrepancies and imperfections which now prevail in the constitution of School Boards and the election of Trustees. Anything which will beget a more lively and widespread public interest in school affairs should be heartily welcomed, and if the proposed election regulations prove to be a means to that end, quite a forward stride of improvement will have been made. The system, as it is, is the cause of confusion, and the election of Trustees into one and the same day, prevented, to a considerable extent, the deliberate selection of Trustees on the part of the people, the whole affair being over before many knew anything about it. The new law will assign one day for the nomination, and another, a week later, for the voting, if any. Then, the voters' list for this purpose will be made to include all who are eligible at present to vote for members of the Legislative Assembly. In short, the new Act will harmonize the mode of electing School Trustees with election for Municipal and Parliamentary purposes. It has not yet transpired whether the ballot is to be employed or not, but the other changes are all improvements, and as such will be actively accepted by those who take an active interest in the cause of public education.

The arrogance of the Princess street organ may prompt it to say some very contrary things, but we most unhesitatingly assert that there was considerable discussion over the Speaker's report, prior to the election, and since it. If there was a pretty big row outside of it, and the end is not yet.

Sir John may have been too sanguine in predicting an immediate return of prosperity, as a revival of anti-depression prosperity under such circumstances is something which cannot be expected in a few days, weeks, or even months. As far as the National Policy is concerned, it has not yet been announced." Refreshing words! The delay in improving the times is unpardonable. If Sir John is capable of doing anything for his country, why the hesitation! The election demand action, now or never.
