THE EFFECT IN GREAT BRITAIN.

London, July 8.—The scene in the House of Commons to-day when the Home Secretary confirmed the statement that England had assumed the protection of Asia Minor was highly exciting. The House was crowded with members of the diplomatic corps. The gallery was filled. The Home Secretary with unusual clearness and decision said the treaty had nothing to do with the questions that have been or are to be discussed at Berlin. It may be communicated to the Congress as a matter of courtesy, but no representations concerning it or a modification of its provisions will be listened to. The treaty has been signed and sealed and goes into instant operation. The Home Secretary closed his speech with a hearty cheering by saying the provisions of the treaty will be well calculated to promote the interest of the best and highest interests of England and Turkey. The execution of the treaty is great. It is understood that the 7,000 Indian troops now at Malta are to proceed forthwith to Cyprus.

Our Island Park.

The Detroit Daily News says—Justice Mackay, of the Court of Queen's Bench, Montreal, held that divorce granted in the United States to persons married in Canada and not valid, even though the parties may have fulfilled all the requirements of the law in the State in which the divorce was granted. According to the decision persons who, after having obtained such divorces, re-marry in Canada, commit bigamy and live in adultery. Across the Atlantic, married persons have had more than enough of one another, the Courts often find it so difficult as the divorce law in the United States holds out. To obtain a divorce in Canada it is necessary to secure the passage of a special Act of Parliament, which is always a matter of difficulty, accompanied as it must be by a trial before a Judicial Committee of the Senate. Under such circumstances it is not surprising that dissatisfied wives and husbands, who could not obtain relief at home from their matrimonial burdens, have had to resort to American Courts. There are hundreds of men and women in Montreal who have been through the same process in various States and who are remarried, so that Judge Mackay's decision is likely to carry consternation into the homes of a host of re-married divorced people, who have, up to the present time, fancied themselves secure and their children legitimate.
