### THE EGYPTIAN CONVENTION.

### The French Circular in Regard to It-A

Settlement of Dispute Desired. Paris, Aug. 2.—M. Flourens, minister of foreign affairs, has sent a circular to foreign agents regarding the Egyptian convention. He says that after the rejection of the convention there was a noticeable spirit of conciliation manifested by England. The convention's two points were: (1) The abandonment of part of the Sultan's suczeraintly to a christian power; (2) the absence of a specified date for the evacuation of Egypt by the British. He believes that if negotiations are renewed it will be easy to arrive at a useful result by avoiding these difficulties. He concludes by expressing the hope that Lord Salisbury will not deceive himself regarding French sentiment on the subject. There is nothing hostile, he says, in his policy. France continues to desire a settlement according to the wishes of all the powers.

### WAS IT A COUP D'ETAT.

#### M. DeLafosse Explains the Case Giving Rise to Sensational Rumours.

Paris, Aug. 2.-M. DeLafosse, who was accused of having proposed a coup d'etat to General Boulanger, has published an account of his relations with the general. He says he often had occasion to visit General Boulanger on official business at the war office. The general was always affable. M. DeLafosse congratulated him upon his raising the moral tone of the nation, after 15 years of depression. General Boulanger replied that a hundred generals had urged him toward war, but he had been compelled to dampen their ardor. M. DeLafosse told General Boulanger that he was wining all the popularity that parliament was losing, and that if he played his cards well he might rise very high.

### A GOOD MAN GONE WRONG.

#### A Stratford Man Lights Out When a Bank Looks Over His Accounts.

STRATFORD, Aug. 2.—H. A. Jamieson, in the grain business for about five years, has left. The bank of Montreal held, it is said, about \$13,000 worth of warehouse receipts of his. They deemed it advisable to hold an investigation. Jamieson came here from St. Mary's about five years ago and has always taken an active interest in church and municipal matters. He is a member of the collegiate institute board and the board. of aldermen, in which he is chairman of the finance committee. A short time ago he was a partner in the Stratford Herald, and had some aspiration to be a member of parliament. He has been a frequenter of the bucket shops, but whether he was ruined by cat speculations or not is conjecture.

### THE CHICAGO BOODLERS.

DETAILS OF M'GARIGLE'S SUCCESS-FUL ESCAPE TO CANADA.

The Sarnia Chief of Police Asked to Arrest Him-But the Order is Not Yet Executed-The Captains of the Schooners Blake and Marsh Make Statements-McGarigle a Perfect Wreck.

CHICAGO, Aug. 1 .- A despatch from Port-Huron, Michigan, gives another account of McGarigle's landing in Canada. When the tug Orient approached the schooner Blake the schooner Marsh, next ahead, let loose the tow line and the Blake dropped astern. Her captain and crew raised a tremendous row for a couple of minutes, keeping the attention of those on board the tug. Meanwhile McGarigle, transferred to the Marsh, in the straits, was bundled into a yawl and sculled ashore. When the officers of the tug discovered the ruse every effort was made to catch the yawl, but it got into shallow water before they could reach it. Mc-Garigle jumped ashore and ran up the street. A reporter for a Chicago paper went aboard the schooner Marsh, whose captain, Freer, told the following story:

"While we were loading cedar in the straits a tug came alongside and wanted to if I had seen anything of the Blake. I said I had not, and he told those on board that they were detectives and believed McGarigle had an unusually trying experience with and knew McGarigle by reputation. I told their captain. He was very reticent. After a good dealof coaxing

he said: "When I got to Chicago a friend of mine came to me and asked me if I would take a passenger to Canada, landing bim at the first convenient point. After some hesitation I consented, providing that he would not tell me anything about the party. suspected that his friend was in trouble. was to let him know when I would be ready to sail. On Saturday afternoon I met him in a buggy in Fifth avenue. We drove around, and I arranged with him to have his triend meet me that night at the cigar store at the corner of Rush and Michigan streets. I also told him when the vessel would be ready, and said I would drop down the river and lie at the north pier until the party, who was to be known as Wil liams, showed up at the appointed place. cleared at the barge office at eight o'clock and went over to the cigar store. A little after ten o'clock, a man whom I recognized by the description given me, came in. I asked him if his name was Williams. He nodded his head and we went down to the vessel together. Then we turned out and got along all right, only the wind has been tantalizing during most the entire voyage.'

Captain Irwin contirmed the story of the master of the schr. Higgie as to meeting the Blake off Manistee. He would make no definite admissions regarding the person who arranged for McGarigle's passage. In nearly all of his conversations he spoke guardedly, but he let out enough to strengthen the suspicion that Dr. St. John and Janitor Dell knew more about it than any other persons. The reporter went back to Sarnia and

found McGarigle, who appeared to be terribly changed. His features are haggard and sallow. "'I am worn out with worry and excitement," he said, "and it would be simply torture for me to comply to the extent you desire. I am sick and need rest so badly that I must ask you to wait until to-morrow. Say for me that I will be back to Chi cago in less than three months, and when I come I will not be hounded as a rascally thief. This investigation that is now being held will develop my innocence of any corrupt act, and will convince the people of Chicago that in spite of all the 'squealing' that is being made in court, am not implicated in any crooked transactions. The worst that can be said of me is that I had money given me by contractors to give the county commissioners. Not one cent of it stuck to my fingers. am a poor man to-day." McGarigle said he p'anned the escape himself, and regrets that he was obliged to impose on the generosity of Sheriff Matson as he did. "If I stayed in gaol," he said, "it was absolutely certain that I would have a spell of typoid fever. My system could not stand that, and it became imperative for me to get out. An op portunity for escape presented itself and embraced it."

### McGarigle to Be Arrested.

CHICAGO, Aug. 2.—A telegram from Sar-He | nia says instructions have been received from State Attorney Grinnell, of Chicago, and the chief of police to arrest McGarigle on an indictment issued at Montreal. The Sar-

#### nia chief of police has not been able to find McGarigle, and the supposition is that he

has left town.

A second bondsman was required on Dr. St. John's bond, but after many hours' search could not be found, and late in the afternoon he was immured in a cell. #### Experiences of the Captains.

It is said in Chicago that Capt. Langan, formerly of Wolfe Island, of the schr. Oliver Mitchell, now on the way to Kingston from Chicago, was approached early in July for the passage of an unknown to Canada for which service he was to be handsomely paid. The captain agreed and at the appointed time the vessel drew alongside the dock indicated: The vessel had only been there a short time when the gentleman who had made the arrangements appeared and told Capt. Langan that he would have to go without his passenger as their plans had been frustrated. It is suspected that the passenger was to have been McGarigle, who escaped on the schr. Blake. The captain, when interviewed in Chicago, would not deny the

Capt. John Irvine, on whose vessel the Chicago boodler is said to have reached Canada, is about forty years of age and has been sailing all his life. Last year he was in command of the schr. Maggie McRae. Previous to that he had charge of the prop. City of St. Catharines, which sank on Lake Huron. He is a widower and a native of Port Dalhousie. Before the schr. Blake ran through the Mackinaw straits it was said that her hull was repainted so that she could not be detected. The colours in which she was decorated were red and white. When Capt. Irvine left here July 2nd he had on board a large quantity of red and lead coloured elastic paint. He evidently made good use of it. The voyage of the Blake is the subject of much discussion in marine circles and many captains think that it will be injudicious for Capt. Irvine to get into the grasp of the Chicago authorities. While passing Detroit he indignantly denied that McGarigle had been aboard his

#### No Word From Stauley.

London, Aug. 1.—A dispatch from St. Paul De Loanda, dated July 31, says:

"Mr. Janssen, governor of the Congo free state, writes from Borna that since receiving the news of the arrival of Stanley at the camp on the Aruwhimi river, no. messenger has arrived from the upper Congo, and that the first news of any accident that may have happened to Stanley must be brought by the Congo state messenger, who is expected to arrive at Borna in a few days."

### The Verdict Arrived At.

ST. THOMAS, Aug. 2.—The jury who held the inquiry into the late collision found Henry Donnelly, engineer, guilty of criminneglect, and that the accident was caused through the unfit condition of the engineer, and through the neglect of the conductor in not inspecting the brakes. The drowning of a young lady at Port Stanley was charged as a result of neglect. The better accommodation of passengers on excursion trains was strongly advised.

### Progress of the Fishery Case.

On this account he proposed that the combatants exchange shots until one was hit, the choice of the distance to be left to the seconds of M. Terry. These conditions not being accepted. General Boulanger's seconds agreed to be content with an exchange of shots between the principals at twenty paces, without any word of command. Considering this proposal to embody, the extreme limit of General Boulanger's formal instruction, his seconds did not feel authorized to make any further proposition. M. Terry's seconds would only accept a duel at 25 paces with a single exchange of shots, the fire to be opened at a word of command. Thereupon as the offended party has the right to dictate the conditions of a duel without being obliged to submit to terms dictated by his adversary's seconds General Boulanger's se
