

SANITARY MATTERS.

A meeting of the board of health was called for yesterday afternoon, and only the mayor and the city's medical officer put in an appearance. This is to be regretted, since there is no season in which the sanitation of the city is deserving of the attention that it does now. True Dr. Fee can go on with his irspection, exercising the powers he possesses to have removed and suppressed whatever has a tendency to injure the public health. But he is laboring under many disadvantages, and can never hope to act with the fullest approval, if not appreciation, of the people as things now stand. He is giving to the duties of his office more time than the city can really expect from him, and reward him so poorly; but he acts conscientiously and with a due sense of the responsibility resting upon him.

The fact is not apparent to everyone that the drains of the city are just now the fruitful source of disease. It is some time since the rain fell sufficiently heavy to flush them out, and the obnoxious matter in them is sending forth effluvia which cannot be breathed without serious danger. There is no way of abating the smells but by flushing out the drains, and the present relations between the water works company and the city do not suggest the asking of favours on the one hand and the conferring of them on the other. There is no help for it seemingly but to endure the present miseries of life and run the present risks of disease until such time as boards of health can be induced to attend to the business for which they are elected, and the city owns the water works and can use it, in connection with an improved sewage system, in washing away the filth of whose existence one gets a disgusting reminder at almost every street corner.

WANTING A POLICY.

In the great speech which be made at the Somerset pic-nic, tendered as complimentary to him, Hon. Mr. Laurier touched upon commercial union, and in these words: "I am not ready to say that the propaga. tors of this scheme pretend to present it as a definite policy, but rather as a feeler for reciprocity, which, as all admit, has always been one of the strongest planks in the liberal platform. Sir John has admitted that the merit attached to the old recipro city treaty was due and due alone to the liberal party, and the same authority asserts that the interchange was of great last. ing utility to the people of the Canadian provinces. Sir John said in the first days of the N. P. that the Americans would be forced to grant us favorable trade relations, but the contrary has been the result, which every farmer will admit with reference to the movement championed by Mr. Butterworth and Mr. Wiman. I am not prepared to say that commercial union is an acceptable idea or that it should be adopted. It will be necessary to take up and discuss a great many preliminary matters before defining the policy, although I do not hesitate to affirm that it is time to put an end to this fatal policy of retaliation, which can assuredly be done without disturbing our national dignity or impairing our national honor." If it is time to put an end to the policy of retaliation, followed by our gov. ernment towards the American government, it is time the leaders of political parties were prepared with a substitute in the shape of reciprocity. Mr. Laurier is following in the foot steps of Mr. Blake in his treatment of fiscal questions. The people cannot admire timidity in a party leader, and it behooves Mr. Laurier to have definite ideas of some sort. He cannot hope to a programme of some sort, the bolder and more aggressive the better, and sticks to it until the opportunity occurs for a test of its popularity.

STICKING TO PRINCIPLE.

The Montreal Witness is rather pleased with the result of the election in South Renfrew and deals with it in a series of articles. In one place it says that "the pain inflicted on true liberals by the South Renfrew election will be as small as their satisfaction would have been if Mr. McIntyre had succeeded;" and in another place it deals with party interests in this vigorous manner:

"The liberal party has something to learn from the defeat of Mr. McIntyre He was thoroughly endorsed by their leaders, but true liberals will not vote at the bebest of leaders for candidates whom they do not trust. The campaign of the liberals in South Renfrew was carried on by men who were married. protectionists, who were in favour of the Canadian Pacific railway monopoly, who held, in fact, none of the doctrines and were bound by none of the principles which it has always been said have been a weakness to the liberal party. Yet they have suffered the most decisive defeat which has yet been encountered by the liberal party. the Canadian reform party is ever to be power in the country, it will be through ad-

THE CHICAGO BOODLERS.

Exciting Scene in Court-McGarigle Still Resting Safely and in Canada.

CHICAGO, Aug. 4 .- The defence in the "boodle" trial has rested the case. Practically no testimony was produced on behalf of the accused, except a general denial from each of thems and evidence as to their previous good character.

The first address was made by Assistant States Attorney Walker. As Walker went on with his denunciation of Wren the face of the defendant grew pale with anger and passion. When Mr. Walker alluded to the fact that Wren had forged Walker's name to a bill for buggies supplied to the county he turned around, and, pointing to Wren, said solemnly: "And when he said in court he did not know his own writing, when his forgery was placed under his eyes, he perjured himself. Dan Wren is a perjurer."

"You're a liar," came thundering from the defendant's corner, and the ponderous commissioner /arose steaming with passion. Instantly all was in commotion.

Walker's face turned crimson and his eyes sparkled like fire. "Yes," he cried. "I repeat it. Dan Wren, you're a perjurer." "You're a liar, you're a liar," yelled Wren, as with clenched hands and teeth he advanced toward the state's advocate.

"Cease this moment," exclaimed Judge Jamieson, and he hit the desk a blow with his hand. When Wren repeated the insulting remarks the judge turned pale, then red. "Pon't let me hear another word out of your mouth, Wren," he thundered, and Wren was forced into his seat by a pair of bailiffs. At once Wren's attorney, Colonel Munn, sprang to his feet and tried to address the court.
