A CASE OF MURDER.

A Well-Known Railway Man Found Shot in the Village of Parkdale.

Toronto, Aug. 26.—Parkdale is excited over the murder of Joseph Priestman, jr., agent for the North Western Masonic association, of Chicago. Constable Smith, a lamp lighter on Dean avenue, near the lake shore, discovered a man lying across the sidewalk in a pool of blood and dead. He had a bullet hole through his head. A British bull dog revolver from which the bullet had evidently been fired lay along the sidewalk, together with a number of the dead man's papers. The pockets of the pants were turned inside out, and robbed of their contents. His gold watch and chain, and ring were left. THE ROUGH CRITICISM OF THE BELLEVILLE PRESS.

Apparently More Hostile Than There is Any Occasion For-The Deliberate Attempt That Was Made to Rattle Young -And it Was a Success Belleville People Stuck on Their Club.

Yesterday's game was a corker. Instead of being a beautifully scientific one, it was full of the wildest errors and constant bick erings. The umpire, Mr. Sagendorff, had a hard row to hoe. He tried to do the square. thing, but pitcher Young was obstinately bound to irritate the Bellevilles by pitching out of position, and Jones and Morrison so persistently "chewed" on him that it was a wonder things were no worse. From the umpire's position it was hardly possible to tell whether the pitcher had his right foot on the rear of his box. Young knew this and although it could not help him any he kept his foot from six inches to a foot too far forward until finally the umpire had to stand behind him instead of behind the batter. Then, after Barnfather was disabled in the fourth inning by a hot tip that struck him beside the knee cap he threw as if he was bound to give Ambach and Trainor a bad record for pass balls, and apparently deliberately tried to hit Jones and Morrison as they batted. Indeed, he succeeded in giving Jones a savage whack and jumped out of his box to do it. In previous games Young showed up well as a pitcher and player generally, although the crowd used to guy him good naturedly when he failed to follow the advice he freely gave to others. He set out to make his opponents mad and ended by getting desperately vexed him-

Another thing that calls for adverse comment was the order in the grand stand. Whether instructed to do so or not the police should promptly check the abominable language in which some gentlemen (?) indulge. One obstreperous individual was ejected after making a horrible nuisance of himself. He afterwards started a fight which was promptly stopped. If such goings-on are not severely dealt with base-ball will not hold favor long. Jones, too, was just a little too ready to kick. No doubt there that allowed a man to go to first because McNichol did once what Young had been

THE IRISH PROBLEM.

MR. GLADSTONE'S STRONG STAND AGAINST PROCLAIMING IT.

Another Remarkable Speech by the Grand Old Man - Counter Arguments that Make the Irish Question Interesting-A Debate Hot Enough.

LCNDON, Aug. 25. - Mr. Gladstone was greeted with cheers in the house this evening when he arose to move : "That a humble address be presented to the queen, representing that the viceroy of Ireland, has proclaimed the National league a dangerous association; that no information has been furnished to parliament to justify the proclamation, by virtue of which her majesty's subjects are to be rendered liable to be punished as criminals, without a judicial inquiry into the nature of their acts; and that the house, in the absence of such information, prays that such proclamation shall not continue in force as to the association named and described therein."

Mr. Gladstone said the Irish viceroy must have acted on information, but where was that information? If the facts were withheld the opposition must urge the three propositions :

1. That it was a slight, almost an outrage, on the dignity of parliament to suppose that it was to discharge such an important statutory duty without knowing the grounds.

2. That it reduced to utter destruction, and to an absurdity, the main contention that the government advanced during the discussion of the Crimes act, that the safeguard promised had proved a farce. Why not follow the course taken by Wellington and Peel in 1829 regarding the Catholic league and suppress it ?

3. What could the house think of information that they must thus know would not

bear the light ' (Cheers.) The proclamation of the National league, Mr. Gladstone declared, was a near approach to a declaration of war on the Irish people. The people of Ireland generally sympathized with the league, because they believed that it had been their salvation. (Parnellite cheers.) Nobody did anything for the tenants until the league was founded. He hoped that the Irish would continue to bear the pressure. They would not have to suffer long. The government's foundation was slipping from under them. Ireland, trusted the English nation to fulfill her reasonable wishes, and was convinced that her expectations would not be disappointed Mr. Gladstone then presented his resolu-

tion amid prolonged cheers. Mr. Balfour said the government's difficulty was not the finding of evidence to justify the proclamation, but the selecting of it from the enormous mass of evidence they possessed. Mr. Balfour argued that when Mr. Gladstone proclaimed the land league Mr. Parnell was imprisoned, and parliament was not sitting, and he afforded no information to any one concerned. He showed that the league was guilty of boycotting, coercing and instigating infractions

of the law. Sir. William Vernon Harcourt asked the speaker whether the documents from which Balfour quoted would be submitted to the

Mr. Balfour refused. Sir William asked the speaker whether Mr. Balfour was bound to table the official

documents cited. The speaker replied that Mr. Balfour was not bound to table confidential documents, but the case was different with official papers, which the house might want to verify. Although Mr. Balfour was justified in quoting from confidential documents the authority of such quotations was weakened because the documents had not been tabled.

Sir V. Harcourt-After the speaker's ruling, I expect that the papers will be tabled. Mr. Balfour-I shall do nothing of the kind. My documents are of three sorts, public and confidential papers, and my own notes. If the people realized the work of the league, they would, regardless of creed or party, support the government. (Ministerial cheers) He accused the opposition of making themselves apologists for intimida-

Mr. Buchanan, liberal unionist, said that the government's action was ill-timed. The English people desired that the Irish difficulty be treated amicably.
