HOW HE WAS RESCUED.

The Doctor Heartily Enjoying his Dip After Hearing That All Were Safe.

T. G. Mason, of Mason, Risch & Co., Toronto, who has just returned from Hay Island, gives an interesting account of the Rev. Dr. Douglas' narrow escape from drowning. He says that on the afternoon in question Dr. Douglas, Miss Mary Douglas, Dr. Douglas' eldest daughter, and a resident of Kingston went out fishing. In an hour they had secured quite a large catch of fish, when, through some hasty movement or other cause, the boat tipped over and the three were thrown into the water. The Kingstonian succeeded in getting Miss Douglas into the boat, while Dr. Douglas, remembering the sports of his early days when he was a noted swimmer in Montreal, kept his nose in the airby "treading water. In his blindness and feeble condition it is not likely that he would have been able to continue this for any lengthened period, and, fortunately, it was not necessary for Arnold Finley, of Montreal, who was in a boat near the scene of the upset, rowed to the doctor's rescue, and catching hold of his shoulders, helped him to get his arms over the gunwale of the boat. Dr. Douglas' first question was, "Is Mary safe?" and, finding that she was, he burst into a hearty laugh, and remarked, "What an amount of fish we have lost." A Mr. Craig, Forsyth's Island, who was near by, was next to arrive and assisted in getting all safe to land, Dr. Douglas being towed along with his arms over the side of the boat. The accident occurred some two hundred yards from shore. On their arrival at Hay Island, about a mile away, restoratives were applied and the drenched ones put to bed, and on Friday all appeared to be as well as ever.

A BIGAMIST'S CRIME.

He Murders His Wife in Racine.

RACINE, Wis., Aug. 30 .- About six years ago a young man came to Racine from Montreal, and entered the employ of a wellknown firm. He soon became a favorite with the fair sex. As he was supposed to be unmarried and amply able to provide for wife the announcement that he was to marry a Racine girl caused no unusual comment. The couple went to housekeeping, and apparently lived happily.

One day, some time after the marriage, the husband received a letter that apparently troubled him. That night his wife died, and immediately after the funeral the widower left for the East. A few days ago a woman called at police headquarters, was closeted with the chief for a time, and told a strange story. She said she was from Montreal and that her husband was the man who had married in Racine, and that her own marriage was consummated previous to the ceremony performed in this city. The woman said that when her husband returned to her he made a startling confession. He told her of his unlawful marriage here, and said he had received a letter written by the Montreal wife, announcing her determination to come to Racine, Fearing arrest for bigamy and dreading the punishment sure to follow, he had given his second wife a triple dose of medicine on the night following the receipt of the letter, he said, and she died a few hours later. The terrible crime was kept a secret. Some time ago, however, the husband disappeared, the wife claiming that he deserted her.

The number required will be 1,200,000, and the cost will be 4,370,000 florins.

HUBBUB IN THE HOUSE.

THE IRISH MEMBERS GET INTO A HEATED DISCUSSION.

Mr. Healy and Col. King-Harman Freely Exchange Compliments - And the Speaker Sits Upon the Two of Them-The Duke of Argyle is Grieved at the Speech of Mr. Gladstone-The Old Man Not abit Worried.

LONDON, Aug. 31. - In the nouse of commons last evening, in the debate on the debate on the vore for the Irish secretary's office, T. M. Healy denounced Mr. Baltour as a Scotchman, ignorant and careless of the duties of his office. He then made a long and violent attack upon Colonel King-Harman, the under-secretary, and was loudly called to order for referring to the under-secretary as a convict, because he had once been imprisoned for making an assault udon the police. He accused Harman of inducing the Times reporters to suppress he had threatened to shoot one Weldon. The chairman reminded Mr. Healy that

Col. King-Harman was absent Mr. Healy retorted that he was within call. Proceeding he said that Mr. Balfour was a mere shadow, but not so Harman, who had been hand and glove in fenianism, had stood for pacliament as a home ruler, and had been secretary of the Home Rule | Kingstons. league. He had been informed that the chief secretary's brother, Gen. Balfour, had stated that Arthur had been appointed chief secretary because he despised Ireland. (Par-

nellite cheers.) The chairman, on an appeal from Mr. Balfour, ruled Mr. Healy out of order. Mr. Healy accepted the ruling, but repeated the allegation amid an uproar on both sides. After denouncing Colonel King-Harman's connection with Orangemen, who he said had committed 500 murders to ribbonmen's one, Mr. Healy declared that the parnellites objected to dealing with a secretary "through a glass darkly." Since they had to deal with Harman they preferred to deal with him as chief secretary.

At this point Col. King Harman entered the house and for his edification Mr. Healy repeated the charges he had made. He added that his appointment was a disgrace to the government. He was glad, however, to notice that Harman was abandoning his combativeness. It seemed to have dawned upon him that he was not a minister of the Orange society, but of the people of Ireland. He advised him to sever his connection with Orangemen.

Col. King Harman here complained of the attacks made upon him in his absence, but fielder. the chairman informed him that Mr. Healy desired that he should be called into the

Mr. Harrington announced that Mr. Charles Augustus Van Sittart Conybare, radical member of parliament for northwest Cornwall, and Mr. Charles Ernest Schwaun, liberal member for North Manchester, had joined the league. Mr. O'Brien said that the first branch of the league against which the government should issue a proclamation would hold its meeting with closed doors, and refuse to open them for the police, even if they demanded admittance. This would leave the police nothing to do but break their way in if they were determined to enter. As the police would probably resort to this violence, the central branch of the league would then ask the lord mayor to grant them the use of the city hall, with special police to defend it during league meetings therein. A majority of the Dublin city council as well as the lord mayor are strong nationalists and leaders in the league.

Told in a Few Lines, and it Was Ended

by a Common Suicide. NEW YORK, Aug, 30.-A man named Wolff, who lives on First avenue, found a shabbly dressed young woman lying in the hallway of his house and gruffly asked her what she was doing there. "Dying," was the low answer. Wolff did not believe this and asked her to go elsewhere to meet her end. The woman answered in a trembling voice that she had taken Paris Green and intended to die no matter what was done to her. Then Mr. Wolff had an ambulance called and the would-be suicide taken to Bellevue hospital. She probably cannot recover. Heidelberg is her name. She is not yet 22 years old. Three years ago she was an unusually attractive girl, married a prosperous young butcher, and became addicted to drink. When her first child was but a few weeks old, while, intoxicated, she let it fall from her arms out of the fourth story window of the house in which she lived. After that she went altogether to the bad. She left her husband to live with other men. coming back to him occasionally when the others tired of her. Heidleberg always received her. Once when Heidleberg was compelled to have a finger amputated the woman implored him to let her nurse him. Again at home she got together all the infatuated man's savings and decamped. Yesterday, after several months absence, she again applied for reinstatement in his affections, promising all kinds of reform. At last she was refused, and leaving the house, after frantic appeals for one more trial, she swallowed the poison.

EXPIATION OF HIS CRIME.

Pranzini Guillotined in Paris for the Murder of Two Persons for Money.

PARIS, Aug. 31.—Pranzini, the murderer of Marie Regnault, her servant, and the latter's little girl, was guillotined this morning. At 5 o'clock the executioner was seen issuing from the prison gate and behind him came Pranzini, ghastly pale, led by four of the executioner's assistants. As he neared the scaffold he faltered for a moment. Turning with a smile of agony he kissed the crucifix, and walked forward. The next instant the knife fell and Pranzini had expiated his crime.
