In view of the excited a ate of feeling over the affair, it is, perhaps, well to explain that Mr. O'Brien's decision to ignore the summons and compel the government to arrest him in order to carry out its intention of arraigning him before a magistrate, was the result of a conference of his immediate personal and political friends, who believed that the course they had decided upon would more sharply define the issue and more exhaustively test the question of the government's right to abridge or abolish the privilege of free speech and free political action. The appearance of Mr. O'Brien in court in obedience to a simple summens, his friends contended, would be-little the issue, while his arrest and his forcible arraignment would at once raise the matter to the plane of a question of the first importance. FIGURING ON A SECOND TERM.

Will President Cleveland Get the Democratic Nomination?

NEW YORK, Sept. 10.-A Washington despatch to the Sun says that a gentleman who has just returned from the North-West says: "While in St. Paul a few days since I saw a letter written by President Cleveland to a personal friend, in which he discuses, at some length, the prospects of his being a candidate for re-nomination. The president says he has not fully determined that he will be a candidate for a second term. Should he determine, however, to become a candidate he says he proposes to take his campaign into his own hands. He intimates that the ticket upon which he runs must be made to suit himself as he is determined to lay out the plan of cam: paign which must be successful." A democratic politician, lof St. Paul, said: "I believe the president has determined, if he is to have the construction of his ticket, to have General John C. Black, the present commissioner of pensions, nominated for the vice-presidency. He has come to the belief that Gen. Black is solid with the soldier electors and could draw a large number of votes to the support of a ticket which would be otherwise decidedly unattractive to even
