A PRISONER FOR LIFE.

A Vil ian Who Made a Horrible Attack on a Defenceless Woman.

CHATHAM, Oct. 6. -At the assizes here colored man, George Hewell, was convicted of criminally assaulting Mrs. McLean, a delicate young woman and the wife of a respectable farmer. The prisoner called at her house and asked for a drink of water. When it was given him he rushed upon the defenceless woman, seized her by the throat, choked her and threw her upon the floor. A terrible struggle ensued, in which the little woman fought desperately, and was left in a semi-unconscious condition, with black. ened and bleeding body.

The jury were only out some ten minutes, when they returned with a verdict of guilty. His lordship remarked that for the protec tion of society crimes of this nature, when clearly proven, merited very severe punish. ment. He sentenced Hewell to imprisonment for life in the Kingston penitentiary, remarking that he was not sure but he was making a mistake in not passing the sentence of death.

The prisoner took his sentence without apparent agitation. It met the approval of the audience in court, judging from their attempt at applause.

A MOONLIGHTER'S FRIENDS HAVE GONE TO THE RESCUE.

The Charge Upon the People-Admission Anent the Midnight Raids-Continuing

The Evictions-Firing Into the Mob. DUBLIN, Oct. 3.—Callinan, the moonlighter, who was one of the party that killed Constable Whelehan at the Sexton homestead at Lisdonvarne, September 11, and who has turned queen's evidence, was today taken to Ennis in order to testify against his accomplices in the trial proceeding there against them for murder. He was escorted by a strong force of police. He swore as to the plot against Sexton and identified seven of the prisoners as having participated in the killing of Constable Whelehan, Callinan admitted that he had planned a number of moonlight raids in Kerry and Clare. He said that he had been in the pay of the police for the last five pulsory. years, and that he had received from Con stable Whelehan, just before the raiding of Sexton, a small sum of money in payment of his share for arranging the raid. This statement caused a great sensation in the court. While returning to jail the prisoners were cheered by the crowds in the streets. The police charged the people and used their batons freely.

THE RECEPTION OF PRESIDENT AND MRS. CLEVELAND.

A Rush on the Party and the Result-Aid ing Mrs. Cleveland in an Alcove to Save Her From Being Torn to Pieces-

Fighting the Beasts at Ephesus. CHICAGO, Oct. 5. - President arrived here yesterday and was given a rousing reception. After he had addressed the citizens they, with one bursting, frantic cheer, crashed through the great rotunda; a mob of a hundred thousand people rushed like wild beasts at him and his wife in the Palmer house. The chief magistrate with his wife had just descended the main stair case. In vain did the police, clubs in hand, attempt to stem the rush. The rope barriers had

deen swept away at the first onset. It was well that a nook of safety had been provided for Mrs. Cleveland. To the right Fighting between the forces of the Ameer of the stair-case was an alcove most hidden in silken bunting and waving green plants. Into this she was hastily thrust, while the president, giving a single sweeping glance at the surging crowd, plunged into its midst and sturdily shouldered himself by sheer strength into the place it had been decided he should stand. Three times did files of brawny dismounted cavalrymen reize the ends of one of the rapes that had been dash ed to the floor and strive to drag back the eager multitude. Only with the aid of a double cordon of police, the front line backing against the crowd, and the second rank pushing their blue coated comrades forward, was a faint semblance of order secured.

The president meanwhile was shaking hands right and left till he was red in the face, and his fresh linen cellar lay limp above his black Prince Albert coat. Behind him, and slightly to his right, standing at the entrance to the alcove, a couple of steps above the crowd, was Mrs. Cleveland, laughing at the president's plight and bowing and hands with all those in line. A low esti mate of the number who marched past him is 6,000 persons. Thousands in the corri dors and streets failed even to catch a sight

of his face. This evening a reception was given to the president and Mrs. Cleveland at the Columbia theater. Ten thousand tickets had been issued, each admitting one man and his complement of ladies. No one had been inside before the advent of the presidential party, and people were obliged to wait in lines stretching fully a block on the sidewalk in each direction of the theater. Simultaneously with his wife from the side of the stage and taking a stand under a masive chandelier in the centre of the stage, speople, two abreast, advanced toward him.

The president was in full dress. Mrs Cleveland wore a close-fitting, simple made reception gown of dark misletoe green plush, cut moderately low, and quaintly trimmed at the nack and on the short sleeves with ancient Escurial lace. In her hair she wore a diamond brooch of exquisite work manship. A necklace of diamonds sparkled at her throat, while around her waist, contrasting with the rich green plush was a girdle of old gold heavy cord and tassel. it did not want much of midnight when

TERRIBLE BRUTALITY. A Shocking State of Affairs Disclosed by

the Death of a Woman. Mrs. Vaillencourt died on Friday last, and in consequence of the rumors which were current concerning the cause of her death the parish priest of Charlesbourg refused to bury the body. Coroner Belleau was notified, and two medical men of this city were instructed to make a post mortem examination. Yesterday an inquest was opened, a jury having first been sworn in in the presence of the body, which presented a frightful appearance. The victim had been confined to bed for several months with paralysis, and she was covered with bed sores and vermin. Worms had commenced to devour her body even during life, and it is doubtful whether the deceased, during LONDON, Oct. 5. - The Morning Post, re- her malady, had even been moved or wash ed. The evidence adduced disclosed a of her unnatural husband. It was said that he habitually left his wife all day alone locked in the house, without food, that he was in the habit of wasting whatever money he earned in whiskey, spending most of the evening in a neighboring tavern. The only food he supplied his wife, and that in very small quantities, seemed to have been potatoes, with an occasional piece of bread. He slept himself in a separate room, in order to avoid the vermin. Some of the witnesses had occasionally spoken to deceased through a window at the back of the house, but none of them had courage enough to report her case to the authorities, for Vaillencourt has the reputation of being terribly violent and vindictive, and ever since the death of his wife is said to have threatened anyone who would interfere or notify the coroner of her death. No time was lost in placing the human fiend under arrest. He was conveyed to the city last night and safely lodged in gaol. THE PEACE ALLIANCE.

Great Britain Likely to Join Italy And Germany-The War Party. London, Oct. 4. - There is a perceptible

inclination of opinion here towards the inclusion of England in the peace alliance set on foot by Italy's adhesion to Germany. Diplomatists are beginning to arrange the European powers under two classes, offensive and defensive. France and Russia belong to the former, while Germany, Austria, Italy and Great Britain are among the latter. Practically there is no outstanding question between the two powers. On the other hand France is greatly disliked here.
