UNEMPLOYED IN CHURCH. A Scene in Westminster Abbey-Jeering

at the Preacher of the Day.

LONDON, Oct. 24. - Several thousand of the unemployed, with a red flag at their head, marched in procession yesterday afternoon from Trafalgar square to Westminster Abbey, and although no invitation had been extended 1,200 of the crowd were admitted. The flag was left in charge of the vergers. Inside the abbey many of the unexpected visitors remained covered and indulged in whistling, while others mounted the pedestals of the various statues or mingled with the decent people present, who mostly left the building. The crowd as a whole chewed tobacco and expectorated everywhere regardless of the surroundings, until the first lesson was announced, when the leader was loudly jeered, completely drowning his voice. The second lesson was similarly received. Canon Prouthers then preach ed a sermon, taking for his text Romans XII, 1. In his discourse he argued that the punishment of the law breaker was necessary for the good of the community. This was received with cries of "oh, oh," and "bosh." The preacher earnestly appealed for order, and exhorted his hearers to try and unroot evil and plant good instead. "That's what we are going to do," was shouted and received with cries of "Hear! Hear !" and cheers. Canon Prouthers then threw his notes aside and addressed himself directly to the roughs. He said that legislation could not alone provide a remedy for hunger and suffering, but every body could express sympathy. (Loud laughter, followed by a noice "That's all we shall get.") Canon Prouthers continued; "Charitable agencies might do much." (A voice "We don't want charity; we want work.") The reverned gentleman enlisted the attention of the mob when he advocated state assistance in times of distress. At the close of the remarks the mob hissed and marched out of the abbey, cordially cheered by their comrades in waiting outside. The whole then proceeded shouting and hooting to Trafalgar square, where the leaders denounced the church and police. Several arrests were made of brawling persons and thieves.

LONDON, Oct. 24. - In the Bow street po lice court to-day one of the men arrested for creating a disturbance in Westminster Abbey yesterday was arraigned. He gave his name as George Budgett, aged twentythree, by occupation an ostrich feather cleaner. The charges against him were brawling in Westminster Abbey and assaulting the police. Canon Prothers, whose sermon was interrupted by the mob which invaded the edifice, testified that the prisoner, who had previously been noisy, shouted when the sermon was commenced, "Sur render half your salary, your --- old -for the benefit of the poor." When the police removed him he kicked and struggled and made an uproar. Budgett was fined £5.

THE HORRORS OF AUSTRIA.

Starvation Among the Children-A Dreadful Condition of Affairs.

NEW YORK, Oct. 24. A Vienna despatch to the World says the inquiry recently instituted into the condition of the Vienna poor attending the elementary schools resulted in the appalling disclosures that upwards of 4,000 children were suffering the pangs of hunger, some of them being on the verge of starvation. A long list of heartrendering cases came to light, and no doubt was left that not a few of the unfortunate little ones had died. Their emaciated appearances amply testified to the veracity of the statements extracted from them, which revealed a condition of hopeless destitution unprecedented in the pauper records of this people. It transpired that their principal food consisted of dry bread and occasionally a little soup or coffee. One boy stated that his tather was a good man, and that when he could not give him anything to eat he let him drink as much gin as he liked, and drunk. SIGNING OF CONVENTION.

Use of the Suez Canal in Time of War-New Hebrides' Agreement.

Paris, Oct. 24.—The negotiations for conventions regarding the new Hebrides Islands and the Suez canal have been concluded and will be signed to-morrow. The Suez canal convention provides that the canal shall be kept open in time of war, that no act of hostility shall be permitted at either of its approaches, or on its bank, within a zone to be determined by an international commission on supervision, that belligerent unable to compel respect for the treaty she will appeal to Turkey, who, in concert with the signatory powers, will take the necessary measures to enforce obedience.. It is reported that Germany, Austria and Russia, already approve the Suez convention. The new Hebrides' convention confirms the agreement of 1875 and 1883, and provides that any action necessary to maintain order shall devolve upon the English and French men of war and that France shall evacuate the military post.

Paris, Oct. 24.—The Temps says that in return for the new Hebrides' convention at England agrees to recognize the French sovereignty over the Leeward Islands and the Haytian archipelago. The conventions afford full satisfaction to French interests, while bearing evidence that a good understanding exists between England and
