#### THE TRAFFIC IN DECORATIONS

They Can be Got in France by the Payment of Money-M. Wilson's Service.

Paris, Nov. 18 .- M. Wilson and his family have quitted the Elysee. M. Rouvier will oppose an immediate discussion, and move that the debate be adjourned until the 24th inst. A trial of strength is expected on the question.

It is rumoured that M. Wilson has resigned his seat. The scandal commission examined M. Wilson, who refuted many of the charges brought against him.

PARIS, Nov. 19.-Mr. Wilson testified that M. Seillieres' check was a subscription to his paper, the Petite France, and that he had no business relations with M. Seillieres. He admitted, however, that he supported the demand for a concession to the Com pagnie des Charbonnages, which has since become bankrupt, in whose books a subscription of 10,000 francs to the Petite France is noted, as paid for Wilson's good offices. He said he had advised the decorations for the contractors who built his mansion, but they were first-class men, and that at the request of Count D'Andlau he advised a cross for Bayenual. Madame Trederne denies M. Rochefort's assertion that she bribed M.

PARIS, Nov. 19. - The Journal des Deliats says the fixed intention of President Grevy is not to resign. He does not admit that parliamentary pressure can enforce a president's resignation. Such a state of things, he holds, would be subsersive of the constitution. His resignation would create a mischievous precedent, as his successors would thereby be bound to resign every time public opinion was against them. It is believed that only M. Gragnon, the late prefect of police, and M. Wilson are implicated in the letter scandal.

Paris, Nov. 19. - Soon after the chamber of deputies met to-day the extreme left moved an interpelation of the government on the question of its domestic policy. A motion was made by the ministry to postpone the debate. Its motion was rejected by 328 to 242. Prime Minister Rouvier immediately announced the resignation of the cabinet.

## THE INCIDENT QUESTION.

Mitchelstown Shooting-Man Heavily Ser tenced-Action Against Sullivan.

LONDON, Nov. 19 .- Mr. Gladstone says that the Mitchelstown shooting and the arrest of Wafred Blunt had no connection with the crimes contemplated under the Coercion act, and therefore the government's action was illegal.

LONDON, Nov. 19.-Mr. Parnell has written a letter to a news agency stating that his health is slowly but steadily improving. He does not intend to speak during the parliamentary recess, as his doctors have ad vised him to avoid exposure, which would probably bring on chills. He has also been warned against undue exertion. He is now staying at Hastings, where he will remain through the winter, unless the weather becomes so severe as to compel him to go to

DUBLIN, Nov. 18 .- A special term of the court was convened at Ennis to try the case of Doughty, charged with inciting the people of Six-mile Bridge to join an unlawful association. The case came up to-day and the prisoner was acquitted. There are two other charges against him, on which he will have to stand trial. Placards have been posted in Tipperary calling upon the people to pay no rent nor taxes until Mr. O'Brien

has been released. DUBLIN, Nov. 19 .- William Condon, a prominent nationalist, was sentenced at Mitchelstown to-day to one month's imprisonment at hard labor for intimidation. His solicitor withdrew from the court, alleging that the magistrate was prejudiced.

A new action will be instituted against Lord Mayor Sullivan for publishing in his paper, the Nation, reports of the meetings of proclaimed branches of the national league. In the case difficulties of the former prosecution will be avoided. Other similar actions which are pending, will be pushed with the greater vigor.

## **OUEEN'S JUBILEE PRESENTS:**

Her Majesty Nervous Regarding Their Safe ty-How They Are Protected.

London, Nov. 18 .- The queen has been very nervous of late about the safety of her jubilee presents in St. James' palace, though there is little need to fear. The precautions taken for their safety are of the most ingenious character. In the large court yard there are barriers so arranged that every visitor has to traverse three sides of the square before he reaches the door of admission. During this long and lonely journey he is quickly inspected by detectives and other policemen, and if he looks particularly suspicious he is followed closely by an officer till he leaves. Numbers of policemen are stationed at the doors and keep guard over the presents. Even if a dynamiter or a robber passed the critical ordeal of the court yard he would come to grief in the

## HARD ON THE PASSENGERS.

The Quarantine at Hoffman's Island Contributes to the Public Scandal,

NEW YORK, Nov. 19 .- A paper publishes interviews with some of the passengers who have been quarantined on Hoffman's Island in which it is claimed that they were illtreated and not given sufficient food. In one instance it is stated they were without anything to eat for three days, and finally becoming desperate, demanded food, when one of the attendance pointed a revolver at them, threatening to shoot any one that created a disturbance. Secretary Mullen of the quarantine commission denies the charge. .

Chamberlain at Washington has been un derstood to say that the purpose of the fishery commission was to make an entirely new treaty, the existing treaty having proved unsatisfactory. The trunk lines have decided to follow at

once the cuts in rates that the Grand Trunk has made upon dressed meats and upon provisions and grain for export. The forest fires in the Cypress swamp, near Golconda, 111, are still burning, and

great damage has been done. One young man, while fighting the fire, was barned to death. Arthur Cardinal, for four years collector and clerk to Lyon Silverman, manufacturer of extracts, Montreal, disappeared on Mon-

day evening. Cardinal was guilty of peculations amounting to \$300. In delivering his annual lecture to McGill college students yesterday, Sir William Dawson condemned the action of professional governing bodies with regard to uni-

versity education. A despatch from Battleford says a meeting of citizens there strongly condemned Commissioner Herchmer's management of the mounted police force. The cause of discontent is not stated, and no complaints have

appeared in the territorial press. The Industrial School Association, Toronto, owing to the rapid increase in the number of lads at the Industrial school at Minico, says it may be impossible, even with the aid of the new building now in course of erection, to accommodate all the applicants. Neglected lads should enjoy the advantages of the school while possible.

## The League And the Brotherhood.

NEW YORK, Nov. 18.-The committees representing the National league and the brotherhood has made its report. The modified contract provides for a service of seven months, during which players may be disciplined, suspended for a definite period, or expelled. They cannot during such service desert or sign with other clubs. Not more than fourteen players can be reserved.

Uncertain Financial Condition. Toronto, Nov. 19 .- The directors of the Central bank are considering offers for the sale of some of their branches, and there is a general belief now that the bank will go into liquidation. The bill holders and depositors will be paid in full. There was an uneasy feeling owing to rumors about other banks being embarrassed.

## The Case a Bad One.

SAN REMO, Nov. 19. - Fresh alarm has been caused by the announcement that the crown prince's malady is undoubtedly soft cancer, and that the pus discharged contains cancer cells of the very worst kind. If the tumour continues to discharge a large quantity of matter its growth may be retarded, but the worst fears are entertained.

## Music Not Wanted.

DAYTON, Ohio, Nov. 19.—In the United Presbyterian anti-musical national convention, yesterday, the following resolution was adopted: "That should the general assembly refuse to grant relief, we shall feel at liberty to maintain the purity and integrity of the United Presbyterian church, even to the extent of separation from a majority purposing a course of defection."

The Pilgrimage to Rome.

VIENNA, Nov. 19 .- The Hungarian pilgrimage to Rome, to attend to the pope's jubilee, will start for the holy city on Monday headed by Cardinal Timor. The Hungarian aristocratic ladies' committee yesterday handed Mons. Galimberti £24,000 for the pope. Numerous other valuable presents have been sent to the pope.

Calling on Secretary Bayard.

WASHINGTON, Nov. 18. - Joseph Chamberlain, Sir Charles Tupper, and Sir Lionel West, the British minister, constituting the British fishery commission, called at the department of state at noon to-day, where the minister introduced his fellow commissioners to Secretary Bayard.

## The Misery at Labrador.

\*OTTAWA, Nov. 18.—Reports from Labra dor state that the fisheries' harvest have failed again this season, and all who could leave that inhospitable region have left and come here, in two schooners. There were six families, comprising forty-eight persons of both sexes. Those left behind have only starvation staring them in the face this winter if relief is not at once sent them.

#### BISHOP CLEARY'S CASE.

A Denial to the Toronto "World"-What His Lordship Did Not Say.

His Lordship Bishop Cleary sends a letter to the Toronto World in regard to the public school question. After explaining his objection to the expulsion of pupils from the schools he says:

"May I trespass oh your indulgence a little further by requesting permission to give denial through your journal to certain allegations made by The Mail. It is untrue that I ever said or wrote a word directly or indirectly at variance with the proposition : 'It is only just that those who contribute to the support of one class of schools should not be entitled to use freely the other;' or that I think it reasonable that the money should be taken by one school board, and the work for which that money is paid be done by another; or that I ever declared 'public schools to be perilous institutions and dangerous alike to both religion and morality;' or that I ever said or hinted that 'if a Roman Catholic parent contribute to the public schools or sent his children thither, he is a wretch."

"There are many thousands of the little ones of my flock attending public schools throughout the diocese with my free consent, and throughout the province of Ontario there are 50,000 Catholic children attending public schools with the knowledge and concurrence of all the Catholic bishops."

#### Father McDonough Heard From.

Rev. Father McDonough, of Napanee, cannot conceive who was the author of the report of the speech of the Bishop of Kingston at Napanee recently. The entire instruction of the bishop was directed to the manners of youth and the laws of social reserve and modesty and gentleness, required for the christian formation of character, particularly in females. He passed no observations whatever on the women of this

The bishop did undoubtedly contrast the social demeanour of young females in the old and new country; he gave evidences of the defective training of female youth, which he himself has often witnessed and has often heard others comment upon since his advent to Canada. It was a libel to make these irregularities refer to the women as well as the girls.

He charges malignity on the part of the correspondent and adds: "I should transcribe almost every second sentence of the libel in giving instances of this unworthy

procedure. The bishop said that the comingling of the sexes at schools tended (not led as the correspondent put it) to the destruction of all

female modesty. The Napanee papers published reports of the visitation at the time, Nov. 2nd, and neither of them expressed a word of dissatisfaction, but rather of high praise and admiration for the whole tenor of his lordship's instructions.

Father McDonough charges malice as the foundation for the report and says it looks suspicious by its appearing in certain papers on certain successive dates. The writer has, we believe, been commu-

#### nicated with, and still alleges that his report is "substantially correct."

ARCHDEACON EVANS. His Visit to the City-A Sketch of the

Eloquent Preacher. Ven. Archdeacon Evans, of St. Stephen's church, Montreal, arrived in the city to-day. He is a cleric of high standing. He is an Ontario man having been born in Simcoe, his father, the Rev. Francis Evans, D.C.L., having held the office of rector of the parish for up vards of thirty years. Mr. Evans' family is Irish. His early education was obtained at Upper Canada college, and in 1863 he matriculated and obtained a competitive scholarship at Trinity college, Toronto, taking the degree of bachelor of arts in 1866, and proceeded to that of master of arts. Mr. Evans was ordained in 1869. His first charge was that of Norwich and adjacent parts. In this he gave evidence of a zeal and practical ability which attracted attention. It, therefore, caused more regret than surprise to his parishioners when in 1871 he was summoned to Montreal to assume the position of junior assistant to Christ church cathedral. In 1873 he was appointed rector of St. Stephen's church, Montreal. Under his care the parish has grown and shows signs of great life. He was appointed archdeacon of Iberville, in 1882, on the death of the late Dr. Leach succeeding to the archdeaconry of Montreal. Mr. Evans is a good preacher, energetic and determined. Archdeacon Evans has practically been the right hand of Bishop Bond ever since the latter's elevation to the episcopate.

## LAW AND LIBERTY LEAGUE.

Magistrates Condoning the Conduct of the

Police-Mr. Stead's Firy Speech. LONDON, Nov. 19 .- A meeting was held to form the "law and liberty league." Jacob Bright, who presided, accused the magistrates of condoning the misconduct of the police. Mr. Stead denounced the brutality of the police, and charged them with maltreating prisoners taken last Sunday, both during the row and after they were taken to the station. He said that the league was designed to vindicate the law and to protect individual liberty. The motion to form the league was offered by Mr. Saunders, who condemned the government for the whole affair. The socialist Hyndman seconded the motion, which was adopted. Sir Frederick Leighton and members of the aristocracy have been enrolled as special constables. Six thousand constables were enrolled to-day. Their initiatory duties began immediately.

## Alleged Libel.

CORNWALL, Nov. 18 .- James Harper, editor of the Cornwall Standard, has been cited on a charge of libel upon the editor of the Liberal newspaper by publishing last May a skit headed "Secretaries Furnished, and in October last criticizing C. W. Young, editor in regard to the purchase of shirts for the Cornwall lacrosse team in Boston.

## Supposed Drowning Accident.

CORNWALL. Nov. 18. - Joseph Tucker and Charles Snow of Massena, N. Y., appeared here with the coat, papers and a bunch of keys which they found in a boat in the Grass River. The property belonging to Eneas McDonald, coal merchant and county treasurer. Mr. McDonald left on Monday afternoon for Massena in order to purchase a pair of mules and was to return yesterday.

O'Brien's Life in Danger. DUBLIN, Nov. 19. - Dr. Romayne, of Cork, visited William O'Brien in Tullamore jail on Thursday. He states that if the present harsh treatment of the prisoner is continued it will cause his death.

## THE NEW IRISH SCHEME.

MR. M. DAVITT ELABORATES AT A CONSIDERABLE LENGTH-

The Representation of Ireland in Parlia ment That Would be Popular - The Several Parties That Would Make Up the House-The First Duty Incumbent Upon the New Parliament.

NEW YORK, Nov. 18 .- The Tribune's Dub lin says the outlines of a plan for an Irish parliament as fermulated by Michael Davitt. Mr. Davitt declares himself against a double chamber, and the principle of voting by first and second orders contained in Mr. Gladstone's bills. He says : "I am certain that no nationalist objects to any practicable provision which will insure to our Protestant fellow country-men the representation to which their members entitle them. Twenty-five per cent. of the entire representation in the national assembly could be guaranteed to them. This would be more than the minority population could justly claim, but I am sure that this number would not be objected to by the Catholic portion of the community. To insure, also, that the Protestants of the south and west should be as fully represented as those of the north a scrutin deliste system of election could be provided by aid of which the ablest champions of the minority could be voted for in Connaught, and Munster as freely as in the most Protestant part of Ulster. In a legislature of say 300 members the minority would thus have a compact party of 75, comprising the best ability within its ranks, and when what is now known as the Na tionalist, or home rule, party would be cer tain to be divided into two or three parties in a national assembly it would not be at all impossible to find the minority representative holding more or less of the balance of power. The division of parties in the national assembly would probably be as fol

"First party, a conservative, nationalist

"Second party, a democratic or radical nationalist party, sub-divided into two

"Third party, comprising the representa tives of those who are now opposed to home "The first duty of the new parliament," Mr. Davitt savs, "would be easily performed.

That would be to make the law and order respected and obeyed. The national senti ment, so long at war with unjust and alien administrations, would combine with nation al honor to uphold laws which would be come popular the moment the people's contidence would be secured in their just and impartial administration, but the first great task, which I hope will devolve upon the new legislature, will be that has baffled the efforts of English statesmen, i.e., a final settlement of the Irish land questson. "I am aware that the present landlord government is hugging the hope of being

able to pass a measure for the solution of this great problem, but I maintain now, as I have never ceased to assert during the last five years, that it is in Dublin and not in London that the final settlement of this question must be made. The next national undertaking would be the resuscitation of Ireland's manufacturing industries concur rently with the building up of the linen and woolen maunfacturies, and also the Irish parliament could not well omit extend ing an immediate helping hand to the fisheries. Not more than 10,000 or 12, 000 men now find employment round the coasts, where, at one time, over 60,000 were engaged in harvesting the food treasure of the seas. A scheme of artificial drainage, upon a national scale, would have to be one of the first great public works undertaken

by an Irish parliament." Mr. Davitt also advocates the abolition of the workhouse system.

# NO BIG BILL YET READY

Mr. Gladstone Not to Visit Ireland-Sir

Charles Warren's Proclamation. LONDON, Nov. 19.—The government will have no big bill ready when parliament begins its session, but will have to fall back on the new repressive changes in procedure, directed against the Irish obstructionists. They had intended to begin with a great local government bill for England, but a difference of opinion has arisen between the boundary commission and the government as to taking the poor law unions as a basis for new elective bodies, which these commissioners advise, and to which the govern-

ment is opposed. There is no foundation for the rumors that Mr. Gladstone will go to Ireland. Some time ago he was asked to attend Mr. Sexton's inaugural as Lord Mayor of Dublin. His reply was not such a decisive refusal as was anticipated, but it is now settled that

he will not go. The government is claimed to have made another false step. It has been decided in the police courts that no penalty attaches to the offence of ignoring Sir Charles Warren's proclamation, which was simply a notice with no effect whatever. The home secretary's theory, that Trafalgar square is crown property, is also broken down, for if the square is the queen's property it cannot come under Sir Charles Warren's supervision. Unless the higher courts come to their aid the government is entirely without a legal defence. Meanwhile the higher legal opinion is against Sir Charles Warren. The question will be formally raised in parliament by the united liberal members for London.

## INSPECTING A BATTALION.
