UNDERGROUND RAILROADS.

A Scheme for Tunnelling New York City-All Ready for a Start.

NEW YORK, Dec. 7. - The Times says: "The plans have been perfected, the route determined, the consent of property owners in ample sufficiency obtained, and the necessary capital subscribed for the building of an underground road by which one may travel from the city hall to the Grand Central station in seven minutes. A four track railroad, running express trains on the middle tracks, and local trains on the outside tracks, is to be built from the post office through Elm street and Fourth avenue to 42nd street. Embarked in the enterprise are W. K. Vanderbilt, Cornelius Vanderbilt, C. M. Depew, Orlando B. Potter, John Jacob Astor, W. W. Astor, the Rhinelanders, the Lorillards, and many other representative people. The enterprise depends now solely upon the adoption by the common council of the plans of the board of street opening. A SHOCKING MURDER.

HEAD OF HER INFANT.

A Horrible Case of Child-murder in North Toronto-A Crazy Mother Uses a Table Knife on Her Own Progeny-What Was Discovered Under the Bedstead.

TORONTO, Dec. 8 .- The most revolting crime that has ever cccurred in Foronto took place yesterday. Elizabeth Fellows. the wife of John Fellows, stableman in the employ of Pears & Booth, cut the head off of her six-weeks' old child, and followed up the deed by cutting off the left arm of the babe, boiling it, eating part of it, and placing the rest of it on the dinner table.

Four years ago John Fellows married Lizzie Williams, 23 years of age. Mrs. Fellows was always a delicate looking woman, and it is believed that her four-fold maternity led to the weakening of her mind. After the birth of her third child, a little over a year ago, she became subject to melancholia, and was for a while confined in the lunatic asylum. She was released in May, and she improved so much that her husband took her back to his home.

Six weeks ago Mrs. Fellows gave birth to her fourth child, the babe which is now a mutilated corpse. After the birth she showed signs of insanity, but displayed no violent tendencies, still her actions were such that her husband feared something. and closely observed her.

Mr. Fellows left the house seven yesterday merning to go to his work. At 10:30 he called at the house and tound his wife sitting near a front window sewing, with her two girls, aged three and one years, standing by her. The baby was cooing in a wicker-bodied perambulator near by. Fellows spoke to his wife, but she did not ap-

pear to hear him. He returned to his work. At 12 o'clock Fellows went home to get his dinner. At the door he was met by his three year old child who said: "Pa, ma has stabbed the baby." He asked his wife to explain, but she said nothing. Her face was red and seemed to be in mental agony. This occurred in the basement. Fellows rushed up stairs, again demanded where the baby was, and his wife followed him. He repeated his enquiry, as to the baby, and his wife said: "Oh, it's all right, every

thing is right." Fellows searched the sitting room and then the baby carriage. He pulled down and pointed to the bedroom, where there were two beds. Fellows got down on his knees and looked under one of the beds. He saw something done up in a bloodstained blanket. Almost crazed he rushed quest. to the office of his employers Mr. Pears and Mr. Booth returned with him to the house. Mr. Pears looked under the bed which Fellows pointed out and found the body of the babe. The head was completely severed and laid upon the legs. The knife had first been inserted at the back of the neck, then drawn around the right side in a downward way, till the cutting was finished at the breast. The whole of the body was clean of blood, and everything indicated that the unfortunate mother had washed away the stains of blood. The mouth and wrinkled forehead gave evidence of a painful death.

But now comes the worst. The body of the babe had been lying on its left side and nothing beyond the severance of the head was noticed. But upon turning the body the left arm was found to be missing.

The poor crazy woman was asked about this. She acknowledged that she had killed her child, that she had cut off its head with a common table knife, that she had cut off its left arm just below the shoulder with the same knife, that she had boiled the arm, eaten part of it and placed the rest on the dinner table for her husband.

A search resulted in finding the arm of the child upon a wooden plate in the cupboard. Mrs. Fellows was arrested. Her speech and her actions make it undoubtedly clear

that she is insane. Meanwhile the carved body of the infant was conffined, and the sight of it was horri-

THE MINOR AND THE GREATER LEAGUES IN UNISON.

An Agreement About Reserving Players -Working Under the National Rules Rather Expensive - The Payments to be Made Annually For the Privilege.

CINCINNATI, Dec. 8. - Three members of the baseball league, and three of the American association, constituting the board of arbitration under the national agreement, met yesterday. They had two questions with which to wrestle. The first was whether they should grant the right to minor organizations to come in under the national agreement, in respect to reserving players, and if so upon what conditions. Six of the minor organizations were here represented by delegates. The delegates held a meeting and appointed a committee to present their case to the arbitration committee. This committee, representing the six minor organizations, presented a request to be admitted to the right to reserve players under the national agreement. The arbitration committee proposed, as a condition of admission, that it be permitted at the end of each season to select two of the best players from each club in all the minor organizations, throw them into a pool, and allow the league and American associations to select from it, the minor leagues to have the privilege of reserving all others. This was rejected by the petitioners. The arbitration committee then, after long debate and consultation, granted the request of the minor organizations under the conditions of the payment annually by each organization of a last bonus. Article nine was charged so as to include a section allowing each minor organization of six clubs to reserve players, on condition of each club paying on or be fore March1st of each year \$50, member ship fee to the arbitration committee, and furthermore on the condition that each minor association of not more than six clubs pay annually, before the 10th of May, \$1.500, and that associations of more than six and not more than eight clubs pay \$2,000 an nually in like manner. Under this rule and article 10 the right of reservation must be claimed on or before March 1st each year, the organizations coming under the rule to the evening of Jan. 5th, 1880.
