LETTER TO THE EDITOR.

Scott Act in Frontenac.

KINGSTON, Dec 13 .- (To the Editor) : The wishes of a majority of the Frontenac county council proved father to the thought that the Scott act is illegal. The ill-gotten birth has cost, it is said, \$2,200 to strangle. When the Dunkin act was carried by a large majority in this county the votes of the majority were defeated by the negligence of county or township officials to give the no-tices due publication. When functionaries appointed or elected by the people are allowed to defeat the lawful exercise of powers of legislation belonging to the people one can quite understand "the fitness of things" which gives point to the argument that because the whiskey interest protects itself against legal scrutiny by the perjury of its victims, therefore the whiskey interest should not be suppressed, though it is the fruitful mother of other crimes. To no other body than a soulless corporation should such arguments be addressed. To any being with a soul it would be an insult to argue that the criminal should go unpunished because his conscience and nice sense of honor should not be put to the strain of a plea of not guilty, The attitude of the county council to-

wards the Scott act gave aid and comfort to every violator of the law in the county. Men proclaimed, and no doubt believed, that because the council refused to recommend the appointment of a magistrate the act was illegal, and the traders, whose pro fits are won at the cost of demoralization and crime, found it easy to lure to perjury, when they could point to the refusal of the council to enforce the law. If the council feared there were no magistrate whose moral courage was equal to the task of conviction, or that the magistracy would indulge in genial tipples with the perjured witnesses and the liquor sellers' counsel after trial, or that the dynamite bomb and the incendiary's torch would visit some of them, they might be excused, because men will, whether or no, take counsel from such fears. But it is safe to say that no such moral or physical reasons influenced them. Their courage is well known. Their appreciation of moral forces and their discernment of the path of duty is beyond question. But there are two factors which lie embedded in the question, "Catch a weasel asleep?" which always sway the average councilman. (1) Does the business to be done involve a tax? Then if the tax will even save my life, or my son's life, I'll vote against it. (2) Will the business to be done cost me the vote of the compact minority? I'll vote against it. In township matters the compact whiskey minority will support me, while the majority are safe to divide on sectional questions and break up into fac-

A little information of a financial charac-

ter may not come amiss to those who are not besotted or whose pecuniary interests do not lie with the whisky trade. These cannot be supposed to accept as true the carefully gathered statistics which show the beneficial operation of the Scott act. If a man has no moral attraction towards efforts for promoting public virtue, except those sanctioned by himself, his self-esteem will limit his vision and he will not see what he does not desire to see. But there is a large class who have an interest in these figures, in proportion to the intensity of their love for the family relation and family life in its widest sense. The statement that in the Scott act county of Halton the judges, at eleven successive assizes, have received kid gloves from the sheriff in token of there being no criminals for trial, will commend the act to many. In Ontario there are about one million inhabitants under license, and about the same number under the Scott act. The number of crimes committed in 1886, in the counties under license, was 7,923, in the Scott act region 1,940, a difference of 5,983. During 18 mouths, ending 1st October last, 3,029 convictions were obtained for violation of the Scott act in this province. All around us the temperance people are aroused and determined to enforce the law. There has been much apathy on their part here, due in some degree to the hope that the law itself would convey its own terrors without the arm of administrative authority. But it requires no argument to prove that the liquor interest will die hard. Its enormous profits blind the moral perceptions of those engaged in it. Familiarity with the evil deadens the susceptibilities and blunts the sympathies of many, even when the destroyer takes away a brother or a child. The kingdom of heaven among men has no more deadly foe than the liquor trade. The unbelief that rejects the gospel has its strongest buttress in the spectacle of men naming the name of Christ who refuse to depart from iniquity, and those who refuse to exercise their authority as citizens to break the yoke of the oppressor .- Yours truly, FRONTENAC.

More On County Litigation. BATTERSEA, Dec. 13 .- (To the Editor) : In your last issue I see the committee on finance have decided to abandon the suit with the Ontario government, in opposition to the claim for expenses of the Scott act. Pity they had not done it before making such an exhibition of themselves. Quite recently a trustee board was going to contest a case with a party in court. One of them, who was very fierce for the trial to go on, asked his lawyer who would have to pay the expenses if they should lose the case. He was told "the individual members of the board." He said : "Well then, I will have nothing more to do with it." So I think if the members of the county were made to suffer themselves alone for their prejudiced, and I might say, unjust acts they would not be quite so eager to rush into law. One would think the K. & P. lawsuit ought to have taught them a lesson that they would never forget.

But there is another matter in connection with this meeting of the finance committee that I would like to notice, and that is the very improper remarks made by Mr. R. T. Walkem concerning the Scott act. He says that the license commissioners have power to sue for whatever claim they liked and the council would have to pay it. Now surely Mr. Walkem knows better than that. If the commissioners had sued for \$3,000 instead of \$1,200 does Mr. Walkem mean to say they would have got it? He also considers the act a most pernicious one and that it leads to rescality. He had seen boys offering evidence at Scott act trials and considered they were saying what was not true. Does he blame the act for that ? Is it not rather an evidence of the depraved effect that the constant use of liquor will have on the human heart. Just as well might he condemn the law against theft, because a man would swear falsely to screen an accom-

It a man goes into a dry goods store and buys a piece of cloth, or into a grocer's shop and buys a pound of coffee or tes, he is not ashamed or afraid to swear to it if necessary. Another iniquity, he says, is that it makes men slaves. Just think of a man, he says, being brought all the way from Inverary to Wolfe Island to be tried there for selling liquor. He also objected to the mode of procedure. It was not right to subject a business man to such indignities. Well, we think that any man selling liquor in open violation of the law has no right to the title of business man, also that instead of justice being brought to the man the man is

Reply to Mr. R. Balmer.

KINGSTON, Dec. 13.-(To the Editor): Last evening's issue gave us a letter by Mr. Balmer to which, with your permission, I would like to put in a few mechanical pointers, in order to set some misinformed people right and let others see the error of his remarks. In the first place he wants the people to believe there is something awful agoing to happen, and he seems to me to be laboring under the idea that all that are not knights of labor are asleep, as he remarks that they are the only ones that show us anything like an intelligent example in solving what he terms "the problems of the day." Good so far, and I for one am glad to hear it. But I cannot lose sight of the fact, nevertheless, that Mr. Balmer's researches and knowledge of what is going on around Kingston are very limited indeed. He may not be aware that there are some five mechanical clubs and social societies, whose noble object is the inculcation of principles which will fit man in every walk of life, the assisting of one another in time of distress. They don't make a great dear of fuss about it ; nevertheless they are progressing and are jewels in Kingston's crown of success, and are ready to defend old Kingston and its interests and its industries and those who run and manage them, as they have in times of trouble and discontent in days gone by. Their interest and success are ours; our aim is to encourage capital and, by our labor, obtain grand results fo the whole community. As to anarchism and the other "isms" that are going through the country, we will leave them and trust that, if any dare put foot on Kingston soil officer Timmerman will see them well provided for and notify some of us mechanics. We entrust him with this duty.

And, Mr. Editor, when they come we will be there, or anywhere else our services may be required. Knights of labor, socalled, have a record both in the United States and Canada. I leave it with any informed and thinking workingman, and he can from any opinion he likes, but mine is, judging from their conduct to men who cannot see through their glasses, as for instance, trying to compel men to join the order by annoying them at their work if they refuse, boycotting them as they say. It shows a small principle, but it is here in Kingston daily practiced. Then trying to compel an employer to keep their man and let, as he is called by them, a scab, go, the same scab being a first-class mechanic. Now, Mr. Editor, I am in for the reform and advancement of the laboring man, but I am not going to leave \$2 a day and strike because he cannot get the same, because he can go back towork on the co-operation, while I have to leave home to get another situation. For these reasons mechanics and laborers never yet have worked in harmony, and never will, and it is for these reasons mechanics will not unite themselves with the order. If there was a classification of the different branches of workingmen in the order, and a little more serious deliberation before action was taken, it would tend to the avoidance of a great deal of trouble, misery and dis tress, say nothing about loss to both parties. Arbitration is a failure, as we have seen in Kingston; and I have found the world over that the man by skill and industry and sobriety will come out on top of the heap and is the successful man at any profession. -I am, sir, yours respectfully, A ME-
