MANITOBA AFFAIRS.

The Elections Vigorously Fought-The Government's Little Schemes-Mr. Royal Not Wanted.

WINNIPEG, Jan. 8.—The contests in Assiniboia and St. Francois Xavier are being fought with bitterness on both sides, but the Opposition is handrcapped by the large amount of whisky and boodle with which the Government are flooding the constituencies. Many Frenchmen are inclined to vote with the Opposition, and Dr. Harrison is taking every means to bring them into line. A stormy meeting held last night at Headingby was largely in favor of Francis, the Liberal candidate. The Government have given instruction to the deputy-returning officers not to allow non-residents to vote, although their names are on the list. Trouble at the polls is expected.

The appointment of Royal as Lieut. Governor is condemned by nearly all the newspapers in the Territories, of both shades of

Rev. J. B. Silcox, the Congregational pastor, delivered a sermon this evening on "The graves of '87." He took occasion to refer to Treasurer, and said: "What the Province of Manitoba sorely needs just now is men of ability, men of truth, men of honor, to lift the province out of the miry slough into which it has been dragged by pot-house politicians and lift it to a respectable position before the world. We are in a sorry and shameful plight to-day. Men who were leaders have left the ship floundering on the shoal and are asking Parliament to pass special laws to make them lawyers. Thus they will make the noble profession of the law a pit for smirched politicians. As a citizen who has loved this province and does love it-and I know I speak for many others-I feel humiliated when I consider the present condition of the Province. The province has been trampled on and spit on by a huge bulldozing corporation and our leaders have not had manliness enough to resent the insult. Like whipped dogs, they have licked the hand that smote them. They have proved themselves either incapable or criminal, or both, and not worthy to represent a people who possess the spirit and independence that have characterised Anglo-Saxons the world over. It would be an unspeakable blessing to the land if some strong man would arise and go to the Legislature as Oliver Cromwell once did and drive the whole kit out-order them to make room for capable, honest men. If it is true that a nation is known by the character of the men it elects to office, what will the world think of us?"

A BIG LOAN.

The loan was negotiated to carry on the work of relief and repairing made necessary by the overflow of the Yellow River.

BROUGHT TO TIME.

The Captain of a Tramp Steamer Porced to Obey the Law.

NEW YORK, Jan. 8.—The British tramp steamer Mosser arrived in this port on Dec. 11 from Asiatic ports with a miscellaneous cargo. When the cargo was unloaded it was found that about 150,000 pounds of tea had become worthless by contamination with other freight. Libels were filed against the vessel for the value of the tea by Gillespie & Co. and others, and Deputy United States Marshal Holmes seized the vessel. He discovered that the captain of the Mosser had coaled and was about

The Marshal hurried to the Federal building and was furnished with fourteen deputies to prevent the departure of the Mosser. At first the captain was obdurate and said he would sail despite the jurisdiction of the court, but finally came to his senses. filed sufficient bonds and paid all the costs.

THE G.T.R. AND ALLAN LINE.

A Settlement of the Dispute Between Them Said To Be Probable.

MONTREAL, Jan. 8. - The statement is made that the Grand Trunk Railway authorities and the Allan Steamship Company have reopened negotiations with a view to settle the difficulty between them. It will be repany fell out with the Grand Trunk Railway on the question of freights, and on Dec. 29 it was decided that the steamers should give the gc-by to Portland as a winter port and call at Baltimore instead. For the past few days, the rumor says, Mr. Andrew Allan, Mr. R. A. Smith and Mr. Sergeant, general freight agent of the Grand Trunk, have been in conference, and an amicable settlement is likely to be arrived at. The new time table of the Allan Line, with Portland reinstated instead of Baltimore, may be looked for shortly.

TIGHTENING THEIR GRIP.

MINERS HAVE A GOOD HOLD.

Cont Shipments Over the Reading Road Steadily Decreasing - Committees of Business Men Will Ask President Corbin to Arbifrate-Other Labor Troubles.

READING, Pa., Jan. 7. - The coal shipments over the Reading Railroad since the opening of the week have decreased steadily day by day and this morning the company's tally sheet at the office in this city showed that hardly 600 cars had come down the road from sundown last evening until to-day. This is regarded by all conservative parties as an indication that the strikers are tightening their hold. Of these 600, about 125 cars contained soft coal from the bituminous regions. Nearly all the anthracite now shipped comes from the individual collieries, the company reserving the small supply mined at their own collieries for its own use. The railroad hands who took the places of the strikers are being boycotted everywhere. Hotel-keepers refuse to keep them except at exorbitant rates, and many of them and the Pinkerton detectives are being quartered in old passenger cars, especially fitted up in the shops in this city with bunks, stoves, etc.

The scarcity of coal and the increased cost of that commodity has not yet resulted in the shutting down of any of the furnaces or manufactories in the vicinity, and the proprietors generally express a hope that a speedy settlement of the strike will avert such a course on their part.

Business Men Taking Action.

SHENANDOAH, Pa., Jan. 7.-A largely attended meeting of leading business men was held here to-day. SHAMOKIN, Pa., Jan. 7. - The Board of Trade have appointed a committee to call on President Corbin and ask that an adjustment of the present difficulty be made. Business is almost entirely suspended.

Will Aftempt to Start a Mine. HAZELTON, Pa., Jan. 8.-No attempt has been made to operate any of the mines in this striking district during the past week. The strikers are apparently satisfied to continue in the present struggle, and a break in the men's ranks is not probable. Another effort will be made on Monday to resume at one of the collieries of the district, that of C. Pardee & Co., at Hollywood. It is thought by the firm that enough Italians and Hungarians can be had to operate one mine.

Support Asked for Lehigh Strikers,

WILKESBARRE, Pa., Jan. 7. - The Local Executive Board of the Knights of Labor issued an appeal yesterday afternoon to the workingmen and citizens in Wyoming and Lackawanna Valleys. They claim that if the strike can be protonged four weeks the Reading Company must yield.

Ordered Out.

NEW YORK, Jan. 8. - A conference was held last night in Jersey City between representatives of the various trades involved in the Reading strike, and it was decided that the men should be ordered out of the Wyoming mines. This action, it was said, would practically stop work in the anthracite coal region. A prominent member of District Assembly 49 said the Knights had fully made up their minds to fight this strike to the end.

A Quiet Sunday.

READING, Jan. 8. - Sunday is usually a very quiet day in the coal regions, and this was exceptionally so. The run of coal down the road since midnight was but 500 cars, while three | rison, actress, was taking the train for Detroit, weeks ago to-day there was shipped through this city 6800 cars drawn by sixty-one engines. At the car shops in this city the books show that the number of coal cars in active service on the road is about 40,000. Nearly all of these are now lying on the siding in the coal

Navigation closed on the Schuylkill Canal on Dec. 10, and about two dozen boats engaged in the coal carrying trade, each containing several hundred tons of coal, became icebound north and south of this city. It was not expected that the coal could be moved before spring, but now every pound has been bought

The information received at the company's office in this city to-night is that to-day's meetings of the strikers showed that there is no break in the miners' strike.

Shamokin appears to be the hotbed of the present strike. It is there most general, both on the railways and in the mines, and it is there where the most feeling is shown against non-union men.

Coal Goes Up.

PHILADELPHIA, Jan. 8.-The Ledger tomorrow will say: The anthracite coal trade are taking advantage of the strike in the Schuykill district to further advance the price for coal, and last week the shippers advanced their prices at the breakers from 30 to 75 cents per ton. The local retail coal dealers have in turn increased their prices from \$6,25 and \$6.50 per ton to \$7.50, with the tendency of prices towards still higher figures.

The New York Cignrmakers' Strike. NEW YORK, Jan. 8.—The strike of the cigarmakers cannot be extended before Tuesday, because the local unions throughout the country must be heard from before general action can be taken according to the rule of the union. The hands of Hirsch & Co. are alone out at present on strike. The hands say that the strike will be general throughout the city on Tuesday.

Will Make no Overtures.

NEW YORK, Jan. 8.—The regular weekly meeting of the striking flint glass blowers took place yesterday at their headquarters in Brooklyn. It was learned that the workmen had decided to make no overtures to the employers. If the latter desire a conference the men will meet them at any time. It is said that very important developments are expected on Monday. It was learned from another source that an eastern manufacturer outside of Brooklyn had decided to withdraw from the association. This will break the combination, and the men can return to work under their own rules.

COMMERCIAL UNION.

What is Thought of it in England-Peace Society's Favours. To the Mail.

LONDON, Jan. 8. - The feeling is rapidly growing here that as commercial union would greatly promote the prosperity of the dominion it is desirable in the interest of the British investors. This view has been put forward in two or three liberal newspapers, and is favoured by several prominent members of the Peace society who have just returned from a visit to the United States and Canada. The latter say Canadian prospects are not very bright just now; that our exports to Canada must decline owing to the tendency of the dominion tariff to increase ; and that free trade between Canada and the States would do more to develop the natural resources of the former than any other measure. They are, therefore, favorable to commercial union, although they admit it would injure British trade to some extent, though not, they say, for long; inasmuch as the United States tariff, which would probably be the one agreed upon under the scheme; will soon be lower than that of Canada. A LETTER FROM THE CARDINAL.

Relating to the Striking Printers in the City of Quebec.

QUEBEC, Jan. 8.—The following letter from Cardinal Taschereau in relation to the labor troubles in the city, was read in all the Cathslie churches to-day:

In my circular of April 5, 1887, informed you that the Holy See had suspended until further orders the effect of the condemnation of the society of the Knights of Labor. Among other conditions the Holy See exacts: 1. That the Knights of Labor be ready to abandon this society so soon as it shall ordain it. 2. That they sincerely and explicitly promise absolutely avoid all that may either favor Masonic and other condemned societies, or violate the laws either of justice, charity or of the state. & That they abstain from every promise and from every oath by which they would bind themselves either obey blindly all the orders of the directors of the society or keep absolute secrecy even .towards lawful authorities. Catholics who fail in one of these conditions are unworthy of the sacraments of the church.

To those who will consult you (the rectors) you will tell them for me (the Cardinal) that I strongly advise all the Catholics of the archdiocese not to enroll themselves in this society which is, to say the least, dangerous, and if they already belong, to withdraw therefrom as soon as possible.

Arrival of the First Through Freight with Flour From Minneapolis,

SAULT STE. MARIE, Mich., Jan. 8"-The first through freight train, containing flour, arrived here from Minneapolis at 4 o'clock this afternoon. The train consisted of two engines and nineteen cars. They left Minneapolis Friday afternoon, but met with heavy snow-drifts. On reaching here the train met with an enthusiastic reception, hundreds greeting it at the station with loud cheers. The train was transferred at this point to the Canadian Pacific Railway, who will rush it through to Boston. This opens up the fastest freight and passenger route from the Mississippi to New England. Eighty-three cars of flour will follow this consignment in four trains.

Among the inscriptions on the fre ight cars were: "Minnesota Sends Greeting to All England;" "First Through Train from the Mississippi to the Atlantic North of Lake Michigan.

him of the crime. Judgment was given by Mr. Justice Rose at Osgoode hall, on Saturday, in the Halton election case, declaring the election void and citing two men to appear before him at Milton, ou February 3rd, to answer the charge of corrupt practices at the election.

The Lake Seamen's union passed resolutions touching the loss of life on the lakes caused by overloading and careless inspection, and calls on congress and the public to aid them in their efforts to assure greater safety to passengers and crews on the lakes.

Mrs. Ida McAnley, Chicago, who killed her husband Christmas eve on discovering that he was engaged in an intrigue with her sister in law, has been re-arrested. She took out letters of administration for her husband's estate, worth \$5,000, and the dead man's mother swore out a warrant charging the wife with murder.

FISHERIES COMMISSION.

Satisfaction in England Over The Late Reports-No Details Yet Known.

LONDON, Jap. 8.-The cheerful reports received regarding the fishery negotiations have given satisfaction, though they are viewed with some skepticism. An amicable settlement is earnestly desired, but Canada would be upheld by a large body of the public and the opinion of the press in insist. ing on her reasonable demands. No details are published yet regarding the concessions which Mr. Chamberlain is reported to have induced the Ottawa government to make.
