# TIE VOTE OCCURS IN 080.

MR. AVERY WILL LIKELY GET THE OFFICE OF PEEVE.

Mr. McIntyre Threatens to Protest the Election if He Does-The Vote Cust for the Candidates Equal-A Result of the Recount Made by the County Judge.

To-day a recount of the ballots cast at the recent municipal elections, held in the township of Oso for reeve and councillors, was held in the chambers of Judge Price, at the court house. The candidates for the office of reeve were Messrs S. Bourke and Avery. Both being very popular with the electors, the contest proved a hot one. At the close of the poll, when the ballots were counted it was found that Bourke had been elected by a majority of one.

The result did not give Mr. Avery satisfaction, and he came to the conclusion that probably a recount would change the result. The court opened at 11 o'clock. Mr. Mc-Intyre appeared for Mr. Bourke, and Mr. Shibley looked after the interests of Mr.

The returning officer, Mr. H. Cannon, and the candidates, were present. Mr. McIntyre said that it had been an

nounced that the ballots had been tampered with after they were placed in the box. Mr. Cannon denied that such had occurred. There had been many stories circulated about the ballots being handled

after being put in the box, but they were not true,

The count was then commenced. Mr. McIntyre enquired the state of the poll and was told that Bourke had 96 votes and Avery 95.

The judge sorted the ballots, which afterwards were reviewed by the lawyers. While the count was proceeding Mr. Cannon told the lawyers to examine the backs of the ballots and they would find his name stamped upon them.

Mr. McIntyre discovered that one of Avery's ballots was not stamped. It was not allowed. There were three ballots for Bourk marked with one stroke and not allowed.

A good deal of time was taken up in considering another ballot which had been marked twice for Bourke. The judge finally ruled it good.

Among the ballots for Avery there was one marked with a single stroke. It was reject d. The result of the investigation was that the votes cast for each candidate aggregated an equal number. Avery, 93; Bourke, 93.

The clerk of Oso, Mr. Cannon, will give the casting vote, and is a supporter of Mr. Avery.

Mr. McIntyre argued that if Mr. Avery was declared elected a protest would be entered against him taking his seat in the council on the ground of not being qualified. Mr. Bourke was, in a previous year,

elected by the vote of the returning officer. Mr. Avery states he is qualified to hold the office of reeve of Oso, and this fact he will prove if necessary. He has an unencumbered interest in the saw mill of Avery & Thompson, and besides owns a farm.

### HON. ALEXANDER MACKENZIE.

Three Honored Men Who Lived in Kingston-Sketch of a Stone Mason, Toronto Week.

Toward the end of the year 1842, three young men resided in Kingston who were destined to act prominent parts in the public life of Canada. One of the three was a rising young lawyer of pleasing address and popular manners, who had won distinction by his defence of Von Schultz and other State prisoners connected with the troubles of 1837. The second had been a student in the office of this young lawyer, and was this in Kingston in April, and was beginning his Canadian life as a stonemason. The young lawyer is now the Right Hon. Sir John Macdonald, first minister of Canada. His student is now the Hon. Oliver Mowat, premier of Ontario. The youthful stonemason is the veteran statesman, Hon A. Mackenzie, a name respected and honoured by every clean man in the Dominion of Canada.

Mr. Mackenzie will be sixty six years of age on his next birthday, the 28th of the present month. He is two years younger than his friend Mr Mowat, and seven years Scotland. His parents had neither poverty brain-power, intelligence, untiring industry, sterling integrity, and an honourable ambition to rise in the world. Along with few. Two years in a private school in Perth: two more in the parish school of Moulin : less than a year in the grammar school of Dunkeld, and the education of the future Premier of Canada was finished so far as the school-master was concerned. At the early age of fourteen his father died, and, like many another brave Scotch lad who has made his mark in the world, young Mackenzie began to earn his bread on the old Eden principle, by the sweat of his brow. Like Hugh Miller he learned the trade of a stone-mason. and like Hugh Miller he was fond of reading. His spare hours were spent in diligent study, and the habits then formed have clung to him all his days. A worthy member of the house of commons, says his hours were over lonesome in the same boarding house with Mr. Mackenzie and David Mills, because, as he explained it, "the moment Mackenzie and Mills came infrom the house they sat down to their books."

In the following year, 1843, Mr. Mackenzie was joined in Kingston by his brother, Hope F. Mackenzie, who afterward represented Lambton and North Oxford in parliament. Mr. Hope Mackenzie was a man of fine spirit, great energy, and high attainments. He was rising rapidly as a public man when his career was suddenly ended by death. Had his life been spared his ability, industry, and natural force of character would soon have placed him in the front rank of Canadian statesmen.

After labouring five years in Kingston, during which time he probably became familiar with the well-known face of the man he afterwards so often faced in parliament, Mr. Mackenzie moved to the neighborhood of Sarnia. 
