and the man upon his evidence admitted that  
the deceased, who was a servant out of place  
and in distress, used sometimes to sleep in  
Mr Frost's stable. On the night the acci-  
dent happened, the family were all retiring  
to rest and the prisoner had gone to bed,  
when his sister came into his room to take a-  
way his candle. Hearing some noise in the  
garden, resembling the sound of a heavy  
shower of rain, he desired his sister to open  
the window and see whether it was raining.  
Upon looking out, she saw a man at the  
kitchen window, and trying to open it. She  
gave the alarm to her brother, who immedi-  
ately jumped up and went down with his gun.  
The alarm having disturbed the man, he was  
moving off in great haste, when the prisoner  
demanded his business there. No answer  
was given, the demand was repeated a-  
gain, but no reply was received; upon which  
the prisoner discharged his gun at him, and  
the unfortunate man fell wounded to the  
ground. The prisoner immediately returned  
to the house, but his pity being excited by  
the groans of the dying man, he came to his  
relief, and he was brought into the house,  
and then it was discovered that he was a  
friend of the footman, who had come to see  
him in the hopes of getting lodging for the  
night. A surgeon was immediately sent for,  
and every attention and kindness was shown  
that his unhappy situation required; but in a  
few hours afterwards he expired. The de-  
ceased when brought in was barefooted, and  
his shoes were found in a clump of laurels,  
about twelve yards from the place where he  
fell.

Several most respectable persons gave the  
prisoner the highest possible character, and  
he was spoken of as a youth of gentle and  
humane disposition.

Mr. Baron Garrow, under the circum-  
stances disclosed, directed the jury to acquit  
the prisoner, charging them, that the melanc-  
holy event which had happened was no more  
than one of those misfortunes to which every  
housekeeper was liable under similar circum-  
stances.

The jury immediately found a verdict of  
Not Guilty, and the prisoner, before he was  
restored to the bosom of his family, all of  
whom were present and in great affliction,  
received the condoling assurance of the learn-  
ed judge, that he returned from the court  
with the sympathising feelings of every well  
disposed mind, and that there was nothing  
in his case which required the indulgence of  
any other sentiment than that of regret,  
which he appeared sincerely to feel in being  
the unfortunate cause of depriving a fellow  
creature of life. The youth, whose heart was  
full, respectfully bowed and retired.

**BISHOP WARBURTON.**

think of human life in general; good  
brown ochre is the complexion of it.'

**Statutes of Upper Canada.**

An Act to give effect and validity to deeds  
executed by married women in the United  
Kingdom of Great Britain and Ireland, or  
in any of His Majesty's Colonies, and to re-  
peal part of and amend an Act passed in  
the forty-third year of his Majesty's reign,  
entitled, "An Act to enable Married Wo-  
men having real estate, to convey the same.

Whereas, there is by law no provision  
enabling married women resident abroad,  
and owning real estate in this province to  
alien the same, BE it enacted by the King's  
most excellent Majesty, by and with the  
advice and consent of the legislative coun-  
cil and assembly of the province of Up-  
per Canada, constituted and assembled by  
virtue of and under the authority of an  
act passed in the parliament of Great Brit-  
ain, entitled, "An Act to repeal certain  
parts of an act passed in the fourteenth  
year of his Majesty's reign, entitled An  
act for making more effectual provision  
for the government of the Province of  
Quebec, in North America, and to make  
further provision for the government of  
the said province," and by the authority  
of the same, that from and after the passing  
of this act, it shall and may be lawful to  
and for any married woman, having real  
estate in this province, and being above the  
age of twenty-one years, with the knowl-  
edge and consent of and by any Deed or  
Deeds jointly with her husband, to alien,  
depart with and convey any real estate  
whereof, she may be seized within this  
province to such use or uses as to her and  
her said husband shall seem meet, which  
conveyance shall be as valid and effectual  
in law to all intents and purposes, as if  
she were sole, any law or usage to the con-  
trary notwithstanding.

Provided Nevertheless, and it is hereby  
declared that, nothing in such Deed con-  
tained, shall have any force or effect to  
to bar such married woman, or her said  
husband, or her heir during the contin-  
uance of her coverture, or after the dissolu-  
tion thereof, or shall be held to have any  
force or effect whatsoever, unless such  
married woman if resident in Upper Can-  
ada, shall appear before any judge or other  
person mentioned and described in a  
certain act passed in this province, in the  
forty third year of his Majesty's reign, en-  
titled "An act to enable married women  
having real estate, more conveniently to  
alien and convey the same," or unless such  
married woman being resident in Great  
Britain or Ireland, or any colony belong-  
ing to the crown of Great Britain, shall  
appear before the mayor or chief magis-

trate of any city, borough or town corpa-  
rate in Great Britain or Ireland, or the  
chief justice, or any one of the judges of  
the supreme court of any colony belong-  
ing to the crown of Great Britain, and be  
examined by such mayor or chief magis-  
trate, or chief justice or judge, touch-  
ing her consent to alien and depart with  
such real estate, and shall freely and vol-  
untarily, and without coercion, give her  
consent before such mayor or chief magis-  
trate, or chief justice or judge as afore-  
said, to alien and depart with such real es-  
tate.

And be it further enacted by the author-  
ity aforesaid, That in case it shall appear  
to such mayor or chief magistrate, chief  
justice or judge, that such married woman  
doth freely and voluntarily consent to de-  
part with, alien and convey her real estate  
without coercion on the part of her hus-  
band or any other person, it shall and may  
be lawful for such mayor or chief magis-  
trate, chief justice or judge, to cause a cer-  
tificate thereof to be endorsed on the deed  
so executed by her and her said husband  
as aforesaid, which certificate shall state  
the day on which such examination is tak-  
en, and shall be signed by the mayor or  
chief magistrate, chief justice or judge be-  
fore whom the same shall be taken, and for  
as much as by the second section of the  
said recited act of the forty third year of  
the reign of his Majesty, the examination  
of any married woman, touching her con-  
sent to alien, depart with and convey any  
real estate in this province, shall take  
place within six months from the time of  
the execution of any deed or conveyance,  
the same being found inconvenient and  
impracticable in many cases, it is hereby  
enacted, that so much of the said second  
section of the said act as enacts that such  
examination shall take place within six  
months from the time of the execution of  
any deed or conveyance as therein stated,  
shall be and the same is hereby repeal-  
ed.

And be it further enacted by the author-  
ity aforesaid, That all examinations of  
such married women and certificates of  
such deeds as before mentioned, which  
may be taken and made as by the said se-  
cond recited acts are mentioned, shall be  
valid in law if the said examination and  
certificate shall be taken and made within  
twelve months from the date of the execu-  
tion of any such deed or conveyance.

And be it further enacted by the author-  
ity aforesaid, That no certificate to be  
granted as aforesaid by any such mayor or  
chief magistrate of any borough or town  
corporate in Great Britain or Ireland, or  
of any colony belonging to the crown of  
Great Britain, shall have any force or ef-  
fect unless the seal of such city, borough  
or town corporate shall be affixed thereto.

**Halifax, Sept. 2.**

A most horrible act of parricide has been  
committed at Pictou, by one Donald Camp-  
bell, who set fire to the house and cottage in  
which his aged father and step mother had  
retired to rest.

It appears that this wretch left his own  
dwelling house on the twenty third inst. with  
a determination to set fire to that of his father;  
he wandered about during the day, consid-  
ering how he might most effectually ac-  
complish his diabolical purpose. In the evening  
he went to the house, and listened to the  
conversation of its aged inmates, until they  
retired to rest. He then secured the door on  
the outside, by passing a stick across and  
putting twisted withs through the latch and  
round the stick. His object was to prevent  
the escape of these unhappy people, when  
they should discover that their house was on  
fire, the cottage being destitute of windows.  
He then placed a fire on the roof, and retired  
a short distance that he might witness the  
annihilation of his intended victims.

Contrary to his expectations however, the  
aged people forced the door, and he beheld  
them endeavoring to save their little all—  
Nature now became too powerful; those  
feelings which accompanied him into exist-  
ence, prompted him to fly to their assistance  
—but the old man charged him with the  
crime he had committed, and drove him a-  
way. He again retired, and beheld his father  
enter his dwelling never to return. He  
was now satisfied that if the woman survived  
he should be punished, and knocked her  
down with a stick; and at her request, as he  
says, conducted her to the door of the house,  
where she also perished.

The perpetrator of this unnatural and in-  
human crime was shortly after apprehend-  
ed, and confessed every thing; a desire of  
obtaining his father's property urged him to  
commit the unnatural deed, and nothing now  
remains to terminate this shocking catastro-  
phe, but his ignominious and shameful death.

**A PROCLAMATION.**

Whereas our Sovereign Lord the King  
by certain letters patent, under the great  
seal of Great Britain, bearing date at  
Westminster, the eighth day of May, in  
the 58th year of his reign, did constitute  
and appoint his Grace, Charles, Duke of  
Richmond, Knight of the most Noble Order  
of the Garter, General and Governor  
in Chief in and over the Province of Up-  
per Canada and Province of Lower Can-  
ada:—And Whereas, in and by the said  
letters patent, it was declared to be the  
royal will and pleasure, in case of the death  
or absence of the said Charles, Duke of  
Richmond, from the said provinces, if up-  
on such death or absence, there should be  
no person commissioned and appointed by  
his said Majesty, to be his lieutenant gov-  
ernor, or to administer the government  
within the said provinces, that the senior  
member of his Majesty's executive council  
of the said province of Upper Canada, or  
of the said province of Lower Canada,  
being a natural born subject of Great  
Britain, Ireland, or the British Colonies &  
Plantations, and professing the Protestant

Religion, who should then be residing  
within such of the said provinces, (The  
Chief Justice and Bishop for the time be-  
ing, excepted) should take upon him the  
administration of the government, and ex-  
ecute the said commission, and the instruc-  
tions relating thereto, and the several pow-  
ers and authorities therein contained, to all  
intents and purposes as other governors,  
lieutenant governors, or persons adminis-  
tering the government, until his Majesty's  
further pleasure should be known there-  
in;—

And whereas by the decease of the said  
Charles Duke of Richmond, (there being  
no person at the time of his death in the  
said province of Lower Canada commis-  
sioned to be the lieutenant governor, or to  
administer the government thereof) the  
administration of the civil government of  
the said province of Lower Canada hath  
devolved on me, the said James Monk, as  
the senior member of the executive coun-  
cil of the said province of Lower Canada,  
as aforesaid: I have therefore taken upon  
myself the administration of the said gov-  
ernment, in pursuance of, and obedience  
to, the said royal will and pleasure; and  
I do hereby make known the same to the  
officers of his Majesty's government, and  
all others his Majesty's subjects in this  
province, and generally to all whom the  
premises may or shall in any wise con-  
cern, who are hereby required to take no-  
tice of the same, and govern themselves  
accordingly.

Given under my hand and seal, at  
Arms, at the Castle of Saint Lewis,  
in the city of Quebec, this twentieth  
day of September, in the fifty ninth  
year of his Majesty's reign.

TUESDAY, OCTOBER 5, 1819.

Last Sunday morning (Oct. 3d) three  
Steam Boats left the port of Kingston, with-  
in a few minutes of each other. The *Fron-  
tenac*, for York and Niagara; the *Charlotte*,  
for the Bay of Quinte; and the *Sophia* for  
Sacket's Harbor. The preceding day, we  
understand, the Steam Boats *Ontario* and  
*Sophia* left Sacket's Harbor together; one  
of them for Ogdensburgh, and the other for  
Kingston.

It appears by extracts from the English  
papers, that large meetings of the populace  
continued to be held in various towns in  
England, as late as the 17th of August. On  
that day a numerous multitude of people as-  
sembled at Manchester, were dispersed, and  
their leaders seized, by military force. Sev-  
eral lives were lost on the occasion. These  
scenes of tumult, whatever are their causes,  
are to be regretted, not only from the im-  
mediate evils attending them, but on account of  
their natural tendency to increase the rigor  
of government and the sufferings of the peo-  
ple. We are glad to see, by London dates  
of the 19th August, that all was then quiet  
at Manchester, although another meeting  
was spoken of. A meeting was proposed to  
be held on the 23d of August, at Kensington  
Commons.

The Duke of Wellington arrived at Aix-  
la-Chapelle on the 10th August, and the next  
day he set out for Berlin. His supposed ob-  
ject is to settle the difference between Den-  
mark and Sweden.

It is stated that the slave trade is carried  
out to a frightful extent at Prince's Island,  
near the Bight of Biafra, on the Guinea coast,  
which is the principal rendezvous on the Afri-  
can shore.

Symptoms of division and dissension are  
said to have appeared at Prussia, to a degree  
that has excited some alarm.

The citizens of New York appear to be al-  
larmed at the appearance of the yellow fe-  
ver in that city. It prevails in Baltimore,  
especially at Fell's Point; and also at  
Charleston (S. C.) and New Orleans. A few  
cases have occurred in other towns in the U-  
nited States. The mayor of Baltimore, at  
the request of the clergy of different denomina-  
tions, has issued a proclamation recommend-  
ing the observance of a public fast.

**DROWNED.**

On Monday night the 27th ult. *Thomas  
Rodgers*, a Sergeant of the 70th Regt. This  
accident was occasioned by his attempting to  
cross from Point Henry to Point Frederick  
in a wooden canoe, which unfortunately up-  
set.

**Mr. Editor,**

While perusing the sixth number of the  
*Christian Recorder*, my attention was arrest-  
ed by the following passage:

"Before closing the list of churches now  
building or recently finished, we naturally  
look to Kingston, where the first place for  
public worship in the province was built—  
This structure was enlarged many years ago,  
but is still too small for the increasing  
population, and for some time it has been ex-  
pected that the congregation would build a  
house worthy of the increased number and  
wealth of the inhabitants. Let a similar  
method to that which prospered so well at  
York be adopted, and it cannot fail of suc-  
ceeding. The writer of this article is con-  
fident that money on this principle might be  
raised in Kingston to any required amount,  
for all the reflecting part of the inhabitants  
feel the necessity of renewing the church,  
and many are liberally inclined. Let those  
who are more immediately concerned, the  
clergy and church wardens, begin this im-

portant business, and no longer expose the  
people of the largest town in the province to  
the reproach of the heathen author, that they  
are building magnificent houses for them-  
selves, and allowing the temple of God to  
fall into decay."

This reflection upon the good inhabitants  
of Kingston, contains too much truth to be  
contradicted; and I see no way for them to  
escape a repetition of the censure but by im-  
mediately setting about the work so strongly  
recommended—the necessity of which is ac-  
knowledged by every one.

The method adopted at York to raise a  
fund was by subscription in the way of loan,  
to be repaid when the seats in the church  
were sold. This appears the only plan  
which is likely to be attended with success,  
at the present period, in Kingston, and I ear-  
nestly hope those who are concerned will  
give some attention to the subject.

So many annual subscriptions and dona-  
tions have been levied in this place, that (not-  
withstanding their liberality) the Kingstons-  
ians begin to tire, and complain of the bur-  
den; but when they see the probability of  
their money being soon returned, I am con-  
vinced none will refuse to loan such a sum as  
his circumstances will warrant.
