The following is from the Durham Chronicle. We are enabled, in consequence of a gentleman being in our office, who has been acquainted with the nature of this individual's engagement, to give to our readers in general, and the sporting classes in particular, a more correct account of him than has yet appeared. He is also a member of the William Elliot referred to in the certificate; and on being questioned as to the truth of the contents, he gave such answers as to leave no doubt of his fraudulent intent.
