DEATH OF LADY MARY BACOT.—It is with Death of Lady Mary Bagot.—It is with regret that we have to announce the decease of Lady Mary Bagot, eldest daughter of the Earl and Countess of Mornington, and widow of the late Right Hon. Sir Charles Bagot, the late Governor of Canada. This sad bereavement was most unexpected, her Ladyship having been only considered slightly unwell within the last few days, her illness being supposed to have arisen from a cold. On Saturday night, alarming symtoms displayed themselves, and shortly after five o'clock yesterday morning, her ladyship breathed her last, at the family residence in Porchester Terrace, her complaint having terminated with inflammation. The deceased lady, who was, as we have above stated, the eldest daughter of the Earl and Countess of Mornington, was born 5th February, 1786, and married 22d July, 1806, the Right Hon. Sir Charles Bagot, second son of the late Lord Bagot, by whom her Ladyship had a family of ten children, seven of whom are living, Lieut. Col. Bagot and the Countess of Winchilsea being her eldest son and daughter.

Foreign.—The debate in the French chamber of Depaties is generally regarded as securing the Ministry in power another session. The letter of Archbishop Crolly, however, has had the effect of producing an official communication from the Lord Lieutenant, which sets the whole question at rost.
