

LOCAL AND OTHER NOTES.

That grim monster, Death, has visited the village since our last issue, and removed the form of two of our most popular and highly respected young people, Miss Susan Curs, sister of our esteemed townsman, John Curs, was the first to obey the summons, her death occurring on the morning of Wednesday last, the 14th inst. On Friday last the spirit of Valentine Mokes passed peacefully from earth. Because of his mother and sister, removed from Pine Hill to this place about five years ago. His many excellent qualities endeared him to all, and those who, by reason of nature's pangs, more keenly mourn, his loss have the heartfelt sympathy of the community. On Saturday his remains were borne to their last resting place at Pine Hill, the funeral being largely attended.

On Wednesday last Deputy Sheriff Robertson of Brockville, assisted by Detective McGowan of Toronto, arrested the man Morris, of Bishop's Mills, who was wanted for the murder of Henry Dool, a neighbor. Very little effort seems to have been made by the local authorities to locate Morris, who was a son-in-law of the neighbor, Koss in the vicinity. The matter was finally brought to the notice of the provincial authorities and a detective was sent down to Brockville. When the

officers arrived in the neighborhood they at once proceeded to the house of Morris who was found in hiding under the bed. He made no resistance to their arrest and so quiet was his demeanor that the officers did not consider it necessary to handcuff him. He delivered up the knife with which the deed is said to have been committed. It is a small two-bladed knife and not longer nor more murderous looking than any ordinary knife carried by farmers. Morris was taken before one of the local magistrates who made out a commitment to the Brockville jail. The writer was quite well acquainted with prisoner years ago and he then had the reputation of being a peaceable, hardworking farmer. Morris claims to have killed Dool in self defence, and says that he is glad that he has been arrested as the suspense of being liable to arrest at any moment was giving him great uneasiness and he was glad that the matter would soon be settled one way or the other. It is said that the neighbors are not very anxious to have Morris punished as they consider the provocation very great.

A MYSTERIOUS LETTER.

The following beautiful specimen of "English as she is spoke" we committed to the careful perusal of occasional correspondents. It was handed to us for publication, having the post mark of a Michigan office. Its pure orthography and elegant chirography won its way to our favor, and we reproduce it.

is what I Call a stupid Rounge I Dont Believe smart Rounge is Long Minded there Heads is to Round to be Long there toungs is to sweet to be wholeston A Man may know enough to Work Himself into a Trick And After All He Aint smart He Dont Know the results Nor effects of what He is Doing Adilston or east of it was unfavourable for Me although Born east of it Dont wish to give my Address.

DIVISION COURT.

The ninth division court was held here on Monday last. Owing to the junior judge having condemned the town hall, the sittings were held in the North Church. Bailiff Brown had a pan of saw dust placed in each paw so that "chawers" found a receptacle ready for the saliva, which would otherwise have been deposited upon the floor. The judge was a "leagle late" as usual, the court not opening until nearly 11 a.m. but when once started business was rushed through with all the despatch possible.

The first case called was Horace Dool vs. Jas. Livingstone. This was an action to recover an account for some pork sold to deft, the amount being \$4. The deft. put in an effect of \$7.50 for work alleged to have been done for pliff, some five or six years ago. Pliff swore that his old acct. was settled at the time by a payment in grain. Verdict for pliff, with costs.

Abel Stevens vs. Jas. Fendling, action to recover payment for service of stallion. Deft. had paid \$5 into court, being as he claimed the amount agreed upon. It seems from the evidence that Stevens called upon the deft. and had a conversation with him regarding the service of the horse.

The deft. offered him half a ton of hay for said service saying that he could get the use of Covey's horse for that amount and proved by his son that this was the agreement. Judgment for deft. with costs.

W. H. McLaughlin vs. Wm. Pierce. This was an action to recover payment for a mason's hammer, which pliff claimed had been taken from a pile of mason's tools by deft. and not returned. Deft. swore that he returned the hammer after using and had seen it in the place where he took it from on several occasions thereafter. Deft. could not prove to contrary, and was nonsuited.

H. R. Gordon vs. Cyrenus Stowell. An action to recover pay for a quantity of provender furnished to Wm. Harper on the order of deft. A number of witnesses were examined, who proved that a change of proprietors of the Elbe Mills having taken place, the deft. was released from payment.

Mrs. Wm. H. Giles vs. J. H. McLaughlin. A claim of \$3.50 for a quantity of stone. From the evidence it appeared that the deft. had got a few loads of stone from the pliff, with the understanding that Wm. H. Shevmen, was to fix the price. Wm. H. Shevmen on being called said that he did not consider the stone worth more than 25c per load, as it was fit only for filling in. The witness said he drew five loads of stone, the value of which were worth \$1 per load and the balance 25c per load. Absent

Witase thought the stone all told was not worth more than \$2.50. Alex. Compo said he had offered Mrs. Giles \$5 for the lot, which included a few loads not taken by the deft. His son had objected to paying \$5 for the lot, so he did not take them. An order was made for \$2.50 without costs.

Gro. H. Weatherhead vs. Thos. H. Johnston.—Deft was up on judgment summons.—Ordered to pay \$1 on 1st October and \$2 per month thereafter until the debt and costs are paid.

J. H. McLaughlin vs. Dr. Mosher.—The Dr. was up on judgment summons. He produced a certificate from Dr. Cornell that he was physically unable to perform hard manual labor. Mac produced a counter certificate which stated that the Dr. was still in an able-bodied condition. The Dr. also pleaded as an excuse that he was not able to earn more than 25c. per day breaking stone, and some days not that much. This excuse was met with the broadly hinted insinuation that he was not so sick as he was. The Dr. intimated that he would like to get a good paying job, and brickmaker King offered to take him on at good wages for all he was able to do, provided he boarded himself. The judge here asked Mac if he hadn't a job piling wood or some other light work that he could let the Dr. have to work out the debt. Mac demurred to this, as he had no desire to "adopt the Doctor." The judge concluded to make out a commitment for twenty days, in default of the claim being satisfied forthwith.

Jas. Lenihan vs. A. E. Donovan.—Action on acct. Struck out.

N. C. Williams vs. J. J. Carey.—Action on acct. Settled out of court.

J. H. McLaughlin vs. Charles Dordridge.—Judgment summons. Deft not appearing, a commitment was made out for 20 days.

SMITH'S FALLS.

A delicate and difficult investigation is under way at Smith's Falls. The practice of flogging pupils in the High school there having become obsolete, and there being a painful absence of variety in the daily program of proceedings, it is said that a few days ago the principal undertook to vary the monotony by thrashing one of the assistant teachers.

The assulted assistant disputes the principal's right to sacrifice him for a school boy's holiday and has appealed to a magistrate and to the School Board against the unusual exercise of insular authority by his superior officer.

Grave questions must arise during the course of the inquiry:—

(1) Has a principal a right to physical exercise during school hours?

(2) If prohibited from operating upon his pupils, may he use his assistants, upon whom to develop his muscle?

(3) And if he enjoys this right with respect to his male teachers, has he not authority to devote his female assistants to the same use?

(4) Then have male and female assistants singly or unitedly, as may best suit their purpose, the right to employ their surplus physical energy in putting identification marks on the principal?

(5) If so, what steps is it advised the Minister of Education should take in order to guarantee a continued supply of principals under the new system of High school discipline?

The Smith's Falls' inquiry will quite fail to meet popular expectation if there be not some strong and satisfactory deliberance upon these various points of grave perplexity.—*Tele.*


