Small Claims Court

What is a Small Claims Court? It is a simple, fast, inexpensive court system that is intended for private citizens to present their case directly to a judge without all the legal procedure for larger claims. Usually lawyers are not present in Small Claims Court.

You must still be prepared for the court of course. Take along all original documents you might have to refer to and be sure to make copies for yourself and your opponent (the judge will want the originals). Your witnesses will have to be present too.

The person bringing the claim (the Plaintiff) will present his case. The judge may ask the Plaintiff questions to clarify the problem. The Defendant may ask the Plaintiff questions and may present evidence as well. Usually, judges will try to give their decision right away.

At the moment, Small Claims Courts are restricted to amounts \$1,000.00 or less. However, there is a proposal before the Provincial Government to expand this limit to \$5,000.00 to keep up with the times.
