

### 1991 MUNICIPAL ELECTIONS

The Township of Rear of Leeds and Lansdowne will be proceeding under the mandatory Part II of the Municipal Act for the election to be held November 12, 1991.

The new provisions require that no person who proposes to be a candidate for any office (i.e. Council, School Boards) may solicit or accept contributions for election purposes or incur campaign expenses until they have filed Notice of Registration with the Municipal Clerk responsible for the conduct of the election.

The amended Act, provides, in Section 122 (1) "Every person who proposes to be a candidate shall, no earlier than the 1st day of January in an election year, and no later than nomination day, file with the clerk of the municipality who is responsible for the conduct of an election, a notice of registration in the prescribed form."
