**NOTICE OF PUBLIC MEETING**

PURSUANT to the provisions of the Retail Business Holidays Act, R.S.O. 1980, c.453, as amended, notice is hereby given that the Council of the Township of Bastard and South Burgess intends to pass a by-law to permit any retail business establishment carrying on a retail business within the Township of Bastard and South Burgess to be open on any holiday.

The relevant provisions of the Retail Business Holidays Act, R.S.O., c.453, as amended, are as follows:

Section 1

A. "holiday" means

- (i) New Year's Day
- (ii) Good Friday
- (iii) Victoria Day
- (iv) Canada Day
- (v) Civic Holiday
- (vi) Labour Day
- (vii) Thanksgiving Day
- (viii) Christmas Day
- (ix) Boxing Day
- (x) Sunday and,
- (xi) any other public holiday declared by proclamation of the Lieutenant Governor to be a holiday for the purpose of this Act;

B. "retail business" means "the selling or offering for sale of goods or services by retail."
