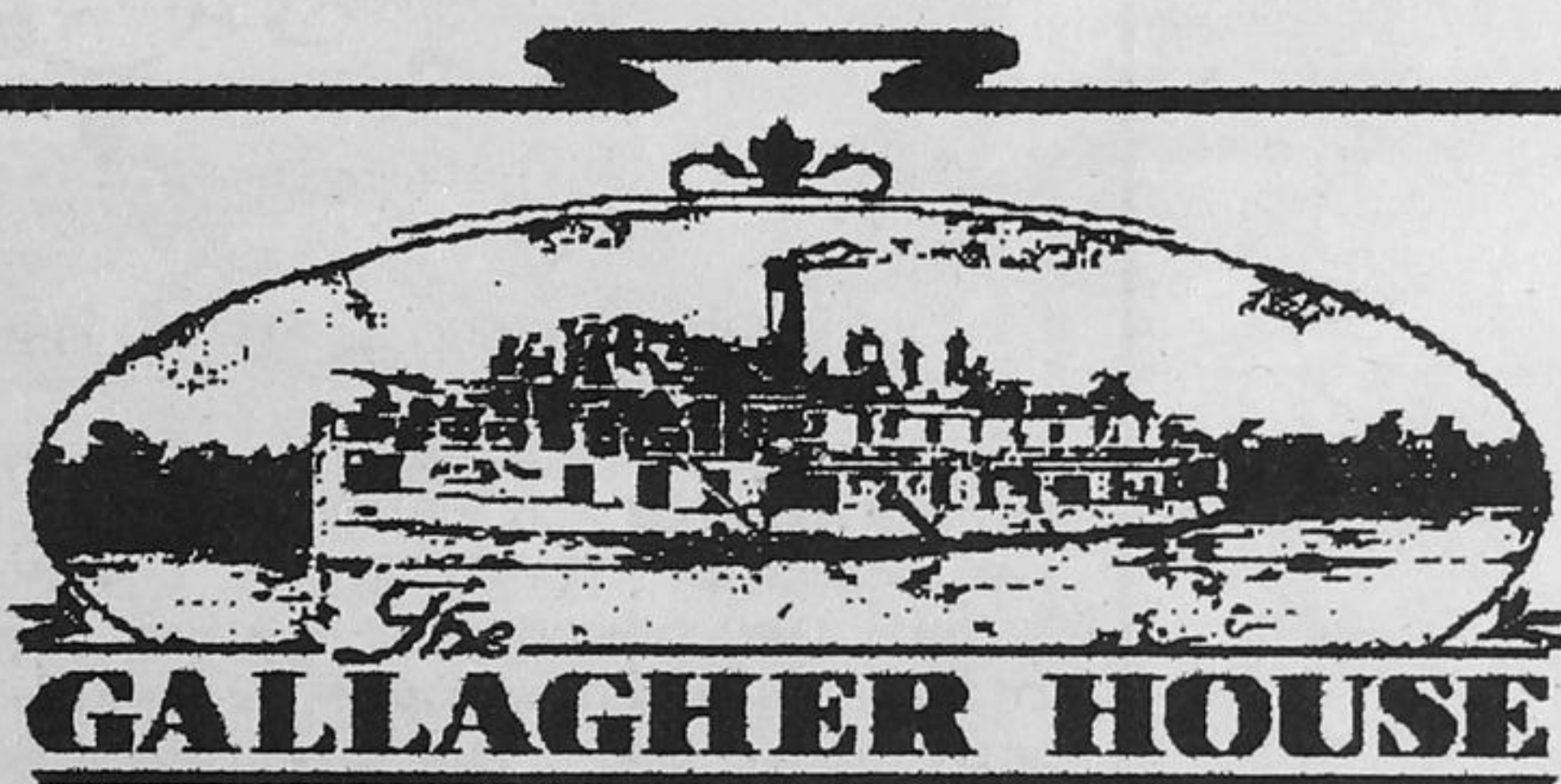

New Bankruptcy Act!

The federal government has proposed a number of changes to the Bankruptcy Act which has remained virtually unchanged since 1949.

Among the changes are:

- An employer-funded program to provide for wages owed to employees of failed businesses (90% of wages up to \$2,000.00). This program would cost employers \$5.00 per employee each year.
- Secured creditors would have to give 10 days notice of their intention to seize their security.
- Corporate proposals that would allow corporations the ability to freeze creditors for up to 51 days if the corporation files a plan of organization.
- Consumer proposals that would allow consumers to propose an arrangement with creditors to settle their debts and a freeze period on those creditors.
- Unpaid suppliers would be allowed to repossess goods sold within 30 days of bankruptcy provided the goods had not been sold and were in the same state they were in when they were delivered.

New Will Needed on Separation

If you have separated from your spouse you should immediately revise your will or make a will if you do not already have one.

Until you are divorced, your separated spouse is still your spouse. This means that if you do not have a will then most of your estate will go to your legal (but separate) spouse.

Separation does not nullify a will. If you had made a will and left all or part of your estate to your spouse, he or she will still be entitled to that share of your estate until you change that will.
