PURSUANT TO NOTICE a public meeting was held in Council Chambers at 7:30 PM. on Monday, March 12, 1992, concerning two proposed amendments to Zoning By-Law 20-1991.

Reeve Bruce Bryan chaired the meeting. The meeting was declared open at 7:30 PM. by Reeve Bruce Bryan who explained purpose of meeting and asked anyone wishing to speak to identify themselves. Reeve Bryan then turned the meeting over to Mr. Longtin.

APPLICATION FOR ZONING AMENDMENT NUMBER 1-1992 G. TACKABERRY & SONS CONSTRUCTION LTD.

Mr. Longtin described the purpose of this meeting was to amend Schedule A of By-Law 20-1991 by changing the zoning on the lands shown on Schedule A to this By-Law from "Aggregate Reserve Course" to "Special Rural Pit (SRP)". The effect of the By-Law is to permit the applicant to expand the existing pit in conjunction with an application for a pit licence under the Aggregate Resources Act and in accordance with the provisions of the Township Zoning By-Law.
