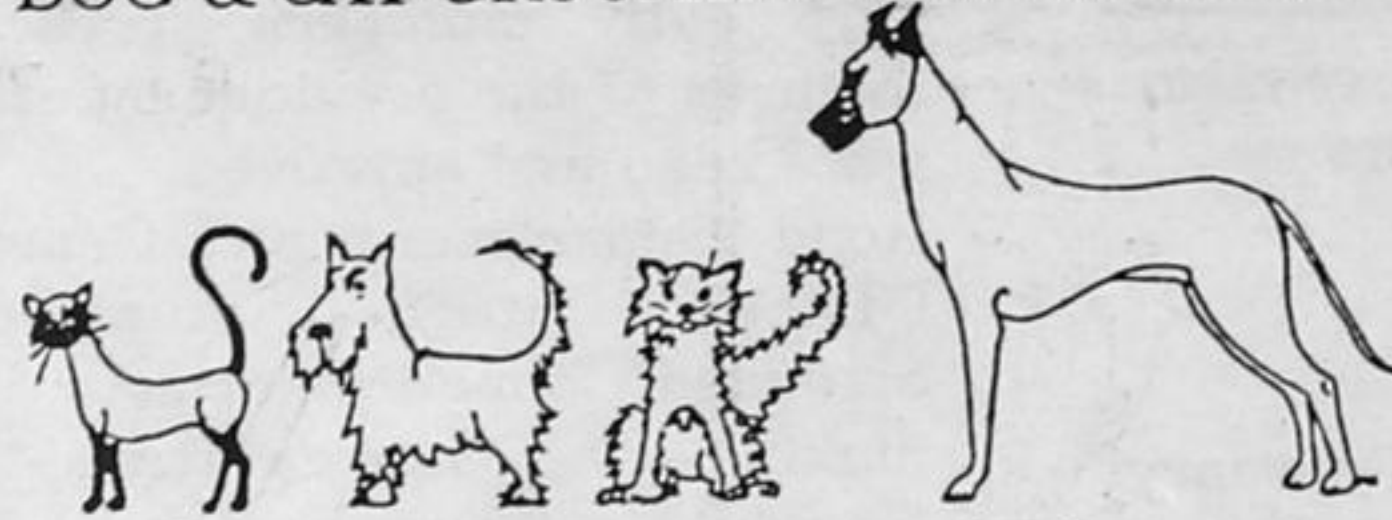

NOTICE OF INTENTION TO DESIGNATE

TAKE NOTICE that the Council of the Corporation of the Township of Bastard and South Burgess intends to designate the property, including lands and buildings at the following municipal address as property of architectural and historical value or interest under Part IV of the Ontario Heritage Act, 1980 R.S.O. Chapter 337.

ALBERT GALLAGHER HOUSE: Bastard Township, Village of Portland, Plan 27, part lot 1, lot 2, lot 3, lot 4, Water Street, S.S., Main Street W.S. The residence was originally built by Albert Gallagher C 1910 and is presently owned by Patrick and Eleanor Dickey.

REASONS FOR DESIGNATION:

STRUCTURE: Two-and-one half storey, brick, rectangular, with a protruding bay on north facade.

ROOF: Original Metal

WINDOWS: Tall rectangular with those in the front and west facade in two sections with upper panes leaded.

DOOR: Downstairs with large glass pane in plain wood trim and wooden panels at the bottom.

VERANDAH: Two storey on front facade with Ionic style pillars.

FENCE: Low, cast-concrete fence along front of property.

ANY PERSON MAY, within thirty days of the first publication of this notice, send by registered mail or deliver to the Clerk of the Township of Bastard and South Burgess notice of his or her objection to the proposed designation together with a statement of the reason for the objection, and all relevant facts. If such a Notice of Objection is received, the Council of the Corporation of the Township of Bastard and South Burgess shall refer the matter to the Conservation Review Board for a hearing.
