Work had been done in the Fall of 1986 on the rink boards and ground surface as part of a Make-Work program in the township. Materials were made available in late Fall for a new rink house to be built in the spring with volunteer labour of Elgin and area residents.

February 2nd

## February 16th

- letter received from Leeds and Grenville Board of Education re paving of south shoulder of County Road 8 advising they would not give any financial assistance

- agreed that Gregory Patterson operate a Chip Wagon, in the village of Elgin on property located at Part Lot 7, Plan 88 under the following condition:

1. the structure be set up on a fixed basis. 2. set back requirements, of the zone that it is in, according to the Zoning By-law be met. 3. That a building permit be obtained. 4. that approval be obtained from Department of Health. 5. this approval is valid for the year 1987 only, and thus would have to be reviewed and approval applied for annually.

- re matter of mailboxes, decision was reached that Township of South Crosby hold no responsibility for erection or replacement of mailboxes that are knocked over or damaged by flying snow.

- if a mailbox is destroyed as a result of being hit by snow, from a moving snowplough, that same be replaced by Road Department - passed a motion to authorize the By-Law Enforcement Officer to contact solicitor and that legal proceedings are to be started against Mr. Augustus Oldendorp

Whereas litter can be dangerous by causing physical harm to man and animals; and


Whereas thoughtlessness and negligence are the main contributory factors in the occurrence and spread of litter; and

FIRE REGULATIONS

In regard to the burning of anything other than everyday household refuse, which may be burned in a suitable incinerator or can, properly covered with a screen to prevent spreading;

For all other burning, you must obtain a Fire Regulation Form from the Fire Chief, Mr. Wayne Carbino, Elgin, Ontario, telephone number 359-5959; or Deputy Chief, Mr. Steve Gordanier, Elgin, Ont. telephone number 359-5227.

Anyone starting a fire will be responsible for all costs and damages.
