
### Elgin & District Co-op **Nursery School**

# The Township of South Crosby

**BY-LAW NUMBER 683** 

Being a By-Law to prohibit the parking of any vehicle on any street or township road, within the Township of South Crosby.

Whereas, the Council of the Corporation of the Township of South Crosby deems it expedient to control and regulate parking on streets and roads in teh Township of South Corsby:

Therefore, the Council of the Corporation of the Township of South Crosby enacts as follows:

- 1. From the 15th day of December in any year, until the 31st day of March of the following year, no person shall park a vehicle or leave a vehicle parked between the hours of 1:00a.m. to 7:00 a.m. on any street or township road, within the Township of South Crosby:
- Every person who contravenes this By-Law shall be liable for any towing and storage charges related to the removal of any vehicle, for the purpose of snow removal.

This By-Law comes into full force and effect on the 15th day of December, 1975.

Read a first, second and third time and passed this 17th day of November, 1975. Signed E. Strong Reeve

## THE CORPORATION OF THE TOWNSHIP OF SOUTH CROSBY BY-LAW NUMBER 36-86

Being a By-Law to amend Schedule 1, to By-Law No. 674, which provides for registering and licensing of dogs.

Whereas the Council of The Corporation of the Township of South Crosby deem it necessary, to adjust the license fees for dogs to alleviate expenses related to dogs;

Therefore the Council of The Corporation of the Township of South Crosby enacts as follows:

That Schedule 1, to By-Law Number 674 be amended as follows: \$ 6.00 1. For a male dog, if only one is kept For each additional male dog owned by the same \$ 8.00 person or kept in any one household \$10.00 For a female dog, if only one is kept For each additional female dog owned by the \$12.00 same person or kept in any one household \$40.00 5. For a kennel

Plus 25¢ for each tag.

Where the certificate of a Veterinary Surgeon is produced showing that a female dog has been spayed, it shall be licensed at the same rate as a male dog. This By-Law shall come into force and effect on the 1st day of January, 1987. Any By-Laws, Resolutions, Motions, Schedules, or previous actions of Council which are in contravention of this By-Law are hereby repealed. Read a first, second and third time and finally passed this 20th day of October, 1986.
