OFFICIAL PLAN PUBLIC MEETING

TAKE NOTICE that the Council of the Corporation of the Township of Bastard and South Burgess will hold a meeting on **August 20, 1985 at 7:00 p.m.** at the Municipal Office, Chantry to consider a proposed new Official Plan for the Township of Bastard and South Burgess.

The proposed new Official Plan will replace the present North Leeds Official Plan, as required under the Planning Act, 1983. This new Official Plan, although based on the policies and approach established in the former joint Official Plan, will affect only the Township of Bastard and South Burgess.

In order to tailor the document more closely to the Township's requirements and implement various Provincial policies, a number of changes have been made and new policies added, such as those affecting:

- consents (severances)
- community improvements
- group homes
- site plan control
- wetlands

Most other changes involve minor editing in order to adjust the wording to affect only the Township of Bastard and South Burgess.

ANY PERSON may attend the public meeting and/or make written or verbal representation either in support of or in opposition to the proposed Official Plan.

ADDITIONAL INFORMATION and copies of the proposed Official Plan are available for inspection at the Municipal Office during regular office hours.
