



HYDRO APPEALING COURT DECISION

Ontario Hydro has filed for leave to appeal a recent Divisional Court decision which resulted in suspension of hearings on its Eastern Ontario Transmission study.

Hydro's application for leave to appeal will be heard by the Supreme Court of Ontario (Court of Appeal) on March 18. The Joint Board and the Ministry of Environment have also filed for leave to appeal.

After the Divisional Court decision was released February 22, the Joint Board adjourned the route stage hearings on the Kingston to Ottawa section of the proposed transmission route.

In October, 1984, the Joint Board had asked the Divisional Court to clarify the Board's jurisdiction with respect to approval of alternatives and hearings notification.

In announcing the decision to appeal the Divisional Court's ruling, Hydro spokesman Norm Manning said, "Hydro is concerned about the implications of some aspects of the Court's decision and is therefore seeking further clarification through the appeal process."

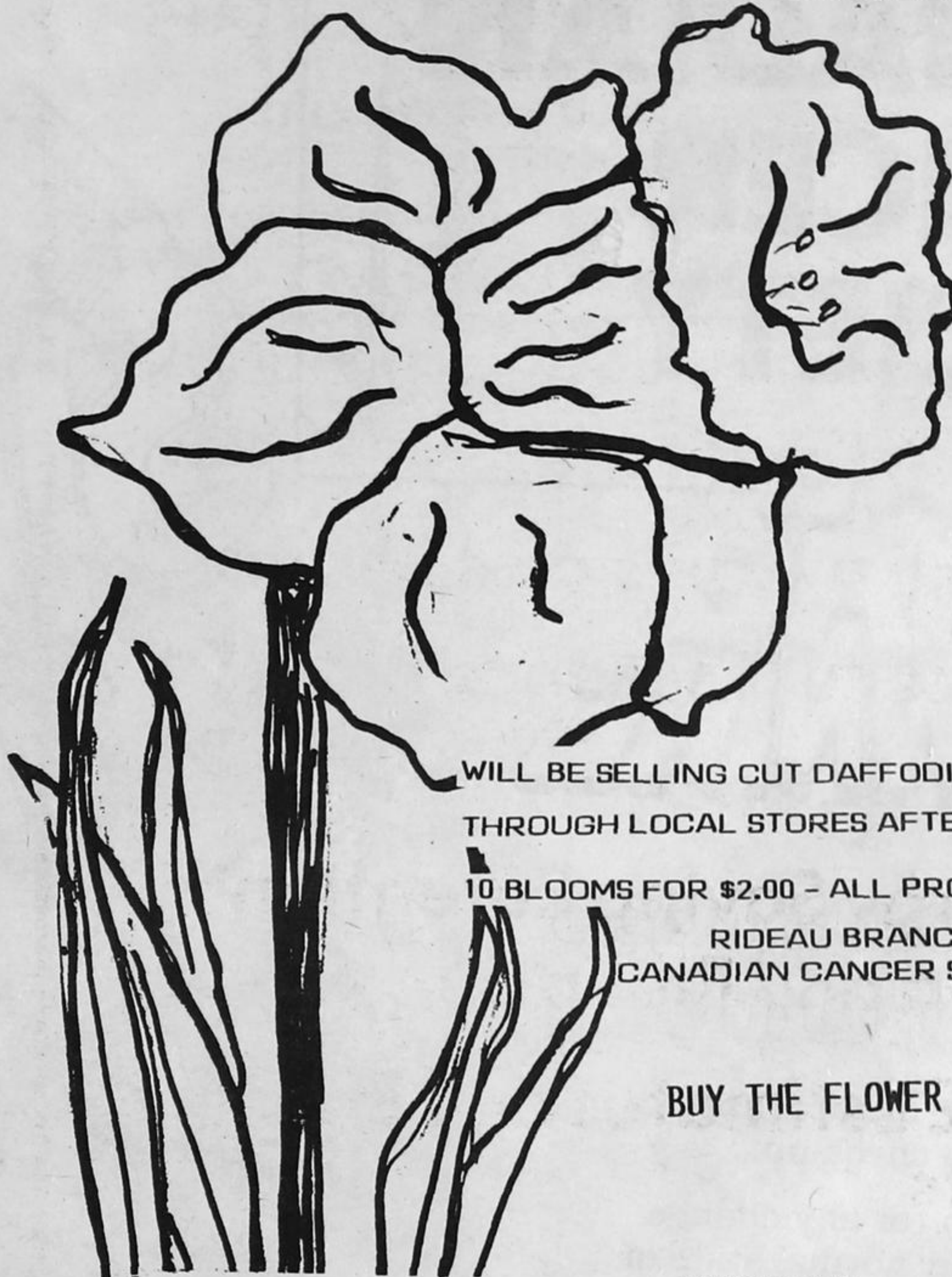
He added that the Divisional Court had a number of positive things to say about how notification was handled for the current hearing.

"Hydro is still working toward its target of having new transmission facilities in service by 1989," Manning said.
