**WINTER  
PARKING  
REGULATIONS**

**By-law Number 683**

A By-law to prohibit the parking of any vehicle on any street or Township Road within the Township of South Crosby.

WHEREAS the Council of the Corporation of the Township of South Crosby deem it expedient to control and regulate parking on streets and roads in the Township of South Crosby.

THEREFORE the Council of the Corporation of the Township of South Crosby enacts as follows:

1. From the 15th. day of December in any year until the 31st. day of March of the following year, no person shall park a vehicle or leave a vehicle parked between the hours of 1a.m. to 7 a.m. on any street or Township road within the Township of South Crosby.
2. Every person who contravenes this By-law shall be liable for any towing and storage charges related to the removal of any vehicle for the purposes of snow removal.

This By-law comes into full force and effect on the 15th. day of December, 1975.

Read a first, second and third time and passed this 17th. day of November, 1975.

**By-law Number 21-78**

The Council of the Corporation of the Township of South Crosby deem it necessary to pass a by-law to regulate parking within the Elgin Police Village.

THEREFORE the Council of the Corporation of the Township of South Crosby enacts as follows:

DEFINITIONS for the purpose of this by-law.

"Park" or "Parking", when prohibited, means the standing of a vehicle, whether occupied or not, except when standing temporarily for the purpose of and while actually engaged in loading or unloading merchandise or passengers.

"Street" or "Highway" includes a common or public highway, street, avenue, parkway, driveway, square, place, bridge, viaduct or trestle, designed and intended for, or used by, the general public for the passage of vehicles.

"Vehicle" includes a motor vehicle, trailer, traction engine, farm tractor, road-building machine and any vehicle drawn, propelled or driven by any kind of power, including muscular power, but does not include the cars of electric or steam railways running only upon rails.

PARKING REGULATIONS

When appropriate signs have been erected and are on display, no person shall park a vehicle on the streets hereafter set out:

<u>COLUMN 1</u>	Halladay Street	Church Street
<u>COLUMN 2</u>	North side	West side
<u>COLUMN 3</u>	From Fire Hall to Church Street	From corner of Halladay Street to Main St.

PENALTIES Any person violating any of the provisions of this By-law shall be subject to a fine and towing charges.
