### HOMEMAKERS HARD AT WORK IN NORTH LEEDS

Mrs. Jennie Updegrove and Mrs. Verna Cardinal have recently been hired through a Canada Works Grant to work as Homemakers in this area. These women are providing in-home services for senior citizens in our community. Sometimes they assist by doing the heavier housework, other times they prepare nourishing meals, and provide lively conversation.

But senior citizens aren't the only people who can receive this service. Persons recently home from hospital, mothers with young children who are ill or disabled persons might also benefit from the help that a homemaker can provide.

The work of the Homemakers is supervised by our VON nurse, Shirley Green. Mrs. Green also does the initial assessment of the clients and determines if they are eligible for the service.
