- that Council support the resolution from the "Township of Kingston," Adoption of a child regarding the tax exempt being increased from \$300. to \$1000. annually during the summer.

Roll call was taken.


It was decided to give a bursary to each - Miss J. Crump and Mrs. K. Woods - for assistance in theological studies.
