- Council authorized the road superintendent to call for tenders for crushed stone for 1979.

- Council will notify Fisheries and Environment that they are prepared to lease the Government Wharf in Portland for an annual fee of \$100.00 and pay the cost of lighting that area

- An approval will be requested from the Ministry of Environment for a dumping depot at the Portland Waste Disposal Site.

-Council will apply to Ministry of Transportation and United Counties of Leeds & Grenville for the erecting of signs, on one of our County Roads.
-Council approved the budgets for the Three fire Departments for the year 1979.

- Council will take no action on the resolution from the Twp. of South Crosby.
